PREMIUM HOLIDAYS

Carey Deaver, Human Resources Director, requested approval to schedule health and dental premium holidays during 2014 as long as the health fund has a balance of 3.0 million or higher. This reserve amount should be adequate to allow for claim fluctuation and claim administration costs. Each health premium holiday results in a savings of approximately \$130,000 to the general fund. MOTION by Kelly, seconded by Pekas, to authorize the scheduling of health and dental premium holidays during 2014 at the discretion of the Human Resources Director, if the health fund has a balance of 3.0 million or higher. 5 ayes.

BID AWARD

Lloyd Olson, Facilities Director, reported on the January 14, 2013 bid opening for the refurbishment of the freight elevator in the Public Safety Building. Two bids were received from the following companies: Kone Elevator Base Bid \$64,687, Alternate #1 Hoistway track replacement \$6,477, Alternate #2 Hydraulic cylinder replacement \$12,228; and Schumacher Base Bid \$74,887, Alternate #1 Hoistway track replacement \$0.00, Alternate #2 Hydraulic cylinder replacement \$32,500, and a voluntary Alternate #3 for a deduct of -\$10,682 which includes the re-use of several parts relating to door assemblies. The engineers for this project, TSP, Inc. has stated that these parts may be worn, but this will not be known until disassembly and inspection. Mr. Olson and TSP, Inc. recommended awarding the bid to Kone Elevator for a Base Bid of \$64, 687.00 and Alternate #2 to replace the hydraulic cylinder in the amount of \$12,228.00. Mr. Olson also stated that there is potential for unforeseen conditions with the replacement of the hydraulic cylinder. TSP, Inc. is recommending a contingency of \$10,000 to \$20,000 to cover the cost associated with those potential conditions. Darlene Johnson, Assistant Auditor, reported that there is cash in the Building Fund due to the refinancing of bonds which could be used for the contingency. MOTION by Pekas, seconded by Barth to award the bid for the refurbishment of the freight elevator in the Public Safety Building to Kone Elevator in the amount of \$64,687.00 Base Bid and \$12,228.00 Alternate #2 replacement of hydraulic cylinder. 5 ayes.

INTEREST EARNINGS

Bob Litz, Auditor, reported that in 2013 the Highway Road and Bridge Fund received interest income in the amount of \$11,361.57. Kersten Kappmeyer stated that there is nothing in statute that forbids the transfer of interest income from one fund to another. Darlene Johnson, Assistant Auditor, stated that according to the Minnehaha County Investment Policy, the interest from the Highway Road and Bridge Fund may be transferred to the General Fund. Commissioner Beninga stated that he believes the interest should remain with the fund that accumulated the interest. Chairman Heiberger agreed with Beninga. MOTION by Kelly, seconded by Barth, to transfer the accumulated interest in the amount of \$11,361.57 from the Highway Fund to the General Fund. 3 ayes. Beninga and Heiberger voted nay. Motion carried.

AGREEMENTS

MOTION by Pekas, seconded by Kelly, to authorize the Chairman to sign the 2014 Agreement with the SD Department of Transportation for Project P000S(00) PCN 02DR for striping and continuing maintenance of approximately 131 miles of Minnehaha County roads at an estimated cost to Minnehaha County of \$82,740.93. 5 aves.

Shannon Schultz, Senior Project Engineer, reported on two proposals received on September 25, 2013, for the development of a Pavement Management system from Infrastructure Management Services (IMS) with Deighton Associates as a sub-consultant and from Data Transfer Solutions, LLC. A proposal selection committee consisting of members from the South Dakota Department of Transportation, Minnehaha County, and the City of Sioux Falls selected IMS as the best proposal. Mr. Schultz gave a briefing on a three year agreement that has been negotiated with IMS in the amount of \$170,915. Mr. Schultz stated that a portion of the contract is eligible to be covered using planning funds through South Eastern Council of Governments and the South Dakota Department of Transportation. MOTION by Pekas, seconded by Beninga to authorize the Chairman to sign the agreement between Minnehaha County and Infrastructure Management Services for Pavement Management System in the amount of \$170,915. 5 ayes.

Shannon Schultz, Senior Project Engineer, gave a briefing on an agreement for Final Design and Construction Administration with Short Elliott Hendrickson, Inc. (SEH) for replacing Structure #50-082-110. The structure is located on a gravel road approximately three miles north of Hartford over the West Branch of Skunk Creek. The preliminary opinion of construction cost for this project is \$560,000. Chairman Heiberger and Commissioner Kelly stated they would like to have had a traffic count done on this road to support the expense of replacing the structure. Mr. Schultz stated that traffic counts are not typically done for projects on gravel roads, but he can include that as part of the Type Size & Location Study for future projects. Auditor Bob Litz reported that the amount Minnehaha County would receive from Payment in Lieu of Taxes would be roughly \$3,800.
