Carey Deaver, Human Resources Director, gave a briefing on an amendment to the three year administrative services agreement for the county health plan with UMR, the third party administrator who processes payments and explanations of benefits. The UMR agreement includes a yearly increase of 4% for medical services fees and a 5% increase for pharmacy administration which is reflected in the amendment. This is the third and final year of the current agreement. MOTION by Pekas, seconded by Barth, to authorize the Chairman to sign the

Amendment to Administrative Services Agreement with UMR effective January 1, 2014. 4 ayes.

ABATEMENT

MOTION by Kelly, seconded by Barth to approve abatement of 2013 Property Taxes in the amount of \$816.66 for ID#77411, representing owner occupied status. 4 ayes.

MOTION by Barth, seconded by Pekas to deny abatement of 2013 Property Taxes in the amount of \$1,434.99 for ID #80812, due to no documentation for owner occupied status on file. 4 ayes.

NOTICES

MOTION by Pekas, seconded by Barth, to authorize the Auditor to post a Notice of Hearing to consider 2013 Carry-Over Supplements to various FY 2014 Budgets. 4 ayes.

MOTION by Pekas, seconded by Barth, to authorize the Auditor to publish Notice to Bidders for Pavement Preservation Project (Chip Sealing) on Minnehaha County Highways 104,110, 122, 130, 146, 150, 151, and 155 totaling 41.765 miles. 4 ayes.

MOTION by Barth, seconded by Pekas, to authorize the Auditor to publish Notice to Bidders for Asphalt Overlay Project on Minnehaha County Highways 109,115, and 150. 4 ayes.

Commissioner Barth reported that a raffle was held on behalf of a Senate candidate and a notice of intent to conduct that raffle was not submitted to the Minnehaha County Commission.

HEARING

Scott Anderson, Planning & Zoning Director, was present for the public hearing and gave the second reading of an ordinance to re-zone from the A-1 Agriculture District to the I-1 Light Industrial District in Tract 2 Benson's Addition W ½ SW ¼ Section 17-T103N-R50W, located on the south side of Lyons. The petition to rezone was submitted by Rosenbauer South Dakota, LLC. There is already a light industrial development located directly to the north of the subject property. The rezoning request meets the criteria and development concepts of the Minnehaha County Comprehensive Plan. The Planning Commission unanimously approved the rezoning request on January 27, 2014. There were no proponents or opponents who spoke. MOTION by Barth, seconded by Kelly, to approve Ordinance MC 16-132-14. 4 ayes. The entire ordinance is on file at the Minnehaha County Auditor's office.

Scott Anderson, Planning & Zoning Director, was present for the public hearing and gave the second reading of an ordinance to re-zone from A-1 Agriculture District to I-1 Light Industrial District in the SW ¼ NW ¼ (Ex H-2) Section 18-T102 N-R49W, located approximately ¼ mile south of Crooks/Renner Exit, directly adjacent to I-29 Northbound. The petition to rezone was submitted by H5 Investments, LLC. There is existing light industrial and commercially zoned property located to the north and northwest and west of the subject property at the Crooks exit off Interstate 29 and County Highway 130. The rezoning proposal meets the criteria and development concepts of the Minnehaha County Comprehensive Plan. The Planning Commission unanimously approved the rezoning request on January 27, 2014. There were no proponents or opponents who spoke. MOTION by Barth, seconded by Pekas, to approve Ordinance MC16-133-14. 4 ayes. The entire ordinance is on file at the Minnehaha County Auditor's office.

BID

Doug Blomker, Assistant Emergency Management Director reported on proposals that were opened on Wednesday, February 19, 2014 for the purchase of nineteen (19) Glock Model 22 Handguns with trade-in. Proposals were received from the following companies: Neve's Uniforms, Cost \$7,771.00, Minus Trade-In

(\$5,035.00), Total Cost \$2,736.00; Jack's Uniforms & Equipment, Cost \$7,771.00, Minus Trade-In (\$5,475.00), Total Cost \$2,296.00. Mr. Blomker recommended that the County accept the proposal from Jack's Uniforms & Equipment. Motion by Kelly, seconded by Pekas, to award the purchase of nineteen (19) Block Model 22 Handguns with trade-in to Jack's Uniforms & Equipment at a total cost of \$2,296.00. 4 ayes.

AGREEMENTS

Carol Muller, Human Services Director, reported that Volunteers of America Dakotas (VOAD) is applying for a Substance Abuse and Mental Health Services Administration grant for residential treatment for pregnant and postpartum women. The VOA is requesting approval of a Memorandum of Understanding which states Minnehaha County will mutually collaborate with VOAD Pregnant and Postpartum Women staff to provide detoxification services. MOTION by Pekas, seconded by Kelly, to authorize the Chairman to sign the Memorandum of Understanding for Substance Abuse and Mental Health Services Administration Services Grant Program for Residential Treatment for Pregnant and Postpartum Women between Volunteers of America Dakotas and Minnehaha County. 4 ayes.

Carol Muller, Human Services Director, gave a briefing on the annual contract for casework with Lincoln County. Changes to the contract include a reduction of caseworker presence in the Canton office from two days a week to one day a week, a decrease in mileage from \$900 to \$540 a year, a decrease in the communication line item from \$1,800 to \$1,200 reflecting changes in actual costs, update in personnel costs, and the monthly fee is increased from \$5,433.42 to \$5,686.50. MOTION by Pekas, seconded by Barth, to authorize the Chairman to sign the Agreement For Casework Services between Minnehaha County and Lincoln County. 4 ayes.

Commissioner Beninga joined the meeting.

Shannon Schultz, Senior Project Engineer, gave a briefing on an agreement with the City of Hartford outlining financial reimbursement for chip sealing 0.764 miles on Highway 151 (Western Avenue) which is contained within the City of Hartford. The estimated amount the City of Hartford will reimburse Minnehaha County is \$19,600. MOTION by Kelly, seconded by Pekas, to authorize the Chairman to sign the Joint Agreement between the City of Hartford and Minnehaha County Regarding 2014 Chip Seal Project. 5 ayes.

BRIEFING

Kyle Helseth, Director of Equalization, reported that Local Boards of Equalization will begin on March 17, 2014 and the County Board of Equalization will begin on April 8, 2014. Mr. Helseth reported that 1,145 new houses were built in Minnehaha County in 2013. The new growth value was calculated at \$318,539,883. The current total property value in Minnehaha County before adjustments is at \$12,753,220,459. This is an increase of 4.6% over the total valuation in 2013.

LEGISLATIVE UPDATE

Robert Wilson, Assistant Commission Administrative Officer, gave an update and status report of the 89th Legislative Session on bills that impact Minnehaha County. Senate Bill 111, an act to revise certain property tax limitations, was tabled with a vote of 8-1. The bill would have changed the maximum increase in property taxes year-to-year from the current 3% or CPI, whichever is less to 3% or CPI, whichever is greater, not to exceed 4%. Chairman Heiberger stated that we need to continue to educate our local legislators on the need for this change and invite them to attend Minnehaha County budget hearings.

MOTION by Pekas, seconded by Barth, to go into executive session to discuss pending litigation. 5 ayes.

The Commission adjourned until 9:00 a.m. on Tuesday, March 4, 2014.
