PUBLIC COMMENT

DJ Buthe, Highway Superintendent, reported that seasonal load limits have been placed on certain county highways due to spring thaw/wet conditions. A memo was sent to media outlets, garbage companies, trucking firms, and law enforcement agencies regarding the load restrictions. The load limits will remain in effect until further notice but no longer than April 30, 2014, unless the Commission adopts a resolution extending the date.

BRIEFING

DJ Buthe, Highway Superintendent, presented the 2014 Minnehaha County Highway Department Construction Project Summary.

BID AWARDS

DJ Buthe, Highway Superintendent, reported that bids were opened on March 12, 2014 for Project MC 121-138MS-14, Micro-surfacing on County Highways 121 & 138. The following bids were received: Monarch Oil Inc. \$404,113.40; Sta-Bilt Construction Co. \$479,056.45; Missouri Petroleum \$529,826.55; Intermountain Slurry Seal \$475,266.83; Astech Corp. \$453,272.46. Sta-Bilt Construction Co. requested to retract their bid due to a bidding error on Item #3 where they bid \$1.98 per ton of Scratch Course material and their intent was to bid \$198 per ton. Kersten Kappmeyer, Chief Civil Deputy State's Attorney, is of the opinion that it would be unreasonable to enforce the contract with such an obvious error. Mr. Buthe recommended awarding the microsurfacing contract to Monarch Oil Inc. MOTION by Kelly, seconded by Pekas, to award the bid for Project MC121-138MC-14 to Monarch Oil Inc. in the amount of \$404,113.40. 5 ayes.

The Highway Materials Bid Award was deferred from March 11, 2014 due to bid irregularities and to allow Kersten Kappmeyer, Chief Civil Deputy State's Attorney, to research state statute regarding bid security requirements. Mr. Kappmeyer reported that according to SDCL 5-18A, bid securities are required for public improvements and are not required for the purchase of materials. Mr. Kappmeyer also reported that state statute gives the county the right to waive technical irregularities in the bid proposal if the irregularities do not alter the price, quantity, quality of the service or tangible personal property offered. The failure to post a bid bond may be considered a technical irregularity. Patty Nohr, 600 E. Meadowlark Trail, Sioux Falls, and co-owner of Myrl & Roy's Paving spoke on Minnehaha County Highway Department's bid letting process in 2012 and 2013. Ms. Nohr described the events that led up to Myrl & Roy's submitting a "No Bid" for the 2014 Highway Materials bid letting. Ms. Nohr stated that the way the Hot Mix Asphalt bid was structured it gave a clear advantage to the only vendor who could supply hot mix asphalt containing shingles (RAS), because that product is a less expensive material. Instead, there could have been two separate bid items, one for Hot Mix Asphalt; Class G and one for Hot Mix Asphalt; Class G (w/RAS) and awarding contracts for both bid items. John Malloy, 200 E. 34th Street, Sioux Falls, Aggregate Division Manager for Concrete Materials, stated they inadvertently omitted including a bid security with their bid, and that this was the first year Minnehaha County required a bid security for the supply contract. Mr. Malloy stated that they bid a very good price for both mixes and he hopes that Concrete Materials will be awarded the bid. DJ Buthe, Highway Superintendent, stated that he does not have a bias against Myrl & Roy's and he has worked with them on projects in the past. MOTION by Barth, seconded by Pekas to award the following bids as recommended by the Highway Department. 5 ayes. Commissioner Beninga stated that he thinks the process of bid letting needs to be reconsidered and for legal counsel to approve any significant policy or practical change. Also there should be an extra effort made to communicate any changes in the bid process to the vendors.

CAPITAL ACCUMULATION DISCUSSION

Ken McFarland, Commission Administrative Officer, gave a briefing on establishing a capital accumulation to be designated for a large expenditure. South Dakota Codified Law 7-21-51 states the board of county commissioners may, by resolution, authorize the accumulation of funds for a period longer than one year for a capital outlay purpose which is extraordinary in nature, exceeds the funding ability of a single-budget year, and may result in the purchase of services, materials, supplies, or equipment. The resolution shall state the purposes for which the funds are to be accumulated and the maximum amount that may be accumulated. The funds to be accumulated must be expended within eighty-four months from the date of the resolution. If the specific purpose for which the funds are accumulated is no longer necessary, the funds shall revert to the fund from which they were originally appropriated. Darlene Johnson, Assistant Auditor, reported on 2013 year end revenue and expenditures. Commissioner Beninga stated that they need to put together a priority list of projects to be considered for capital accumulations. Mr. McFarland recommended using the capital accumulation for replacement of the current accounting system and integrate the accounting/tax records software packages between county departments. Commissioners discussed having further consideration for establishing a capital accumulation during the budget process. Chairman Heiberger requested information on a projected cost of new accounting software. Mr. McFarland stated that we will likely have to commission a consultant to analyze our current accounting system, identify what software packages are available, identify a cost associated with the new software, and identify a time line for implementation.

Commissioner Kelly left the meeting.

LIAISON REPORTS

Commissioner Beninga reported that the Minnehaha County Criminal Justice Advisory Committee is working on a final draft of their recommendations on public safety issues. Robert Wilson, Assistant Commission Administrative Officer, stated the committee will be presenting their report at the April 8th Commission Meeting.

Commissioner Kelly re-joined the meeting. Commissioner Barth left the meeting.

NEW BUSINESS

Charles Martinell representing the Sioux Falls Water Festival Committee, read a proclamation declaring March 18th and 19th, as Sioux Empire Water Festival Days. MOTION by Pekas, seconded by Beninga, to authorize the Chairman to sign the proclamation. 4 ayes.

MOTION by Pekas, seconded by Beninga, to go into executive session to discuss personnel and contracts. 4 ayes.

The Commission adjourned until 9:00 a.m. on Tuesday, March 25, 2014.
