MOTION by Barth, seconded by Beninga, to authorize the Auditor to publish a Notice of Hearing on September 23, 2014, to consider the transfer of the On-Sale Liquor License and On-Off-Sale Malt Beverage License from Swearingen Enterprises, Inc., Breck's Bar & Grill, to Michael Swearingen, Chasers Food & Spirits. 4 ayes.

#### LIEN COMPROMISE

Commissioner Pekas gave a briefing on a request for compromise of lien for DPNO 83886. The lien is for Public Defender services provided in 2012. A payment of \$366 was received shortly after the lien was placed. The applicant states he was never told he had to pay for the services of his Public Defender and that his debts and obligations exceed his income. As part of the court's sentence in the case associated with the lien, the applicant was ordered to pay fines and court costs as a condition of suspending 120 day jail time. Due to an initial failure to pay these fines and costs, a warrant was issued for his arrest. The applicant has dealt with the warrant through the Sheriff's Office Walk in Warrants program, however the court order to pay the fines and costs remain active. The applicant has moved to Brookings to start a new job and is requesting a compromise and release of the lien in full with no additional payment. He lists assets in the amount of \$1,110 that include a checking account, household goods, and other personal property. His liabilities include debts and auto loans totaling \$12,384 as well as monthly expenses. According to his 2013 tax return he had an adjusted gross income of \$31,760 and received a tax refund of \$924. The applicant was present and asked for leniency stating he would be willing to pay 50% of the lien. MOTION by Beninga, to approve a compromise and release of the lien upon payment of \$867. Motion dies for lack of a second. Vice Chairman Pekas informed the applicant that he could bring a petition back to the Commission possibly when all members are present. Commissioner Barth stated that the Commission looks favorably on people who make consistent partial payments on their liens.

# 9/02/2014 AGREEMENT

Jamie Gravett, Juvenile Detention Center Director, gave a briefing on an agreement with Volunteers of America – Dakotas (VOA) to provide four additional shelter care beds at a fee of \$110 per day, per bed for the remainder of the calendar year. Currently the VOA provides three beds at no daily cost, and charges \$115 per day, per bed, for any additional beds. There is no guarantee that additional beds will be available. Mr. Gravett stated that they are consistently using more than three beds at the VOA. This agreement guarantees a total of seven beds, and gives the county a reduced rate. MOTION by Beninga, seconded by Kelly, to authorize the Chairman to sign the Guaranteed Bed Contract for Non-Secure Detention between Minnehaha County and Volunteers of Americas – Dakotas for four additional beds at \$110 per bed, per day for the remainder of the 2014 calendar year. 4 ayes.

# EMERGENCY DECLARATION

Ken McFarland, Commission Administrative Officer, reported that the Highway Department inspected the culvert approximately 2 3/4 miles west of the I-29 and Baltic exit on County Highway 114 due to a recent noticeable bump in the road. The Highway Department immediately took action to close the road to truck traffic and only allow passenger cars to cross at slow speed in one lane because of the poor condition of the culvert. The Highway Department has a contract with Hancock Concrete Products through the Lincoln County materials letting for concrete pipe. The cost of purchasing an 8' x 8' Reinforced Concrete Box Culvert (RCBC), sloped ends, and appurtenances to install the pipe are \$41,706. The Highway Department received informal quotes to install a new box culvert from H&W Contracting, LLC in the amount of \$44,040 and from Metro Construction, Inc. in the amount of \$67,450. The Highway Department is requesting the Commission declare the culvert repair an emergency, accept the proposal from H&W Contracting, and authorize the agreement with Hancock Concrete Products for the purchase of materials. MOTION by Kelly, seconded by Barth, to declare the repair of the culvert on County Highway 114 an emergency pursuant to SDCL 5-18A-9, to authorize the Highway Department to proceed with the repairs, authorize the Chairman to sign the agreement with Hancock Concrete Products in the amount of \$41,706 for materials, and accept the proposal from H&W Contracting in the amount of \$44,040 for installation of the box culvert. 4 ayes.

# HEARING

David Heinold, Planner I, was present for the public hearing and gave a briefing on a petition to vacate a portion of S. Prince of Peace Place beginning at East 52<sup>nd</sup> Street Lying Adjacent to Block 1 and Lot 12A, Block 2 in Prince of Peace Addition to the City of Sioux Falls, Minnehaha County, South Dakota and Extending to the Edge of Lot 12A, Block 2; all in Section 35-T101N-R49W, Minnehaha County. The petitioner is Avera McKennan and they are the only property owners who have access to this portion of S. Prince of Peace Pl. They are requesting the vacation in order to properly accommodate the construction of a new long term care addition. Staff recommends approval of Private Road Vacation #14-02. Garrett Peters, Director of Facility Development for Avera, was present for the public hearing and spoke in regard to the miss-communication as to whether the City of Sioux Falls or Minnehaha County held the authority to vacate the road. Kersten Kappmeyer, Chief Civil Deputy State's Attorney, stated that Minnehaha County is the authority that handles private road vacations. MOTION by Barth, seconded by Beninga, to approve Resolution MC14-53. 4 ayes.

# **RESOLUTION MC14-53 RESOLUTION TO VACATE A PRIVATE ROAD**

**WHEREAS,** a public hearing was held on September 2, 2014, pursuant to the provisions of SDCL 31-3-7 and SDCL 31-3-38 to consider a petition to vacate a private road; and

**WHEREAS**, said hearing was for the purpose of determining whether the public interest will be better served by such proposed vacation; and

WHEREAS, the Board finds that the proposed private road to be vacated does not provide access to public lands.

**NOW, THEREFORE, BE IT RESOLVED AND ORDERED,** by the Minnehaha County Board of Commissioners that the following described private road, is hereby declared vacated:

That the remaining portion of South Prince of Peace Place beginning at East 52nd Street lying adjacent to Block 1 and Lot 12A, Block 2 in Prince of Peace Addition to the City of Sioux Falls, Minnehaha County, South Dakota and extending to the edge of Lot 12A, Block 2; all in Section 35-T101N-R49W Minnehaha County.

**AND BE IT FURTHER RESOLVED,** that this resolution be placed on file with the Minnehaha County Auditor and recorded with the Minnehaha County Register of Deeds.

# BUDGET HEARING

A public hearing was held for the FY 2015 Minnehaha County Budget. Ken McFarland, Commission Administrative Officer, gave a briefing on the FY 2015 budget which stands at \$72,141,845. The budget is supported by revenues that include a sluggish 2.4% growth in property taxes due to new construction within the county and a 1.4 % CPI adjustment allowed by the property tax limitation statutes in total county property taxes collected. The budget is also supported by modest increases in the bank franchise tax, recording fees, vehicle registration fees, and spending \$1.4 million in accumulated cash in the Highway Fund for road and bridge projects. The Provisional Budget includes one new court records officer position in the jail. The Provisional Budget also reflects the implementation of a modification in the county's pay plan for full and parttime employees along with normal step increases of approximately 2.5% in accordance with the parameters of the county's pay plan. The Provisional Budget keeps county operations on par with the 2014 budget with little to no growth to fund any requests for new positions, equipment, or programs. The Commission conducted one other budget hearing as well as a joint hearing with the City of Sioux Falls for the Museum, Metro Communications, and the Library, to consider some additional budget adjustments. These adjustments will reduce the General Fund Budget by \$10,821. These changes, as well as any last minute changes in payroll budget, and the impact of the final centrally assessed utility values will be incorporated into the final budget which will be presented for consideration and adoption on September 30, 2014. No public input or comments were received.

### AGREEMENTS

Shannon Schultz, Assistant Highway Superintendent, gave a briefing on a Professional Services Agreement with Infrastructure Design Group (IDG) for Project Development on Emergency Repair Projects (FEMA) resulting from the June flooding. IDG has met with FEMA Disaster Managers which initiated the official kick-off of the 60-day period of identifying needs and developing cost estimates. IDG's fees to participate in site inspections and other project development activities are \$8,889.72. 85% of all design, administrative, and construction fees will be reimbursable through FEMA. MOTION by Beninga, seconded by Barth, to authorize the Chairman to sign the agreement with Infrastructure Design Group for Professional Services for Emergency Repair Projects (FEMA) in the amount of \$8,889.72. 4 ayes.

# GRANT

Aaron McGowan, State's Attorney, gave a briefing on a three year Highway Safety Grant Application for fulltime dedicated DUI/Vehicular Crimes prosecutors and/or support staff to oversee and track all DUI cases in Minnehaha County. The objective is to reduce the number of DUI offenses that are dismissed or in which the defendant is allowed to plead to a lesser offense, and to enhance prosecutions of vehicular homicide and vehicular battery cases. The grant is funded through the U.S. Department of Transportation/National Highway Traffic Safety Administration. The dollar value requested is not to exceed a fulltime salary equivalent of Grade 22/Step 3. MOTION by Kelly, seconded by Barth, to authorize the State's Attorney's Office to submit the Highway Safety Grant Application. 4 ayes.

### RECOMMENDATION

Ken McFarland, Commission Administrative Officer, reported that the South Dakota Board on Geographic Names has an additional opportunity for the Minnehaha County Commission to comment on the naming of an island located in the Big Sioux River by Dell Rapids. The original name suggested was Quarry Island and the board also received a suggested name of Dells Island. The board has deferred a decision on naming the island pending a recommendation from the County Commission. Commissioners declined to make a name recommendation and believe input from the citizens of Dell Rapids is more important than a recommendation from the County. The Commission asked that a letter be sent to the SD Board on Geographic Names reflecting their position.

# CONTRACT

Ken McFarland, Commission Administrative Officer, gave a briefing on a contract with the US Probation & Pre-Trial Services Office for Non-Medical Detoxification Services. The current contract rate is \$128.59 based on the contract with the previous detox provider. Since Minnehaha County has a new provider and a revised budget, staff is recommending a contract rate of \$140 per day. MOTION by Kelly, seconded by Beninga, to authorize submission of a response to a solicitation by the US District Court, District Court Probation and Pretrial Services Services for residential detoxification services at a rate of \$140.00 per day. 4 ayes.

#### NEW BUSINESS

Ken McFarland, Commission Administrative Officer, asked the Commission to consider holding a special meeting during the week of November  $10^{th} - 14^{th}$ . There will be no commission meeting the previous week due to the Commission Meeting Room being used for General Election purposes, and Veterans Day is on the regular meeting day, Tuesday, November  $11^{th}$ .

Jeff Gromer, Warden, asked to have a 2004 Chevy Tahoe from the Sheriff's Department removed from the surplus property auction and be kept for use by the Jail. MOTION by Barth, seconded by Beninga to remove the 2004 Chevy Tahoe from the surplus property auction. 4 ayes.

Scott Anderson, Planning Director, reported on changes that FEMA is making to the flood plain map for an area primarily in the southwest portion of Sioux Falls. The changes will also affect an area in Minnehaha County west of Ellis Road between 41<sup>st</sup> Street and 57<sup>th</sup> Street.

Motion by Beninga, seconded by Barth, to adjourn into executive session for personnel and legal briefing. 4 ayes.

The Commission adjourned until 9:00 a.m. on Tuesday, September 9, 2014.
