The Siouxland Heritage Museum presents an average of 185 Starlab Programs per year to approximately 3,700 people, primarily K-12 students. The material in the 1980 Starlab is beginning to deteriorate and break down. The acquisition of a new Starlab is funded by a grant from the Sioux Falls Area Community Foundation. The total cost of the new Starlab is \$12,850 including a \$1,000 trade-in allowance on the 1980 Starlab. Chairman Heiberger congratulated Commissioner Pekas on his upcoming Judgeship and stated he will be resigning his seat on the County Commission at the end of this year. A discussion will be held during the November 25, 2014 commission meeting on the process for appointing a new commissioner to his seat.

Chairman Heiberger stated that a discussion on conducting an election review will be on the November 18, 2014 commission meeting agenda.
