The documents and resolution previously provided include one purchaser and one bond. Since that time there is one additional bank that would like to participate. The documents and resolution need to be revised to include two purchasers and two bonds. MOTION by Pekas, seconded by Barth, to defer consideration of a resolution giving final approval to the issuance of Economic Development Revenue Bonds for Augustana College Association to finance the Froiland Science Complex to the November 25, 2014 Commission Meeting. 5 ayes.

MINUTES APPROVAL

MOTION by Kelly, seconded by Pekas, to approve the November 12, 2014, Commission Minutes. 5 ayes.

VOUCHERS TO BE PAID

MOTION by Pekas, seconded by Barth, to approve the following bills in the amount of \$413,718.17. Commissioner Pekas and Barth commented on bills submitted for Court Appointed Attorney services. Commissioner Pekas stated that the County is obligated to pay court appointed attorney bills that are reviewed and signed by a judge which result in a lien being placed on the individual receiving the services. Pekas stated that the Auditor should be advised that the Commission will be asking for access to vendor files to allow a review of these bills. Barth stated that the County budgets for court costs which are out of the County's control, and the only alternative is to hire additional Public Defenders and Public Advocates. Kersten Kappmeyer, Chief Civil Deputy State's Attorney reminded the commission that there is a remedy to objecting to court-ordered legal bills when there is no legal authority for them to be paid in a certain case. In those appropriate cases, the State's Attorney's Office with Commission authorization can, and has brought, a case to the South Dakota Supreme Court to challenge such bills and get them set aside. VOTE on motion. 5 ayes.

MOTION by Pekas, seconded by Barth, to authorize the County Auditor to publish a notice to bidders for Minnehaha County Highway Project MC 14-16, consisting of grading, rip-rap, and miscellaneous repairs to drainage structures throughout Minnehaha County through the Emergency Response Program. 5 ayes.

Commissioner Pekas gave a briefing on a request for compromise of lien for DPNO 36872 and 49129. The applicant is requesting a compromise and release of the liens in full with no payment in an attempt to become eligible for a home ownership program administered by Hunkpati Investments. DPNO 36872 originated in Tripp County and is in the amount of \$8,387.56. Minnehaha County's portion of this lien is \$2,374.80 consisting of rent, utilities, public defender, and other poor relief services provided between 1996 and 2008. DPNO 49129 is in the amount of \$1,630.52 and is in the name of the applicant and her ex-husband. This lien is for rent and utilities provided between 2002 and 2003. All services were requested by the applicant prior to the couple's divorce. A lien also exists in the name of the applicant's current husband that could potentially impede completion of a real estate transaction. That lien is DPNO 65674 in the amount of \$1,104.60 and is for public defender services. The applicant lists assets of \$5,000 consisting of two vehicles, liabilities of \$8,346.43 consisting of debts to Hunkpati Investments and a bank loan owed to West Lakes Financial Services. Commissioner Pekas stated he is concerned that we don't know if the applicant is actually attempting to refinance or purchase a home, and also that the applicant has stated that she has lost three sources of income. Commissioner Barth stated that he agrees with Commissioner Pekas and he would like to defer this item for two weeks to allow time to gather more information from the applicant. MOTION by Barth, seconded by Pekas, to defer this item until the December 2, 2014 commission meeting. SUBSTITUTE MOTION by Kelly to deny the request for compromise of lien. Motion dies for lack of a second. VOTE on main motion 4 ayes. Kelly voted nay.

Commissioner Pekas gave a briefing on a request for compromise of lien for DPNO 71459 in the amount of \$2,856.07. The request was submitted by Attorney Grant Alvine on behalf of his client. The lien is for public

defender, public advocate, and poor relief services provided between 2009 and 2014 by Minnehaha County that total \$2,604.07. The remaining balance of \$252.00 was incurred in Lincoln County. Mr. Alvine's client has been presented with an offer of a \$10,000 settlement from American Family Insurance as the result of an automobile accident. If the offer was accepted and all fees and costs associated with the accident were paid in addition to the outstanding county aid lien, his client would still owe more money than she received. Mr. Alvine is working with the insurance company in hopes of increasing the settlement amount and indicated he may reduce or wave his legal fees in an attempt to settle this matter. The applicant is unemployed, lives with relatives and her sole source of income is a child support payment of \$250 per month. She is requesting the lien be released only as it applies to proceeds from a settlement from American Family Insurance. MOTION by Pekas, seconded by Barth, to approve Resolution MC14-71. 4 ayes. Beninga did not vote due to a loss of video/audio conference link.

PUBLIC COMMENT

Scott Ehrisman, 806 S. 10th Avenue, Sioux Falls, spoke on his qualifications and stated his interest in being appointed to the Minnehaha County Commission after Commissioner Pekas's seat becomes vacant.

APPEAL

David Heinold, Planner I, gave a briefing on an appeal filed by Rocky Loosbrock, 26493 483rd Avenue, of a decision of the Minnehaha County Planning Commission to approve Conditional Use Permit (CUP) #14-48 to allow a daytime dog training facility on property legally described as Lot 1, Tract 3, Skyberg's Addition, SE ¼ Section 14-T101N-R48W in Split Rock Township. The petitioner is Ryan A. Jordan. The site plan shows there will be a 40' by 6' outdoor dock with a non-slip outdoor

carpet and a 4' wide ramp to help dogs out of a 4' deep 33' x 18' above-ground pool. The pool will be used to train dogs for Flight Dog competitions. The County Planning Commission voted 4-1 to approve CUP 14-48 with the following eight (8) conditions: 1) That Conditional Use Permit #14-48 shall permit a Daytime Dog Training Facility. 2) That the hours of operation shall be open to the public from 5:00 p.m. to 9:00 p.m. weekdays, noon to 8 p.m. Saturday, and no Sundays. 3) That the proposed use shall adhere to the submitted site plan dated 9/25/14. 4) All waste shall be disposed of in conformance with the Solid Waste Ordinance. 5) That all lighting shall be of a full cutoff and fullyshielded design directed downward to prevent light pollution off of the property. 6) That six (6) parking spaces be provided in conformance with Article 15.00 and parking shall not be permitted on 265th Street at any time. 7) That a building permit is required for the training dock and above-ground pool. 8) That a building inspection is required prior to the commencement of operations. Petitioner Ryan Jordan, 1417 Creekside Circle, stated the property the Flight Dog training pool will be on is land owned by his wife's parents. Mr. Jordan spoke on safety measures and rules they will implement in consideration of their neighbors concerns. Mr. Jordan stated they would limit the number of dogs to six (6) per day. Opponent Rocky Loosbrock spoke in opposition to the CUP stating concerns about barking dogs and the right to quiet enjoyment of his property. Adjoining property owner and opponent Barb Jurgens, 48258 265th Street, spoke on behalf of her sister and herself stating concerns about possible rezoning due to businesses being allowed in the area, noise from dogs barking, privacy, increase in traffic, decrease in property value, and possible growth of the business. Angela Jordan, wife of Ryan Jordan, stated they will not be holding events at this facility. It will be used by herself and her friends for training their dogs. MOTION by Pekas, seconded by Barth, to uphold the Planning Commission's decision to approve Conditional Use Permit #14-48 with 8 conditions. 5 ayes.

GRANTS

Lynn DeYoung, Emergency Management Director, reported that Minnehaha County has been awarded a 2014 Homeland Security Grant in the amount of \$127,874.86. The grant will be used for the following purposes: \$22,000, training for Mass Casualty; \$7,341.62, MDT Software for the Sheriff's Office; and \$98,533.24, radios for the Sheriff's Office and Police Department. MOTION by Kelly, seconded by Barth, to authorize the Chairman, Auditor, and Emergency Management Director to enter into the 2014 Reimbursement Terms and Conditions Agreement, State Homeland Security Program Grant Award, in the amount of \$127,874.86. 5 ayes.

Lynn DeYoung, Emergency Management Director, gave a briefing on a grant award from the South Dakota Department of Health in the amount of \$10,000. The purpose of the grant is for funding training classes for mass fatality management. MOTION by Pekas, seconded by Kelly to authorize the Chairman, Auditor, and Emergency Management Director to enter into the State of South Dakota Sub-Recipient Grant Agreement between Minnehaha County Emergency Management and the South Dakota Department of Health in the amount of \$10,000. 5 ayes.

AGREEMENT

Kristin Trana, Administrative Coordinator for the Sheriff's Office, gave a briefing on the 2015 Police Service Agreements. The hourly rate will be increased from \$30.30 in 2014 to \$31.90 in 2015. MOTION by Pekas, seconded by Kelly to authorize the Chairman to sign the 2015 Police Service Agreements between Minnehaha County and the Cities of Baltic, Colton, Crooks, Dell Rapids, Garretson, Hartford, Humboldt, and Valley Springs. 5 ayes.

DISCUSSION

Commissioners held a discussion on how to proceed with a review of the election process. Chairman Heiberger stated Commissioner Barth has brought forward questions concerning the 2014 General Election to the commission and she would like to have an independent review to address issues and concerns that have been reported. Commissioner Kelly stated he would like to see Shantel Krebs, the recently elected Secretary of State, citizen representation, and people who understand the election process on the review board. Commissioner Barth stated he is disappointed that the November 7th Canvass meeting was not recorded and that the minutes didn't reflect any discussion of concerns he raised regarding the election. Barth further stated that now it appears there is no plan to have that discussion. Barth stated that going forward with a review panel is a reasonable thing to do. Chairman Heiberger stated that the election issue was brought up under old business during the November 11, 2014 commission meeting and it is an agenda item at today's meeting. Commissioner Pekas stated an independent review is necessary and the recently elected Secretary of State, Auditor, and independent people in our community should be involved in the process to make suggestions to all the different local entities of government. Commissioner Beninga stated the review process needs to be started as quickly as possible but not necessarily be completed as soon as some people may want. Beninga stated he would also like to include the vendor of the equipment in the process. Hopefully a result that everybody can agree on will avoid the majority of the problems with elections. The Commission decided by consensus to have each Commissioner, Secretary of State Elect Shantel Krebs, and Auditor Bob Litz nominate a person to serve on the election review board. The nominations will be brought forward at the December 2, 2014 commission meeting for review and appointment. Also discussed at that time will be what the commission wants the panel to accomplish.

AGREEMENTS

Robert Wilson, Assistant Commission Administrative Officer, presented the 2015 per diem agreements between Minnehaha County, Volunteers of America Dakotas, and the 13 counties that are part of the regional detention partnership. Member counties will pay \$165 per day for secure and non-secure detention at the JDC. This is an increase from the 2014 rate of \$155 per day. The rate for non-secure detention at the VOA facility will be at \$120 per day. This is an increase from the 2014 rate of \$115 per day. MOTION by Kelly, seconded by Pekas, to authorize the Chairman to sign the 2015 Minnehaha County Regional Detention Center Per-Diem Contracts with the following counties: Bon Homme, Brookings, Charles Mix, Clay, Hanson, Hutchinson, Lake, Lincoln, McCook, Miner, Moody, Turner, and Yankton. 5 ayes.

Robert Wilson, Assistant Commission Administrative Officer, gave a briefing on an agreement with Hauge Associates. Inc. for lien notification and collection services on behalf of Minnehaha County. The fee schedule is 30% on recoveries through non-legal collection efforts and 30% on recoveries where litigation is authorized by the County Commission. There will be no fee collected by Hauge for accounts where the County is receiving payment from the Clerk of Courts for attorney fees which originate through court ordered payment. MOTION by Pekas, seconded by Barth to authorize the Chairman to sign the Lien Collection Services Agreement between Minnehaha County and Hauge Associates, Inc. for a three year term beginning January 1, 2015 and ending December 31, 2017. 5 ayes.

LEASE

Robert Wilson, Assistant Commission Administrative Officer, gave a briefing on the 2015 lease agreement between Minnehaha County and CASA (Court Appointed Special Advocate). Under the terms of the agreement, CASA will pay \$7,250 to lease 1,500 square feet of office space on the first floor of the Extension Building. CASA will make four payments in the amount of \$1,812.50 at the beginning of each quarter. The County pays for heat, electricity, and janitorial service. MOTION by Pekas, seconded by Barth, to authorize the Chairman to sign the 2015 lease agreement between Minnehaha County and CASA. 5 ayes.

LIAISON REPORTS

Commissioner Kelly reported on the November 17, 2014 Diversity Committee meeting. The primary mission of the group is to file reports with the federal government and make sure the county is in compliance with federal regulations.

Commissioner Barth reported that last week the Homeless Advisor Board met. Barth also read an email sent to him by Carol Muller, Human Services Director, that stated the last homeless count was over 600 people. Ms. Muller also reported 32 families were recently put into hotels in Sioux Falls.

Commissioner Kelly reported on the Township meeting that he and Commissioner Barth attended. Kyle Helseth, Director of Equalization, talked about the increases there will be in ag valuations this year. They also discussed the new signs and the program for stop signs.

Chairman Heiberger reported on the Public Defender's Office Advisory Board meeting where they had a demonstration on the new case management program designed by the Minnehaha County Information Technology Department.

NEW BUSINESS

Robert Wilson, Assistant Commission Administrative Officer, thanked the Commission for their patience with the issues experienced at the beginning of the meeting with Commissioner Beninga's video/audio conference link.

Robert Wilson, Assistant Commission Administrative Officer, reported that the operating account for Safe Home that is administered by Lloyd Company is going to be repaying the county loan above and beyond the scheduled amount again this year. At the end of this year there will be a total of \$100,000 above the scheduled repayment of funds that will be coming back to the county. Chairman Heiberger stated that one third of the residents at Safe Home pay their own rent.

Motion by Pekas, seconded by Barth, to adjourn into executive session for personnel and legal briefing. 5 ayes.

The Commission adjourned until 9:00 a.m. on Tuesday November 25, 2014.
