#### **RESOLUTION MC14-72**

RESOLUTION OF THE COUNTY OF MINNEHAHA, SOUTH DAKOTA GIVING APPROVAL TO A PROJECT ON BEHALF OF THE AUGUSTANA COLLEGE ASSOCIATION AND ITS FINANCING UNDER SOUTH DAKOTA CODIFIED LAWS, CHAPTER 9-54; AND AUTHORIZING THE ISSUANCE OF ITS ECONOMIC DEVELOPMENT REVENUE BONDS, SERIES 2014A (THE AUGUSTANA COLLEGE ASSOCIATION PROJECT) IN AN AGGREGATE PRINCIPAL AMOUNT NOT TO EXCEED \$13,000,000 AND ITS ECONOMIC DEVELOPMENT REVENUE BOND, SERIES 2014B (THE AUGUSTANA COLLEGE ASSOCIATION PROJECT) IN AN AGGREGATE PRINCIPAL AMOUNT NOT TO EXCEED \$5,000,000; PRESCRIBING THE FORM OF AND AUTHORIZING THE EXECUTION OF AN INDENTURE OF TRUST, A LOAN AGREEMENT AND CERTAIN RELATED DOCUMENTS; AUTHORIZING THE EXECUTION AND SALE OF THE BONDS AND DIRECTING DELIVERY THEREOF; AND PROVIDING FOR THE SECURITY, RIGHTS, AND REMEDIES OF THE OWNERS OF SAID REVENUE BONDS.

WHEREAS, the County of Minnehaha, South Dakota (the "County") is a political subdivision and corporate body politic duly organized and existing under the Constitution and laws of the State of South Dakota; and

WHEREAS, pursuant to the Constitution and laws of the State of South Dakota, particularly, South Dakota Codified Laws, Chapter 9-54 (the "Act"), the County is authorized to carry out the public purposes described therein and contemplated thereby; and

WHEREAS, the County is authorized by the Act to issue its economic development revenue bonds to finance a project, as defined in the Act, and loan the proceeds thereof to The Augustana College Association (the "College") pursuant to a promissory note (the "Note") and a Loan Agreement (as hereinafter defined); and

WHEREAS, such economic development revenue bonds shall be payable solely from the revenues of the College or other security pledged therefor; and

WHEREAS, the County and Wells Fargo Bank, National Association, as Trustee (hereinafter, together with any successor trustee under the below mentioned Indenture, referred to as the "Trustee"), have agreed to execute and deliver an Indenture of Trust (as hereinafter defined, the "Indenture") pursuant to which the County will issue its Economic Development Revenue Bond, Series 2014A (The Augustana College Association Project) in the principal amount of \$13,000,000 (the "Series 2014A Bond") and its Economic Development Revenue Bond, Series 2014B (The Augustana College Association Project) in the principal amount of \$5,000,000 (the "Series 2014A Bond"); and

WHEREAS, the Bonds are being issued to raise funds to pay a portion of the costs of acquisition, construction and equipping of the Froiland Science Center and related facilities all located or to be constructed on the Land (as hereinafter defined) (the "Project"); and

WHEREAS, the proceeds of the Bonds are to be loaned to the College pursuant to a Loan Agreement between the County and the College (the "Loan Agreement") and the Note; and

WHEREAS, to secure its obligations under the Loan Agreement, the College has agreed to (1) mortgage the real property where the Project is located in Minnehaha County, South Dakota (the "Land") and any improvements now or hereafter installed or located thereon to the Trustee and (2) a pledge of the pledges and receipts have been solicited and received from various donors with respect to the Project; and

WHEREAS, the Bonds are to be sold to one or more financial institutions (the "Original Purchasers"); and

WHEREAS, neither the County nor the State of South Dakota nor any political subdivision thereof (other than the County and then only to the extent of the trust estate pledged in the Indenture, which consists of the payments to be made by the College in accordance with the Loan Agreement) shall be liable on the Bonds or any additional bonds (if and when issued) or other obligations, and the Bonds shall not be a debt of the County or the State of South Dakota or any political subdivision thereof (other than the County and then only to the extent of the

trust estate pledged in the Indenture, which consists of the payments to be made by the College in accordance with the Loan Agreement) and in any event shall not give rise to a charge against the credit or taxing power of the County, the State of South Dakota, or any political subdivision thereof,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF MINNEHAHA, SOUTH DAKOTA AS FOLLOWS:

Section 1. <u>Issuance of Bonds</u>. On the basis of the information provided to the County to date, it appears that it is desirable for the County to issue its Bonds under the provisions of the Act and pursuant to the Indenture for such purpose. The Bonds shall not constitute a charge, lien or encumbrance, legal or equitable, upon any property of the County, except the revenues specifically pledged to the payment thereof, and each Bond, when, as and if issued, shall recite in substance that such Bond, including interest thereon, is payable solely from the revenues and property specifically pledged to the payment thereof, and shall not constitute a debt of the County within the meaning of any constitutional or statutory limitation.

Section 2. <u>Loan Agreement</u>. The County will enter into the Loan Agreement with the College satisfying the requirements of the Act. The loan payments or other amounts payable by the College to the County under the Loan Agreement, together with amounts pledged thereunder and the mortgage on the Land, shall be sufficient to pay the principal of, and interest and redemption premium, if any, on the Bonds as and when the same shall become due and payable.

Section 3. <u>Purpose</u>. The County finds, determines, and declares that the purpose of the Bonds is to provide low cost financing of the Project and economic development for the County. The proceeds of the Bonds will be loaned to the College for such purpose, which meet the general purposes contemplated and described in the Act.

Section 4. <u>Security</u>. The County further finds that the Bonds are and shall be payable solely from the trust estate pledged under the Indenture, including the County's interest in the Loan Agreement and Note, and shall be further secured by a Mortgage One Hundred Eighty Day Redemption, Security Agreement and Financing Statement (the "Mortgage").

Section 5. <u>Public Purpose</u>. The County further finds, determines, and declares that it is a public purpose and is in the best interests of the County to provide for the issuance of the Bonds.

Section 6. <u>No Conflict</u>. The County further finds, determines and declares that to the best of its knowledge, no member of the governing body or other officer of the County is directly or indirectly interested in the Loan Agreement, the issuance and sale of the Bonds, the Project, or any contract, agreement or job contemplated to be undertaken thereunder.

Section 7. <u>Terms of Bonds</u>. The issuance of the Bonds for the purpose described herein is hereby authorized. The Bonds shall bear interest initially at the rate of interest to be established pursuant to the Indenture, shall be in such denomination and form, be numbered and dated, shall mature and be subject to redemption prior to maturity, and shall have such other details and provisions as are prescribed by the Indenture.

Section 8. <u>Limited Obligations; Execution</u>. All Bonds shall be special limited obligations of the County payable solely from and secured by a pledge of the trust estate under the Indenture, including the County's interest in the Loan Agreement and Mortgage, in the manner provided in the Indenture. The Bonds do not and shall not constitute an indebtedness, liability, general or moral obligation (except to the extent of the trust estate pledged under the Indenture) or a pledge of the faith and credit or any taxing power of the County, the State of South Dakota, or any political subdivision thereof.

The County hereby authorizes and directs the Chair of the Board of County Commissioners and the County Auditor to execute the Indenture, and to deliver to said Trustee the Indenture, and hereby authorizes and directs the execution and delivery of the Bonds in accordance with the Indenture, and hereby provides that the

Indenture shall provide the terms and conditions, covenants, rights, obligations, duties, and agreements of the bondholders, the County and the Trustee as set forth therein.

All of the provisions of the Indenture, when executed as authorized herein, shall be deemed to be a part of this resolution as fully and to the same extent as if incorporated verbatim herein and shall be in full force and effect from the date of execution and delivery thereof. The Indenture shall be substantially in the form on file with the County on the date hereof, and is hereby approved with such necessary and appropriate variations, omissions, and insertions as are not materially inconsistent with such form and as the Chair of the Board of County Commissioners, in the discretion of the Chair of the Board of County Commissioners with advice of the State's attorney, shall determine; provided that the execution thereof by the Chair of the Board of County Commissioners shall be conclusive evidence of such determination.

Section 9. <u>Designated Representatives</u>. The Chair of the Board of County Commissioners and the County Auditor are hereby designated as the representatives of the County with respect to the issuance of the Bonds and the transactions related thereto.

Section 10. <u>Execution of Loan Agreement</u>. The Chair of the Board of County Commissioners and the County Auditor are hereby authorized and directed to execute and deliver the Loan Agreement with the College, and when executed and delivered as authorized herein, the Loan Agreement shall be deemed to be a part of this resolution as fully and to the same extent as if incorporated verbatim herein and shall be in full force and effect from the date of execution and delivery thereof. The Loan Agreement shall be substantially in the form on file with the County on the date hereof, which is hereby approved, with such necessary variations, omissions, and insertions as are not materially inconsistent with such form and as the Chair of the Board of County Commissioners, in the discretion of the Chair of the Board of County Commissioners with advice of the State's attorney, shall determine; provided that the execution thereof by the Chair of the Board of County Commissioners shall be conclusive evidence of such determination.

Section 11. <u>County Covenants; Not a General Obligation</u>. All covenants, stipulations, obligations, representations, and agreements of the County contained in this resolution or contained in the Indenture or other documents referred to above shall be deemed to be the covenants, stipulations, obligations, representations, and agreements of the County to the full extent authorized or permitted by law, and all such covenants, stipulations, obligations, representations, and agreements shall be binding upon the County. Except as otherwise provided in this resolution, all rights, powers, and privileges conferred, and duties and liabilities imposed, upon the County by the provisions of this resolution or of the Indenture or other documents referred to above shall be exercised or performed by the County, or by such officers, board, body, or agency as may be required or authorized by law to exercise such powers and to perform such duties. No covenant, stipulation, obligation, representation, or agreement herein contained or contained in the Indenture or other documents referred to above shall be deemed to be a covenant, stipulation, obligation, representation, or agreement of any officer, agent, or employee of the County in that person's individual capacity, and neither the members of the Board of County Commissioners of the County nor any officer or employee executing the Bonds shall be liable personally on the Bonds or be subject to any personal liability or accountability by reason of the issuance thereof.

No provision, covenant or agreement contained in the Indenture, the Loan Agreement, the Bonds or in any other document relating to Bonds, and no obligation therein or herein imposed upon the County or the breach thereof, shall constitute or give rise to a general obligation of the County or any charge upon its general credit or taxing powers. In making the agreements, provisions, covenants and representations set forth in the Indenture, the Loan Agreement, the Bonds or in any other document relating to the Bonds, the County has not obligated itself to pay or remit any funds or revenues other than the trust estate described in the Indenture.

Section 12. <u>No Third Party Beneficiaries</u>. Except as herein otherwise expressly provided, nothing in this resolution or in the Indenture, expressed or implied, is intended or shall be construed to confer upon any person, other than the County, the owners of the Bonds, and the Trustee, as fiduciary for owners of the Bonds, to the extent expressly provided in the Indenture, any right, remedy, or claim, legal or equitable, under and by reason of this resolution or any provision hereof or of the Indenture or any provision thereof, this resolution, the Indenture and all of their provisions being intended to be and being for the sole and exclusive benefit of the

County, the owners of the Bonds, and the Trustee as fiduciary for owners of the Bonds issued under the provisions of this resolution and the Indenture, and the College to the extent expressly provided in the Indenture.

Section 13. <u>Severability</u>. In case any one or more of the provisions of this resolution or of the Indenture or of the Bonds issued hereunder shall for any reason be held to be illegal or invalid, such illegality or invalidity shall not affect any other provision of this resolution or of the Indenture or of the Bonds, but this resolution, the Indenture and the Bonds shall be construed as if such illegal or invalid provision had not been contained therein. The terms and conditions set forth in the Indenture, the pledge of revenues derived from the Loan Agreement and the Mortgage, the creation of the Bonds pursuant to and under the Indenture, and the application of said revenues, collateral, and other moneys are all commitments, obligations, and agreements on the part of the County contained in the Indenture, and the invalidity of the Indenture shall not affect the commitments, obligations, and agreements on the part of the Bonds for the purposes, in the manner, and according to the terms and conditions fixed in the Indenture, it being the intention hereof that such commitments on the part of the County are as binding as if contained in this resolution separate and apart from the Indenture.

Section 14. <u>Satisfaction of Conditions Precedent</u>. All acts, conditions, and things required by the laws of the State of South Dakota, relating to the adoption of this resolution, to the issuance of the Bonds, and to the execution of the Indenture and the other documents referred to above to happen, exist, and be performed precedent to and in the enactment of this resolution, and precedent to the issuance of the Bonds, and precedent to the execution of the Indenture and the other documents referred to above have happened, exist, and have been performed as so required by law. The members of the Board of County Commissioners of the County, officers of the County, and attorneys and other agents or employees of the County are hereby authorized-to do all acts and things required by them by or in connection with this resolution and the Indenture and the other documents referred to above, and this resolution.

Section 15. Further Authorization To Execute And Deliver Documents. The Chair of the Board of County Commissioners and the County Auditor are authorized and directed to execute and deliver any and all certificates, agreements or other documents which are required by the Indenture, the Loan Agreement, or any other certificates or documents which are deemed necessary by bond counsel to evidence the validity or enforceability of the Bonds, the Indenture or the other documents referred to in this resolution, or to evidence compliance with Section 148 of the Internal Revenue Code of 1986, as amended; and to take such other administrative action as is permitted or required by the Indenture, the Loan Agreement and the Bond Purchase Agreement. All such agreements or representations when made shall be deemed to be agreements or representations, as the case may be, of the County. If for any reason the Chair of the Board of County Commissioners is unable to execute and deliver those documents referred to in this resolution, any other member of the Board of County Commissioners of the County may execute and deliver such documents with the same force and effect as if such documents were executed by the Chair of the Board of County Commissioners. If for any reason the County Auditor is unable to execute and deliver the documents referred to in this resolution, such documents may be executed and delivered by the Deputy County Auditor with the same force and effect as if such documents were executed and delivered by the County Auditor.

Section 16. <u>Reimbursement of Expenses.</u> The College shall reimburse the County for its costs incurred with the issuance of the Bonds, including the costs of publication, cost of any attorneys' fees incurred by the County and an administrative fee for the time incurred by the County with the review of the documents and ongoing monitoring and reporting requirements in such amount as determined by the County Auditor is reasonable and in the best interests of the County for the transaction of this nature and complexity.

# CHANGE ORDER

DJ Buthe, Highway Superintendent, gave a briefing on Change Order #1 to the contract with Prahm Construction, Inc. for Project MC253-460BR-14, replacement of two structures 5 miles north and 3 miles east of Humboldt. The project is complete and the change order is for addition and subtraction of quantities to complete the final pay application for the project. The net subtraction to the change order and decrease to the contract value is \$1,861.90 resulting from minor additions and subtractions to the project for various field measured quantities. MOTION by Barth, seconded by Kelly, to authorize the Chairman to sign Change Order #1 to the contract with Prahm Construction, Inc. for an amended contract amount of \$496,074.20. 4 ayes.

# APPOINTMENT

Commissioner Kelly gave a briefing on the appointment of Dr. Bill Smith to the County Criminal Justice Advisory Committee. This past summer Craig Anderson resigned his position as Chairman of the Committee, and Assistant Sheriff Michelle Boyd was appointed as Committee Chair. This left two citizen positions on the committee vacant. The Criminal Justice Advisory Committee recommends the appointment of Dr. Smith be approved by agreement of the Chairs of the County Commission and the

# DISCUSSION

Robert Wilson, Assistant Commission Administrative Officer, reported the Commission Office has been contacted by a number of people who have expressed an interest in being appointed to the County Commission following the anticipated resignation of Commissioner Pekas, due to being elected as a Circuit Judge in the Second Judicial Circuit. Mr. Wilson requested the Commission recommend a way to formally recognize those who have expressed an interest in the position and that the Commission have a discussion on the process they would like to use to fill the position. Mr. Wilson also stated that the process cannot get under way until the vacancy occurs. Commissioner Pekas stated that in order to get the process started, he would prepare his resignation later today with the idea that it will not become effective until the end of the year. Kersten Kappmeyer, Chief Civil Deputy State's Attorney, stated that according to statute, even if Commissioner Pekas were to submit his resignation with an effective date of the end of the year, the appointment process could not start until after his resignation was effective. Mr. Kappmeyer also stated that there is not a defined procedure in statute as to how do proceed with the appointment. Commissioner Kelly stated they should consider if they want to make a caretaker appointment to the position. Kelly stated he thinks there is a lot of merit to making an appointment of someone who would only serve the remaining two years of the term. Kelly also stated they will have to find someone who already has a pretty deep knowledge of the process of government, and that he feels the person appointed will have an edge of incumbency going into the 2016 election. Chairman Heiberger stated she disagrees with Commissioner Kelly and believes they should appoint the very best candidate to the position and if that person decides to run in 2016, it will then be up to the voters who they elect. Heiberger also stated voters need to be informed when they go to the polls as to who is doing what type of a job, and that the Commission has worked very hard in dealing with the financial issues of the County. Heiberger further stated that they should not appoint a place holder to the position for two years when they are making important decisions. In response to a question from Commissioner Barth, Kersten Kappmeyer stated that under statute, a letter of resignation from Commissioner Pekas is to be submitted to the Auditor's Office who then transmits it to the Commission Office. Pekas's resignation becomes effective on the date stated in the letter. Chairman Heiberger stated they should ask for resumes to be submitted to the Commission Office and for those names to be kept confidential during the review process. Heiberger also stated that they could discuss setting a deadline for submission of applications at the commission meeting next week under old business when Commissioner Beninga is in attendance. Commissioner Pekas spoke on the job duties and time requirements of being a County Commissioner. Chairman Heiberger asked the Commission Office to put out a press release asking for applications to be submitted without listing a deadline, then follow up with a deadline after Commissioner Beninga has an opportunity to weigh in. Commissioner Kelly asked Commissioner Pekas if he would put in writing the details of the position as he previously stated, so applicants have an understanding of the job requirements.

# LIAISON REPORTS

Commissioner Barth reported on the Planning Commission meeting on November 24, 2014 where they moved the solar array forward with some changes. Barth also stated that there will soon be a vacancy on the Planning Commission due to the end of Mark Rogen's term.

Commissioner Barth reported that the Multi Cultural Center is going to have a pancake event on December 7<sup>th</sup>. Tickets are \$6.00, and he has purchased tickets for the Commissioners.

Commissioner Kelly and Robert Wilson reported on a tour of the Johnson County, Kansas Central Booking Center in Olathe, KS. Representatives from the Sheriff's Department, Jail, and Criminal Justice Advisory Committee met with several staff members including Major Doug Baker of the Johnson County Sheriff's Office and Betsy Gillespie, Director of the Johnson County Department of Corrections. The purpose of the trip was to see their central booking location as part of the site master planning process the Criminal Justice Advisory Committee is currently engaged in with Shive Hattery and TSP.

# NEW BUSINESS

Scott Anderson, Planning & Zoning Director, stated that they are putting out a press release for the upcoming vacancy on the Planning Commission. The vacancy will be open through the 15<sup>th</sup> of December. Mark Rogen's term expires December 31, 2014 and he is eligible for reappointment should he decide to reapply. Appointments to the Planning Commission are for four year terms, and the Planning Commission meets in the evening on the 4<sup>th</sup> Monday each month with the exception of December when they do not hold a meeting. Mr. Anderson also reported that December 4<sup>th</sup> is the date for the next meeting of Invision 2035, which is the review and rewrite of the Comprehensive Plan.

Robert Litz, Auditor, reported on the vote recount that was held on November 24, 2014 for the State Representative race in District 9. The request was petitioned by Bob Deelstra who received eight (8) votes less than the second place finisher, Paula Hawks. Mr. Litz stated that the recount resulted in the same vote totals as the totals reported on election night.

Robert Wilson, Commission Administrative Officer, reported that the state association does put out a booklet titled "So You Want to Be a County Commissioner" that lists the duties and responsibilities of the position and they will send a copy of that to each person they receive a resume from.

Chairman Heiberger reported that Peter Harriman will be retiring from his position at the Argus Leader and thanked him for his fair and accurate coverage of the Commission Meetings. Commissioner Kelly also thanked Mr. Harriman for his reporting. Commissioner Barth stated Mr. Harriman's work also covers a huge diversity of issues and his work with the county is only a small part of what he knows.

Motion by Barth, seconded by Kelly, to adjourn into executive session for personnel and legal briefing, and contract negotiations. 4 ayes.

The Commission adjourned until 9:00 a.m. on Tuesday December 2, 2014.
