TAX DEED

Bob Litz, Auditor, gave a briefing on Tax Deed #2560, RDID 42268 that was gifted to the South Eastern Development Foundation (SEDF) for the purposes of affordable housing. SEDF has been in the process of quiet title action on the property to clear a federal tax lien. That process is complete and Mr. Litz requested approval of a resolution transferring the property to SEDF. The transfer of county property to a nonprofit organization requires a unanimous approval of the full Commission. SUPPLEMENTS

Darlene Johnson, Assistant Auditor, requested supplements representing reimbursements and pass-through dollars which must be recorded in the county budget.

MOTION by Barth, seconded by Pekas, to supplement from the General Fund to the Auditor-Elections budget, ASN 15189, Election Equipment, \$217,625 representing reimbursement from the City of Sioux Falls and the State of South Dakota HAVA funds for the cost of the DS850 tabulating machines purchased. 4 ayes.

DJ Buthe, Highway Superintendent, reported on the December 17, 2014 bid opening for Highway Project MC126BR-14, Structure Replacement for #50-143-120. The following four bids were received: Dakota Contracting Corporation \$304,435.65; Nolz Dragline & Construction, Inc. \$315,728.94; Prahm Construction, Inc. \$344,473.60; Graves Construction \$387,899.80. Mr. Buthe recommended the bid award for the project go to the low bidder, Dakota Contracting Corporation. MOTION by Pekas, seconded by Barth, to award the bid for Highway Project MC126BR-14 to Dakota Contracting Corporation in the amount of \$304,435.65. 4 ayes.

DJ Buthe, Highway Superintendent, reported on the December 10, 2014 bid opening for Project MC 14-16, Grading, Rip Rap, and Miscellaneous Repairs to Structures. Minnehaha County will be reimbursed 81.95% of the cost of the permanent repairs. The South Dakota Department of Transportation (SD DOT) will reimburse the county for eligible costs. The following eleven bids were received: Soukup Construction \$66,224.56; BX Civil & Construction \$97,363.89; Zacharias Construction, Inc. \$99,802.11; Prahm Construction \$102,079.25; Rounds Construction Company \$107,459.75; First Rate Excavate, Inc. \$109,202.40; Schenk Industries \$112,528.20; Smith & Smith Construction \$138,892.00; Krueger Excavating & Paving \$141,843.95; H&W Contracting, LLC \$195,282.50; RP&H, Inc. \$199,562.00. CHANGE ORDER

DJ Buthe, Highway Superintendent, gave a briefing on Change Order #3 to the Contract with Prahm Construction, Inc. for Project MC121-STR13, Replacement of Bridge Structures 50-240-85 and 50-240-95 on Highway 121. The change order is for addition and subtraction of field measured quantities and liquidated damages resulting in a deduct of \$24,589.59. MOTION by Pekas, seconded by Barth, to authorize the Chairman to sign Change Order #3 to the contract with Prahm Construction, Inc. for Project MC121-STR13 resulting in a new contract amount of \$1,076,008.81. 4 ayes.

AGREEMENT

DJ Buthe, Highway Superintendent, gave a briefing on the State of South Dakota Department of Transportation (SD DOT) Force Account Agreement for the 2014 Flood Event. This agreement allows Minnehaha County to be reimbursed for eligible costs associated with the approved Emergency Relief projects. MOTION by Pekas, seconded by Kelly, to authorize the Chairman to sign the Transportation Force Account Agreement for the 2014 Flood Event between Minnehaha County and the SD DOT. 4 ayes.

SALE PROCEEDS

DJ Buthe, Highway Superintendent, reported on the Iron Planet auction of surplus property that was held on December 11 & 12, 2014. The total sale proceeds were \$45,276. SDCL 6-13-8 provides that the sale revenue may be credited, at the discretion of the governing board, to the Highway Fund or to the General Fund. MOTION by Barth, seconded by Kelly, to designate \$45,276 in proceeds from the sale of surplus property from the Highway Department on Iron Planet to the Highway Fund, ASN 13983. 4 ayes.

LAISON REPORTS

Commissioner Barth and Scott Anderson, Planning & Zoning Director, commented on the progress of the Intergovernmental Planning group in designing forms to be used by all entities and in setting up guidelines for hosting meetings.

Commissioner Barth commented on a luncheon he attended at Safe Home that was hosted by Lloyd Companies.

Chairman Heiberger commented on the Chamber Meeting last week where they stated in their platform support of the TIF program and opposition to any changes that would negatively impact the program. Heiberger stated that she expressed to the Chamber that the County is interested in having a seat at the table during TIF discussions due to the affect they have on County finances.

Commissioner Kelly asked if there has been any action taken to see that a representative from the SE District is in attendance during the 2015 Legislative Sessions. Ken McFarland, Commission Administrative Officer, stated he and Robert Wilson were asked to coordinate with Bob Wilcox, Executive Director of the South Dakota Association of County Commissioners, to identify what sessions would be most critical for a representative to attend.

OLD BUSINESS

Commissioners Barth, Heiberger, and Kelly spoke on Commissioner Pekas's service on the County Commission, and wished him well as he begins his new position as a Circuit Court Judge.

Commissioner Pekas stated that he will not be able to attend the December 30, 2014 commission meeting; however he would be able to phone in and vote on the transfer of the tax deed property to SEDF. MOTION by Pekas, seconded by Barth to defer consideration of a resolution to Quit Claim Deed Tax Deed #2560, RDID 42268 to the South Eastern Development Foundation until the December 30, 2014 meeting. 4 ayes.

Commissioner Pekas spoke on his years serving as a County Commissioner.

Chairman Heiberger reported that Commissioner Beninga emailed to say he is on his way to the meeting.

MOTION by Pekas, seconded by Barth, to recess into executive session for contract discussion, legal briefing, and personnel, with the intent to come back into regular session to consider the transfer of Tax Deed #2560, RDID 42268 to the South Eastern Development Foundation and to rescind the action to defer that item to the December 30, 2014 commission meeting. 4 ayes.

Commissioner Beninga joined the meeting.

The Commission came out of executive session.

Motion by Beninga, seconded by Barth to approve the transfer of Tax Deed #2560, RDID 42268 to the South Eastern Development Foundation and Resolution MC14-84. 5 ayes.

RESOLUTION MC14-84

WHEREAS, Minnehaha County holds under Tax Deed proceedings the following property:

Deed #2560, RDID #42268, for property legally described as Lot 13, Block 28, Pettigrew's Addition to City of Sioux Falls

WHEREAS, it is in the best interest of Minnehaha County taxpayers to transfer this property to the South Eastern Development Foundation; and

WHEREAS, the South Eastern Development Foundation has agreed to develop this property with the purpose of providing affordable housing; now

BE IT FURTHER RESOLVED, that the County Treasurer is hereby authorized to issue a Quit Claim Deed thereto and the County Auditor is hereby authorized to abate all outstanding taxes, interest, penalties, and municipal nuisance special assessments levied against this property.
