The structure is located on 255th Street between 462nd and 463rd Avenue approximately 4 miles north of Hartford. The daily average traffic count on the bridge is five (5) vehicles per day. The estimated cost of the project is \$472,000. Mr. Buthe stated this project is a higher priority because the structure is in poor condition and is very narrow. Beninga stated that there are alternative routes, and with the cost of this project he would prefer they look at a higher need bridge with a higher traffic count before spending this kind of money. Commissioner Kelly stated he would prefer to see what the state legislature does with the bridge fund and whether there are any excess moneys towards the end of

the season. Commissioner Kelly also stated he would like to allow time for the township and other interested parties to speak on this project. SUBSTITUTE MOTION by Kelly, seconded by Beninga, to defer this item for one week. VOTE to substitute the motion, 4 ayes. VOTE on substituted motion, 4 ayes.

LIEN COMPROMISE

Robert Wilson, Assistant Commission Administrative Officer, gave a briefing on a request for compromise of lien for DPNO 25594, 31009, and 7101. There are two applicants who are in the process of purchasing a home together. During a title search the three liens were noted against the applicants. DPNO 25594 is for public defender services provided to the first applicant in the amount of \$3,011.15. Three payments were received on the lien totaling \$99.15. The last payment was received on August 18, 2010. The applicant has an annual salary of \$21,060 according to his 2013 tax return. He lists assets of \$500 and liabilities of over \$13,000, mostly for back child support payments in South Dakota and Minnesota. The applicant is requesting a release of the lien in full with no payment due to the burden of his child support payments. DPNO 31009 is for poor relief and public defender services provided to the second applicant. A number of payments have been received totaling \$830, bringing the lien to its current balance of \$2,394.06. The last payment on this lien was on February 24, 2010. The applicant has an annual salary of \$16,000 according to her 2013 tax return. She received a refund of \$4,250 and is using \$3,000 for the cash required at the closing on the home. She lists assets and liabilities of \$4,000 representing the value and the debt on an automobile. She is requesting a compromise and release of the lien in full upon payment of \$1,000. DPNO 7101 is in the name of the second applicant and her ex-husband. The lien is for a variety of poor relief services, court appointed attorney services, and public defender services provided between April, 1981 and May, 2014. Payments totaling \$2,234.47 have been made on the lien. In addition, the county commission compromised \$22,786.01 in accordance with the County's annual lien compromise policies resulting in a present balance of \$20,145. A county records search showed that all of the services listed on this lien were received by the second applicant's ex-husband. She is requesting that her name be removed from the lien account with no payment leaving the lien only in the name of her ex-husband. Commissioner Kelly stated concern regarding no offer of payment from the applicant and also for the child support the applicant owes. MOTION by Beninga, seconded by Bender, to defer action on DPNO 25594 for one week. 3 ayes. Kelly voted nay. Motion carried.

REQUEST

Traci Smith, Public Defender Director, gave a briefing on Gideon's Promise Law School Partnership Project. The program provides its partners the opportunity to recruit law student grads from law schools across the country. Salaries of the lawyers recruited through the program would be paid for one year, as well as three years of education and training for one recruit hired each year. The County would be responsible for paying a \$6,500 education and training fee for each additional lawyer they recruit each year. As long as the attorneys are in compliance with the terms and conditions of employment, the program asks that they are moved into permanent positions following their first year. Ms. Smith asked for authorization to have two Gideon's Promise lawyers placed in the Public Defender's Office. Ms. Smith stated she believes with the employee turnover her office experiences it will be possible to plan accordingly to move the attorneys placed through the program into permanent positions. The first attorney would be at no cost to the County for one year and the second attorney would be a cost of \$6,500 for the education and training fee. The salaries of both attorneys would be paid by the program. Commissioner Kelly questioned possible liability issues of having attorneys working for the County that aren't employees. Kersten Kappmeyer, Chief Civil Deputy State's Attorney, stated there will be ongoing discussions regarding liability and other employee issues as well as to define the terms of our relationship with Gideon's Promise. Mr. Kappmeyer suggested the Commission may want to consider authorization to pursue the Gideon's Promise Law School Partnership Project and re-visit the issue when the terms of the partnership are better defined. Commissioner Bender stated she would make the motion to pursue, if she understood exactly what they were pursuing.

Chairperson Heiberger stated the motion was to pursue the Gideon's Promise Law School Partnership Project, motion seconded by Beninga. Commissioner Kelly sought clarification that the motion would still require the matter to come back before the Commission before any further action was authorized beyond pursuit of the program. Commissioner Heiberger confirmed that was her understanding of the motion. VOTE on motion, 4 ayes. Commissioner Heiberger stated again after the vote her understanding that authorizing any particular public defender position through this program would need additional commission approval.

AGREEMENT

DJ Buthe, Highway Superintendent, gave a briefing on a Professional Services Agreement with Civil Design Inc. for construction design services for the replacement of bridge structure 50-289-060. The bridge is located on County Highway 114 approximately four miles west of Sherman. MOTION by Kelly, seconded by Beninga, to authorize the Chairperson to sign the Professional Services Agreement with Civil Design, Inc. for construction administration services for the replacement of Structure 50-289-060 at a cost not to exceed \$55,130. 4 ayes.

Kersten Kappmeyer, Chief Civil Deputy State's Attorney, asked the Commission to consider if they would like to intervene as a party in the Dakota Access Pipeline proceedings before the South Dakota Public Utilities Commission. Party status would allow Minnehaha County to bring concerns about factors that are relevant in the pipeline application directly to the Public Utilities Commission for consideration. MOTION by Kelly, seconded by Bender, to authorize Minnehaha County's intervention in the matter of the application to the South Dakota Public Utilities Commission by Dakota Access, LLC for the Dakota Access Pipeline Project Docket Number HP14-002. 4 ayes.

LEGISLATIVE UPDATE

Robert Wilson, Assistant Commission Administrative Officer, gave an update and status report of the 90th Legislative Session on bills that impact Minnehaha County.

LIAISON REPORT

Commissioner Beninga stated he believes it would be important to have a monthly meeting with the Highway Superintendent regarding prioritizing road and bridge projects and how townships might be involved in funding some of those projects.

NEW BUSINESS

Shannon Schultz, Assistant Highway Superintendent, stated he misspoke at last week's commission meeting and wanted to correct his statement regarding two miles of gravel road in the far west portion of Minnehaha County that are farmed out to McCook County for maintenance. This arrangement is because the road is so far away that it doesn't make sense to take Minnehaha County equipment that distance, not because the Highway Department doesn't have the equipment and knowledge to maintain gravel roads.

MOTION by Kelly, seconded by Beninga, to adjourn into executive session for legal briefing and personnel. 4 ayes.
