AMBULANCE LICENSE

Ken McFarland, Commission Administrative Officer, reported that Rural Metro Ambulance Services will not be providing surface ambulance services in Primary Service Area 5 effective May 21, 2015. The Auditor's Office has received applications from Med-Star Ambulance and Paramedics Plus for a surface ambulance license for Primary Service Area 5 for the licensing period beginning May 21, 2015 through December 31, 2015. Dr. Jeff Luther, Quality Assurance Director, has reviewed the applications and concluded both service providers meet the requirements for licensure under Minnehaha County Ordinance MC31-3-10. Mike Bureau, Chief Operating Officer for Paramedics Plus, was present and spoke on their application and service plan. Jay Masur, Owner and Gerry Bauer, Director of Operations for Med-Star Ambulance were present and spoke on

their application and service plan. Daren Ketcham, Metro Communications Director, spoke on how calls are dispatched and stated they would work to get mutual aid agreements in place with the provider selected. Lynn DeYoung, Emergency Management Director, informed the Commission that there will be some logistical work that needs to be done after a provider is selected and prior to the start of the licensing period. Tom Kaffer, Humboldt Ambulance Director, stated his department feels it would be a smooth transition from the current provider to Paramedics Plus. Commissioners Kelly and Bender stated they would like to defer this item one week for further review of the applications. MOTION by Barth, seconded by Kelly, to defer this item until the April 28, 2015 meeting. 4 ayes.

BRIEFING

Michael Mattson, Deputy Sheriff Lieutenant, gave a briefing on updates to the Minnehaha County Inmate Guidebook for the Jail and the Community Corrections Center Inmate Guidebook. Final approval of the guidebooks will be on April 28, 2015.

APPEAL

Kevin Hoekman, Planner 1, gave a briefing on an appeal of Conditional Use Permit (CUP) #15-17 filed by Annette Krenke. CUP #15-17 allows for the expansion of mini storage units on the property legally described as Tract 3A, France's Tracts, S ½ SW ¼, Section 7-102-49. The property is located at 25788 472nd Avenue in the northeast corner of the Crooks/Renner exit of I-29. The Planning Commission unanimously approved CUP #15-17 with nine (9) conditions at the March 23, 2015 Planning Commission Meeting. Tim Tiahart, petitioner of CUP #15-17, was present and stated they will be planting evergreen trees along the north side of the property as required by condition #8 of the permit and he is in the process of changing the lighting to the west. Annette Krenke, was present and requested the storage units be 1,000 feet from her property line because of the security lights. Ms. Krenke also said she is opposed to a business being built on Mr. Tiahart's property since it is in a residential area. Commissioner Barth stated this area is likely for development as it is located next to the intersection of a county highway and the Interstate. MOTION by Kelly, seconded by Bender to uphold the Planning Commission's approval of CUP #15-17 with nine (9) Conditions. 4 ayes.

BID AWARD

Jason Reaves, Senior Project Engineer, reported on the March 24, 2015 bid opening for Project MC-155-OL-2015, Contracted Overlay on County Highway 155. Five bids were received from the following companies: Asphalt Surfacing Company, \$1,374,936.20; Double H Paving, Inc., \$1,396,269.75; Black Top Paving Company, \$1,407,074.50; Seal Pros, Inc., \$1,555,555.00; and Myrl & Roy's Paving, Inc., \$1,729,279.00. Mr. Reaves recommended the bid award go to the low bidder, Asphalt Surfacing Company. MOTION by Bender, seconded by Barth, to award the bid for Project MC-155-OL-2015 to Asphalt Surfacing Company in the amount of \$1,374,936.20. 4 ayes.

ELECTION EQUIPMENT SALE

Bob Litz, Auditor, requested authorization for the sale of two DS 650 Ballot Tabulation Machines to Marshall County, SD, for a cost of \$100 per machine. Minnehaha County purchased the machines using Help America Vote Act (HAVA) funds. The proceeds from the sale of the machines to Marshall County are to be returned to the State's HAVA fund. Mr. Litz stated the machines do not have to be declared surplus for a government to government sale per SDCL 6-5-5. MOTION by Barth, seconded by Bender, to authorize the sale of two DS 650 Ballot Tabulation Machines serial numbers 4205-7325 and 4205-7328 to Marshall County, SD for a sum of \$200. 4 ayes.
