## REPORT

Traci Smith, Public Defender Director, presented the 2014 Annual Report and Caseload Analysis for the Public Defender's Office. The report is on file in the Auditor's Office.

BID

Jeff Gromer, Warden, reported on the May 13, 2014 bid opening for a DVR Recording System for the Jail. The following three bids were received: Integrated Technology & Security, \$96,475; Com-Tec, \$268,200; Safe-N-Secure, \$139,291.58. The bids are all significantly higher than the budgeted amount for the project of \$50,000. The Sheriff's Office is recommending the rejection of all bids and publishing a new notice to bidders that clarifies the scope of the project to indicate the number of current video cameras the system must support with the ability to expand the system as future needs develop. MOTION by Barth, seconded by Kelly, to reject all bids received on May 13, 2015 for a DVR Recording System for the Jail. 5 ayes. MOTION by Kelly seconded by Barth to authorize the Auditor to republish a revised Notice to Bidders for the purchase of a Video Surveillance Recording System. 5 ayes.

## BRIEFING

DJ Buthe, Highway Superintendent, reported that due to recent legislation, the federal Surface Transportation Program (STP) will be eliminated, and the existing STP dollars will be paid out to participants in 2015. Minnehaha County's portion of the payout is \$1,123,484. Mr. Buthe gave a briefing on additional projects and equipment that he would like to utilize \$732,000 of the unanticipated revenue to support in the 2015 budget.

## AMENDMENT

DJ Buthe, Highway Superintendent, gave a briefing on an amendment to the contract with Infrastructure Design Group for Project MC14-16, Emergency Response Project Construction and Administration. The amendment is in the amount of \$5,106.17. Mr. Buthe reported project site #40 located on Highway 121 between Highways 122 & 130, was a significantly worse than originally anticipated during the initial site surveys. The scope of the work is expanding significantly to fill a scour hole caused by flooding damage. The amendment is for additional construction administration and observation at the site. MOTION by Beninga, seconded by Barth, to authorize the Chairperson to sign Amendment #1 to the contract with Infrastructure Design Group for Project MC14-16 for a new contract amount of \$34,946.57. 5 ayes.

## AGREEMENT

Kersten Kappmeyer, Chief Civil Deputy State's Attorney, presented an agreement between Minnehaha County and the South Dakota Department of Social Services to provide funding to the Minnehaha County State's Attorney's Office for the services of Qualified Expert Witnesses for child abuse and neglect court cases involving Indian children. Mr. Kappmeyer also presented an agreement between Minnehaha County and Luke Yellow Robe to provide the Qualified Expert Witness service. The Indian Child Welfare Act requires an expert witness in cases where placement of Native American Children in non-Indian homes is possible. The State of South Dakota contracts with Minnehaha County for this service and the amount paid to Mr. Yellow Robe matches the amount paid to the County by the State. Under the terms of the agreement Luke Yellow Robe will be paid the sum of \$104,696 for the one-year term payable in four quarterly installments, with the first payment due upon funds being received by the County from the State of South Dakota. MOTION by Beninga, seconded by Barth, to authorize the Chairman to sign the agreement between Minnehaha County and the South Dakota Department of Social Services and between Minnehaha County and Luke Yellow Robe for Qualified Expert Witness Service for the contract period June 1, 2015 thru May 31, 2016. 4 ayes.

## SURPLUS PROPERTY

Monte Watembach, Information Technology Director, requested the AS 400 Server with external DVD-Ram & Tape Drive, Asset #72960 be declared as surplus for the purpose of donation to the City of Sioux Falls. MOTION by Bender, seconded by Barth, to approve Resolution MC15-31. 5 ayes.

## AGREEMENT

Ken McFarland, Commission Administrative Officer, reported that Juvenile Accountability Block Grant funds allocated to Lutheran Social Services (LSS) to provide for a Middle School Diversion Officer, will be exhausted by the end of May 2015. The grant period expires at the end of June 2015. Minnehaha County has negotiated a contract with LSS to continue the program for the remainder of the year. Under the terms of the contract, LSS will provide a 10% match for the officer. Minnehaha County will provide \$31,852 to cover the period from June 2015 thru December 2015. LSS will provide one (1) full time employee to provide evidence based curriculum to youth and families involved with the juvenile justice system. LSS will bill the county for actual costs not to exceed \$31,852 by the 15<sup>th</sup> of each month. MOTION by Beninga, seconded by Bender, to authorize the Chairperson to sign the agreement for Middle School Diversion Officer between Minnehaha County and Lutheran Social Services in the amount of \$31,852 for the period from June 2015 thru December 2015. 5 ayes.

## DISCUSSION

The Commissioners discussed amending Resolution MC11-25 which limits the number of Special Event Alcohol Beverage Licenses issued to any person to six (6) within one calendar year. Commissioner Heiberger stated that the limit on the number of these licenses issued could have an impact on the consumer if the caterer they want to hire already has obtained the maximum number of Special Event Licenses. Commissioners Bender and Kelly commented on the fact that there have not been any complaints received from establishments asking for the limit to be increased. MOTION by Beninga, seconded by Barth, to amend Resolution MC11-25 by increasing the number of Special Event Alcohol Beverage Licenses to twelve (12) per calendar year effective for the current year. Commissioner Beninga spoke on the limited number of caterers and facilities available for people that want to hold an event at a venue that is not a typical bar. VOTE on motion, 2 ayes. Barth, Bender, and Kelly voted nay. Motion fails.

#### SURPLUS PROEPRTY

Kersten Kappmeyer, Chief Civil Deputy State's Attorney, requested the Commission declare two photocopiers previously used in the State's Attorney's Office as surplus for disposal and removed from the County's capital asset list. MOTION by Beninga, seconded by Barth, to approve Resolution MC15-32. 5 ayes.
