AGREEMENT

Kristin Trana, Administrative Coordinator for the Sheriff's Office, gave a briefing on the Inter-Local Agreement between the City of Sioux Falls and Minnehaha County pursuant to the Disparate Allocation Determination for the US Department of Justice 2015 Byrne Justice Assistance Grant in the amount of \$62,365. Under the terms of the agreement, the City of Sioux Falls will retain \$40,537 of the grant allocation and the County will receive \$21,828. MOTION by Bender, seconded by Barth, to authorize the Chairman to sign the Inter-Local Agreement between the City of Sioux Falls and Minnehaha County for the FY2015 Byrne Justice Assistance Grant Program Award. 4 ayes.

APPEAL

Kevin Hoekman, Planner I, was present for the public hearing and gave a briefing on appeals filed in opposition to the Planning Commission's May 18, 2015 unanimous approval of Conditional Use Permit (CUP) #15-29 with twelve (12) conditions. Wyatt Sundvold is the petitioner of CUP #15-29 that allows a Class C Confined Animal Feed Operation (CAFO) for four hundred ninety nine (499) animal units on property owned by Candice Anderson. The property is legally described as Tract 2 (Ex. Tracts A & B & Ex. A 100' Strip Lying Adjacent to Tract A), Anderson's Addition N ½, Section 10-T102N-R48W. The proposed CAFO will be composed primarily of dairy calves that are bottle fed, weaned, and moved to a dairy on a different site. The site plan includes one confinement building that is of a pole shed style construction, and a concrete waste containment structure. The operation will work with a submitted manure management plan. Mr. Sundvold is also pursuing a Certificate of Compliance with the State DENR to show the facility is in compliance with state regulations for a CAFO of 1,000

animal units. An appeal was received by the Minnehaha County Planning & Zoning Department from Jeff and Siri Sorenson, 48186 257th St., Garretson. Also named on the appeal were Gary and Laree Popp, 48132 257th St., Garretson, Troy and Kimberly Barber, 48146 257th St. Garretson, and Loren and Wanda Schoeneman, 25697 482nd Ave., Garretson. A second appeal was received from Kim Beiningen, 809 N. Snowberry Circle, Brandon. Since the Planning Commission's approval of CUP #15-29, Mr. Sundvold has submitted a revised site plan that locates the building further to the south to utilize the existing grove of trees as a northern wind break, and to provide a greater distance from the residents to the north who are appealing the CUP. The revised location of the building would require a signed waiver from the landowner to the southwest of proposed CAFO. The petitioner has indicated he is not able to obtain the signed waivers from the landowners as required by condition #12 which states the required waivers of the property owners of the two dwelling units to the south shall be obtained prior to the issuance of a building permit. Mr. Hoekman read the twelve (12) conditions for CUP #15-29. The petitioner, Wyatt Sundvold, 1600 East Cedar Street, Brandon, SD, stated the dwelling unit to the southeast of the proposed CAFO is outside the required waiver area of 1,100 feet, and requested for that waiver requirement to be removed. Mr. Sundvold also stated that the dwelling unit to the southwest of his proposed CAFO is only 40 to 60 feet short of the 1,100 foot required setback and it also has a CAFO on the property. Mr. Sundvold asked that consideration be given to his current management practices, manure management plan, and fly treatment plan to substantiate a reduction in the 1,100 foot setback so a waiver would not be required from the dwelling unit to the southwest. Opponent Jeff Sorenson, 48186 257th Street, submitted a written document and spoke on his concerns about the project that include the following: there are eight homes located in the half section immediately to the north of the proposed site; the CAFO lies on a half-section between two populated township roads; odor will be carried by the south/southwest prevailing winds; plans for future expansion of the CAFO; the uncovered manure storage structure; the shelterbelt plans; and the approved conditions do not stipulate the animals to be small calves, nor that they be contained within a building. Commissioner Barth asked Mr. Sorenson if there was anything that the applicant could do to make this project acceptable. Mr. Sorenson said it would be helpful if the CAFO was moved south, leave the existing grove of trees, and to enclose the manure storage structure. Mr. Sorenson stated there are inconsistencies in the letter he received from Mr. Sundvold and the report he received from Planning & Zoning staff regarding plans for future expansion. Mr. Sorenson stated there needs to be improvement in the process for issuing these permits. Not seeing reports in advance and finding things out once they are approved have not been helpful. Kim Barber, 48146 257th Street, asked for clarification as to whether the permit is being issued for bottle fed calves or cows, and at what point does the herd have to be weaned down to stay within the 499 animal units limit? Kevin Hoekman stated the calves are worth one animal unit and there is no distinction between a calf and a full grown cow, unless it's a dairy cow which are considered 1.4 animal units. Mr. Hoekman also stated staff can do an inspection of the operation if there is a concern he has more animals than allowed. MOTION by Barth, seconded by Kelly to approve CUP #15-29 with 12 conditions. Mr. Hoekman stated that if Mr. Sundvold is unable to obtain the waivers as required in condition #12, he won't be able to obtain a building permit. Kersten Kappmeyer stated a waiver is required within 1,100 feet of the CAFO per county ordinance. Condition #12 is an additional condition requiring waivers from the two south properties. The property to the southeast is outside of the 1,100 feet, and the waiver requirement for that property could be legally removed. The Commission may find that there is new technology, management practices, topographic features, soil conditions, or other factors which substantiate a reduction in the minimum separation criteria, which could result in a waiver not being required for the property to the southwest. SUBSTITUTE MOTION by Kelly, seconded by Bender, to defer action for two weeks to allow the parties involved to meet and see if they can come to a resolution. Commissioner Barth asked Mr. Sundvold if the CAFO building could be moved so there are no dwellings within 1,100 feet. Mr. Sundvold stated that could be done. Roll Call vote on adoption of substitute motion: 3 ayes, Barth voted nay. Roll Call vote on main motion as substituted: 4 ayes. Item is deferred for two weeks.

APPEAL

David Heinold, Planner I, was present for the public hearing and gave a briefing on an appeal filed by James and Linda Elliot and Jill and Robert Keifer, 48531 265th St. to the Planning Commission's May 18, 2015 unanimous approval of Conditional Use Permit (CUP) #15-32 with eleven (11) conditions. Selden and/or Brenda Lacey are the petitioners. The permit allows a Class B Calf Confined Animal Feed Operation (CAFO) for one thousand two

hundred fifty (1,250) animal units on the property legally described as S ½ SW ¼, Section 17-T101N-R47W. The proposed plan is for two barns housing up to 1,250 dairy calves with no outside pens or access. The construction would be in two phases which consist of 760 head of dairy calves housed in the west barn and 490 head of dairy calves in the east barn. The barns would be constructed with concrete floors and walls engineered to contain all manure in accordance with Natural Resources Conservation Service and DENR standards. A nutrient management plan has been submitted which indicated the petitioner has access to enough cropland to apply manure based on the crop nitrogen needs. Miles Lacey, 26511 485th Ave. Valley Springs, submitted a letter acknowledging that he is willing to waive the setback distance requirement between his residence and the proposed CAFO. Brian Donohoe, 401 E. 8th St., Suite 215, Sioux Falls, the attorney representing Brenda and Selden Lacy, stated the project meets the criteria for a conditional use of this size, and spoke on the benefits of CAFOs to the environment and agricultural production. Seldon and Brenda Lacey spoke on their plans for improving their family operation for the future of their children. Steve Ollerich, 904 Eagle Run, Dell Rapids, current President of the Sioux Basin Cattlemen's Association, spoke in support of the project. Barry Berg, 1307 N. Clark Avenue, Dell Rapids, employed by the SD Association of Conservation Districts, stated a concern about the shelterbelt impeding the air flow of the facility, and also spoke in support of the project. Walt Bones, 46036 268th Street, Chancellor, former Planning Commission board member, stated this project complies with the Comprehensive Plan for Minnehaha County and that this project will be better for the environment and for the animals and encourages support for the project. Matt Swanson stated he grew up on the farm to the west of the proposed CAFO and that he supports the project. Don Johnson, Valley Springs Township board member, stated the township will handle the culvert permit and approach when the building is ready, and the Township has no problem with the facility. No one spoke in opposition to the permit. MOTION by Barth, seconded by Kelly, to uphold the Planning Commission's approval of CUP #15-32 with the following conditions: 1) The facility shall not exceed 1,250 animal units in size. 2) Copies of the nutrient management plans shall be approved and filed with the Minnehaha County Planning Department on an annual basis. 3) Approval must be obtained by the township for the construction of the new road access. 4) An address sign must be purchased at the Planning Department and placed at the driveway of the facility. 5) The roofed sorting and receiving area must be in conformance with South Dakota Department of Environment and Natural Resources design standards for any newly constructed waste containment facility. A registered professional engineer shall certify the plan specifications and the construction of the facility. 6) A landscaping plan shall be submitted to the Planning Department consisting of shelter belt trees on the north and west sides. Any dead trees shall be replaced within one season. 7) The facility shall conform to the submitted site plans. Any minor changes may be approved by the staff at the Minnehaha County Planning Department. Major changes will require an amendment to this permit and a public hearing. 8) All driveways, parking, and loading areas within the site must comply with minimum standards that are listed in Section 15.04 of the 1990 Revised Zoning Ordinance for Minnehaha County. 9) A rendering service must be used to pick up and remove dead animals from the property. 10) A building permit is required for all structures prior to construction. 11) That the Planning & Zoning Department reserves the right to enter and inspect the CAFO at any time, after proper notice to the owner, to ensure that the property is in full compliance with the conditional use permit conditions of approval and Minnehaha County Zoning Ordinance. Roll call vote: 4 ayes.

HEARING

Scott Anderson, Planning & Zoning Director, spoke on the process for development of the Envision 2035 Comprehensive Plan which will be used as a resource to provide direction in making land use and development decisions in the rural area to the year 2035. David Heinold, Planner I, and Kevin Hoekman, Planner I, presented an overview of the plan. The following elements are included in the plan: a population and employment analysis, existing land use analysis, growth management, rural conservation, environmental stewardship, transportation, future land use plan, and implementation. MOTION by Kelly, seconded by Barth, to adopt Resolution MC15-39. 4 ayes. The Envision 2035 Comprehensive Plan is placed on file in the Auditor's Office and is available for inspection.

A RESOLUTION ADOPTING THE ENVISION 2035 COMPREHENSIVE PLAN.

WHEREAS, the Minnehaha County Planning Commission prepared the proposed Envision 2035 Comprehensive Plan in accordance with SDCL11-2 and recommended that the Board of County Commissioners adopt the Plan; and

WHEREAS, the Board of County Commissioners held a public hearing in accordance with SDCL11-2-19 and 11-2-20 on the proposed Envision 2035 Comprehensive Plan; and

WHEREAS, the Board has determined that the proposed Envision 2035 Comprehensive Plan should be adopted to supersede the previously adopted 1998 Comprehensive Development Plan adopted on December 15, 1998.

NOW, THEREFORE, BE IT RESOLVED that the Envision 2035 Comprehensive Plan is hereby adopted for the purpose of protecting and guiding the physical, social, economic, and environmental development of the county; to protect the tax base; to encourage a distribution of population or mode of land utilization that will facilitate the economical and adequate provisions of transportation, roads, water supply, drainage, sanitation, education, recreation, or other public requirements; to lessen governmental expenditure; and to conserve and develop natural resources. Said Plan shall be on file in the Office of the County Auditor.

BE IT FURTHER RESOLVED that the Envision 2035 Comprehensive Plan shall serve as the basis for Ordinance MC16-90 (as amended) – the 1990 Revised Zoning Ordinance for Minnehaha County and Ordinance, Ordinance MC23-93 – the 1993 Revised Subdivision Ordinance of Minnehaha County, South Dakota, Ordinance MC28-01 (revisions included) – the 2001 Revised Joint Zoning Ordinance for Minnehaha County and the City of Dell Rapids, Ordinance MC30-02 (as revised) – the 2002 Revised Joint Zoning Ordinance for Minnehaha County and the City of Sioux Falls, Ordinance MC33-04 (as amended) – Declaration and Abatement of Public Nuisances, Ordinance MC41-11 – the 2011 Floodplain Management Ordinance for Minnehaha County, Ordinance MC38-10 – the 2010 Revised Drainage Ordinance of Minnehaha County, and any amendments hereafter made to these ordinances, so as to carry out the purposes of the Envision 2035 Comprehensive Plan.
