PLANNING & ZONING NOTICES

MOTION by Barth, seconded by Beninga, to authorize the Auditor to publish a notice of hearing at a joint meeting of the Dell Rapids City Council and Minnehaha County Commission to consider an ordinance amending the 2001 Revised Joint Zoning Ordinance for the City of Dell Rapids and Minnehaha County on July 21, 2015 at 9:00 a.m., in the Minnehaha County Commission Room. 5 ayes. The proposed ordinance would rezone the property legally described as Lot 1 of Overvaag Tract 2, SW1/4, Section 8-T104N-R49W from the C Commercial District to the RR-1 Rural Residential District.

APPEAL

The appeal of the Planning Commission's May 18, 2015 approval of Conditional Use Permit (CUP) #15-29 with twelve (12) conditions was deferred by the County Commission on June 16, 2015, to allow the parties involved to meet and see if they can come to a resolution. CUP #15-29 allows a Class C Confined Animal Feed Operation (CAFO) for four hundred ninety nine (499) animal units on property owned by Candice Anderson. The property is legally described as Tract 2 (Ex. Tracts A & B & Ex. A 100' Strip Lying Adjacent to Tract A), Anderson's Addition N ½, Section 10-T102N-R48W. Kevin Hoekman, Planner I, reported that Wyatt Sundvold, the petitioner, met with surrounding neighbors that are appealing the CUP on June 23, 2015 to discuss their concerns. Mr. Hoekman read the proposed conditions that were agreed upon at that meeting. Mr. Sundvold submitted a revised site plan to accommodate some of the concerns expressed at that meeting. The revised site plan places the proposed CAFO to the south of the existing trees and outside of the required setbacks from the nearest dwellings. Mr. Hoekman recommended removing the condition requiring waivers from the property owners of the two dwelling units to the south of the proposed facility since both dwellings are outside the required setback. Mr. Hoekman read the twelve (12) conditions that were approved by the Planning Commission for CUP #15-29. Opponent, Gary Pop, 48132 257th Street, Garretson, spoke on additional conditions that were agreed to at the meeting on June 23rd that included the manure storage facility must be covered and that the shelterbelt trees be planted as proposed on the site plan to the west, north, and on at least 34 of the east side of the facility. Wyatt Sundvold, 1600 E. Cedar Street, Brandon, SD, stated he is in favor of the conditions agreed upon at the June 23rd meeting. MOTION by Beninga, seconded by Barth, to uphold the Planning Commission's approval of Conditional Use Permit #15-29 with the following fifteen (15) amended conditions: 1) The facility shall be limited to 499 animal units in size. 2) Copies of the nutrient management plans shall be approved and filed with the Minnehaha County Planning Department on an annual basis. 3) Shelter belt trees shall be planted as proposed on the site plan, to the west, north, and 3/4 of the distance of the length of the facility on the east side of the facility. In addition shelterbelt trees shall be placed in approved locations around the manure containment facility. Any dead trees shall be replaced within one season. 4) The shelter belt trees shall be planted utilizing at a minimum Minnehaha County Conservation District standards. 5) An address sign must be purchased at the planning department and placed at the driveway of the facility. 6) The manure storage facility must be in conformance with South Dakota Department of Environment and Natural Resources design standards for any newly constructed waste containment facility. A registered professional engineer shall certify the plan specifications and the construction of the facility. 7) The facility shall conform to the submitted site plans. Any minor changes may be approved by the staff at the Minnehaha County Planning Department. Major changes will require an amendment to this permit and a public hearing. 8) A rendering service must be used to pick up and remove dead animals from the property. 9) The operation shall maintain fly control as to not become a nuisance for neighbors. 10) A building permit is required for all structures prior to construction. 11) That the Planning & Zoning Department reserves the right to enter and inspect the dairy CAFO at any time, after proper notice to the owner, to ensure that the property is in full compliance with the conditional use permit conditions of approval and Minnehaha County Zoning Ordinance. 12) The CAFO facility be located to the south of the existing tree grove.

13) Half or more of the existing tree grove, to the north and east of the building will remain intact until the planted shelterbelt is well established. 14) The manure storage facility shall be fully covered and any water from the manure will be retained in the storage facility. 15) Cattle shall be housed within the CAFO building at all times except for temporary periods of up to 24 hours for routine cleaning maintenance. 5 ayes.

BIDS

DJ Buthe, Highway Superintendent, reported on the June 24, 2015 bid opening for the Furnish and Installation of two (2) Hydraulics and Combination 15' 201 SS Dump and Spreader Bodies for Tandem Axle Trucks. The following two bids were received: Northern Truck & Equipment, \$158,908.00; Custom Truck Equipment, \$184,896.00. Mr. Buthe recommended the bid be awarded to the low bidder, Northern Truck & Equipment. MOTION by Kelly, seconded by Beninga, to award the bid for the Furnish and Installation of two (2) Hydraulics and Combination 15' 201 SS Dump and Spreader Bodies for Tandem Axle Trucks to Northern Truck & Equipment in the amount of \$158,908.00. 5 ayes.

DJ Buthe, Highway Superintendent, reported on the June 24, 2015 bid opening for Project MC122BR-15, replacement of structure 50-243-100. The following three bids were received: Prahm Construction, Inc., Base Bid \$460,793.15, Alt. Bid \$489,098.15; Graves Construction Company, Base Bid \$616,584.69, No Bid on Alternate; SFC Civil Constructors, Base Bid \$674,982.45, Alt. Bid \$692,908.95. Mr. Buthe stated the Alternate Bid was for a newer product for the steel in the deck of the bridge called ZBar, and he has chosen not to accept the alternate for this project. Mr. Buthe recommended the bid be awarded to Prahm Construction, Inc. for the Base Bid cost. MOTION by Bender, seconded by Barth, to award the contract for Project MC122BR-15 to Prahm Construction, Inc. in the amount of \$460,793.15. 5 ayes.

Robert Wilson, Assistant Commission Administrative Officer, reported that no bids were received for the June 24, 2015 bid opening for Fairgrounds Roof Repairs. Commissioners discussed possible revisions to the bid specifications and re-bidding the project. MOTION by Kelly to defer this item for 60 days. Motion dies for lack of a second. MOTION by Barth, seconded by Bender, to authorize the Auditor to re-publish a notice to bidders for the project. Barth withdrew his motion. MOTION by Barth, seconded by Kelly, to defer this item two weeks to allow time to evaluate options for proceeding. 5 ayes.

OLD BUSINESS

Lynn DeYoung, Emergency Management Director, gave a briefing on Minnehaha County's response to the storm damage in the City of Garretson. Chairperson Heiberger thanked all departments, agencies, and individuals who helped with the cleanup.

MOTION by Barth, seconded by Beninga, to adjourn into executive session for personnel discussion. 5 ayes.

The Commission adjourned until 9:00 a.m. on Tuesday July 7, 2015.
