Carey Deaver, Human Resources Director, reported last year's Segal compensation study indicated entry level attorney salaries are 5% lower than our government comparisons and 29% lower than the private sector. A decline in applicant numbers to fill attorney positions during the past few months prompted another review of attorney salary data. This review found organizations which are most relevant and/or geographically close to Minnehaha County have an average starting salary that is 9% higher than the county's current base rate of \$53,913. Hiring new attorneys at this level would result in a new attorney earning more than several current staff members. Ms. Deaver requested approval of the following five actions: 1) Begin utilizing the fifth step in grade 21 (21/6 at \$59,508 for 2015) as the advertised base salary for new full-time attorneys immediately. Post a four step hiring range in accordance with current practice. 2) Adjust salaries for all current full-time attorneys below \$59,508 to the new minimum on August 15, 2015. 3) Provide a one-step increase (approximately 2.5%) to any attorney in grade 21 or 22 who currently earns \$59,508 or more, but is not yet at range maximum, in order to alleviate compression at the new base salary. This will also assist in addressing market issues for current staff as survey data reflects that our wages are low throughout the range. 4) In order to lessen equity concerns, reset the step date for anyone receiving a 10% increase to August 15th, the date of implementation, and selectively reset steps in the remaining few situations where less experienced staff would be eligible for increases before more experienced, higher paid staff. 5) Increase the rate of pay for Julie Hofer, Public Advocate, by one step (2.5%) to avoid her earning the same rate as staff she supervises. The proposed rate adjustments would result in a 2015 cost of \$42,640 if approved. HEARING

Kevin Hoekman, Planner I, gave a briefing on a Public Nuisance Ordinance violation at the property owned by Tamara and Mike Day. The property is legally described as N 114' W 73' Peterson Tract 2 SE ¼ SW ¼ 17-103-50 Lyons Township. The first inspection of the site was on March 25, 2015. Staff found that a building was recently burned and various unlicensed vehicles on the property. The owners were sent a letter to make them aware of the violations. No response to the letter was received. A second letter was sent to the owners on April 24, 2015. On May 6, 2015 Tamara Day called and discussed a potential timeline of cleanup. One month after the conversation with Tamara, the site was inspected again and no change was visible. Another letter was sent on June 12, 2015 to which no response was received. Due to little response from the property owners and lack of cleaning up the debris from the burned building, unlicensed vehicles, weeds, and other debris, the Planning and Zoning Department and the Office of the State's Attorney believe that the only recourse is to declare the property a public nuisance to allow Minnehaha County to remove the violations from the property. On July 21, 2015 a notice of a public hearing on August 4, 2015 was sent to the property owners via certified mail with a return receipt. The return receipt has not been received by the Planning & Zoning Office. A final site visit was made on August 3, 2015, and the violations still remain. The property owners were not present at the public hearing. MOTION by Barth, seconded by Kelly, to declare the property a public nuisance and enact SDCL 21-10-6 to authorize the Planning & Zoning Department to abate the nuisance by removing the violations from the property. 5 ayes.

HEARING

Shannon Schultz, Assistant Highway Superintendent, was present for the public hearing and second reading of Ordinance MC47-15, An Ordinance for Permitting Requirements for Utilities Crossing Highways Under Minnehaha County Jurisdictions. Kersten Kappmeyer, Chief Civil Deputy State's Attorney, stated the ordinance enacts the requirement of having a permit, gives authority to charge fees, makes a statement of bonding requirements, and defines the violations and penalties when taken with the proposed companion resolution adopting the guide book and forms that set the fee schedule. Al Miron, 25935 469th Ave., Sioux Falls, asked about the fee structure for installing drain tile crossing a highway, and if this ordinance will require applicants to obtain professional engineering services. Mr. Kappmeyer stated that the fee for a drain tile crossing would be \$50.00. Mr. Schultz stated standard crossings such as utility lines or service lines that are horizontally bored do not require engineering. MOTION by Barth, seconded by Kelly, to approve Ordinance MC47-15. 5 ayes. The ordinance is on file at the Minnehaha County Auditor's Office.

Lynn DeYoung, Emergency Management Director, gave a briefing on the State and Local Agreement Addendum with the State of South Dakota to be used to support salary and administrative expenses within the Minnehaha County Emergency Management Office. This is a 50% reimbursement grant and requires a 50% match from the county. This year's grant amount is \$227,360.22. In past years the grant amount has been greater than what is needed to support salary and administrative expenses within the county. Mr. DeYoung stated he will develop a

Lynn DeYoung, Emergency Management Director, gave a briefing on the Joint Powers Agreement between Minnehaha County and the South Dakota Department of Game, Fish, & Parks for use of one (1) boat, motor, trailer, and specialized equipment for public safety, emergency, and search and rescue efforts in Minnehaha and adjacent counties. MOTION by Beninga, seconded by Barth, to authorize the Chairperson to sign the Joint Powers Agreement between Minnehaha County and the South Dakota Department of Game, Fish, & Parks. 5 ayes.

SUPPLEMENT

On the request of Kim Adamson, Budget & Finance Director, MOTION by Barth, seconded by Beninga, to supplement \$1,726.00 from the Building Fund to the Building Fund Budget, ASN 19633, Outside Repairs, representing insurance reimbursement from State Farm Fire and Casualty Company. 5 ayes.

AGREEMENT

On the request of Robert Litz, Auditor, MOTION by Barth, seconded by Beninga, to approve a sales order agreement between Minnehaha County and Elections Systems and Software (ES&S) for the purchase of one (1) DS 850 High Speed Digital Image Scanner Ballot Counter in the amount of \$109,387.50. The machine will be paid for utilizing Help America Vote Act Funds administered by the South Dakota Secretary of State. 5 ayes.

LIAISON REPORTS

Commissioner Kelly reported that he attended the public hearing for revisions to the Floodplain map at the library on Tuesday evening, July 28, 2015. Mr. Kelly stated the meeting was attended by many of the people living north of Sioux Falls who will be affected by the revisions. Mr. Kelly also stated he toured Ditch Road with Lynn DeYoung, Emergency Management Director. Mr. Kelly stated the ditch has not been maintained and is full of debris. Commissioners and Scott Anderson, Planning & Zoning Director, discussed mitigation options. Commissioner Heiberger asked Scott Anderson and Lynn DeYoung to look into this issue. Mr. Anderson stated it is important for property owners that will be affected by the Floodplain revisions to obtain flood insurance now so they will be grandfathered in at a lower rate. Mr. Anderson stated his office will be sending out notices to those property owners in the county that will be affected by the revisions to the Floodplain map.

Commissioner Barth reported the City of Sioux Falls gave a presentation on their affordable housing projects at the Homeless Advisory Board meeting on August 3, 2015.

Commissioner Heiberger reported that she met with the Senior Project Director for Forward Sioux Falls and was informed that they have a goal of \$17 million this year. Heiberger stated the County may be discussing a contribution during the final budget review in September.

MOTION by Barth, seconded by Beninga, to adjourn into executive session for personnel and potential litigation. 5 ayes.
