### **GRANT**

Lynn DeYoung, Emergency Management Director, reported Minnehaha County has been awarded a 2015 Homeland Security Grant in the amount of \$140,410.76. The grant will be used for the following purposes: \$8,767.80, radios and ear pieces for the Mobile Command Post; \$16,319.00, bomb response suit; \$16,000.00, universal ATV; \$12,904.96, radio amplifier and smart board mobile command post; \$86,419.00 portable digital radios. Mr. DeYoung reported that the State has moved to an on line grant management system, and grant documents will now be signed electronically. MOTION by Barth, seconded by Kelly, to authorize Minnehaha County Emergency Management to enter into the agreement with the South Dakota Office of Homeland Security and to authorize electronic signatures on the 2015 Homeland Security Grant Award Agreements. 5 ayes.

### **LEASE**

Carol Muller, Commission Administrative Officer, gave a briefing on the 2016 lease agreement between Minnehaha County and CASA (Court Appointed Special Advocate). Under the terms of the agreement, CASA will pay \$7,250 to lease 1,500 square feet of office space on the first floor of the Extension Building. CASA will make four payments in the amount of \$1,812.50 at the beginning of each quarter. The County pays for heat, electricity, and janitorial service. MOTION by Beninga, seconded by Barth, to authorize the Commission Chair to sign the 2016 lease agreement between Minnehaha County and CASA. 5 ayes.

## **GRANT EXTENSION**

Robert Wilson, Assistant Commission Administrative Officer, reported the Community Development Block Grant (CDBG) from the State of South Dakota to assist Southeast Technical Institute in funding the expansion of its commercial driver's license (CDL) training program, was due to expire on October 31, 2015. The grant is administered by the Southeastern Council of Governments who is requesting to extend the grant period one year to fully utilize the remaining scholarships. MOTION by Bender, seconded by Kelly, to authorize the Commission Chair to sign the Request For Amendment to Grant 1112-302, to extend the grant period until October 31, 2016. 5 ayes.

## LIAISON REPORT

Commissioner Heiberger reported that she and Commissioner Beninga met with the Public Defender's Office the morning of November 17, 2015, and discussed the Gideons Promise Program. Ms. Heiberger reported the next round of interviews for that program will begin in December. Ms. Heiberger also reported they discussed pre-trial services.

Mr. Steinhauer will be serving as a South Dakota State Representative, and will not be re-applying for a position on the Planning Commission. Mr. Anderson encouraged interested parties to apply. Commissioner Barth stated that Mr. Steinhauer will be missed on the Planning Commission.
