COMPROMISE OF LIEN

(Deferred from November 24, 2015)

Kersten Kappmeyer, Chief Civil Deputy State's Attorney, gave a briefing on a request for compromise of lien submitted by Elaine F. Combs, Personal Representative for the estate of the person who is the lienee of DPNO 22103. The estate is attempting to sell the home that was owned by the lienee. In order for the buyer to gain clear title to the property, the lien needs to be resolved prior to the closing on December 7, 2015. The applicant is asking for a release of the lien only as it applies to the home they are selling. The release of liens against the home from the State of South Dakota and AAA Collections have been verified with the Register of Deeds Office. Mr. Kappmeyer stated that Probate Court will decide how the creditors will be paid, and it is most likely that Minnehaha County will be paid in full due to our priority in class. James Myers, Myers Billion, LLP, attorney for the estate, spoke on the request and asked that the lien be released contingent on the sale of the home. Mr. Myers stated that after closing costs and administration expenses there will be approximately \$60,000 to be divided among creditors through Probate Court.
