Ms. Walhof stated she inadvertently purchased the license tabs using the kiosk at the Get & Go on E. 10<sup>th</sup> Street.

Pam Nelson, Treasurer, stated she runs her office following state laws and treats everyone equally. Ms. Nelson stated Ms. Walhof is not eligible for a refund according to state statute. Commissioner Beninga asked Kersten Kappmeyer, Chief Civil Deputy State's Attorney, to review the state statutes related to this issue.

# **AGREEMENTS**

Jamie Gravett, Juvenile Detention Center Director, presented the renewal contract with Southeastern Behavioral Health to provide on call qualified mental health professional (QMHP) services and ongoing needs counseling for the youth detained in the Juvenile Detention Center (JDC). The contract has an increase to the current contract rate for on call services from \$50.00 per week to \$100 per week. The cost for counseling and training to residents of the JDC remains the same as the current contract at \$50.00 per hour. MOTION by Beninga, seconded by Barth, to authorize the Chairperson to sign the one year renewal

agreement between Minnehaha County and Southeastern Behavioral Healthcare, Inc. for Qualified Mental Health Professional services commencing on December 23, 2015. 4 ayes.

Robert Wilson, Assistant Commission Administrative Officer, gave a briefing on an agreement with Southeastern Behavioral Health to provide Qualified Mental Health Professional services for the Mobile Crisis Team. The terms of the agreement are for Minnehaha County to pay Southeastern Behavioral Health a program administrative fee of \$5,000 per year in twelve monthly installments of \$416.67. Minnehaha County will also be responsible for the on-call costs of mental health professionals at a rate of \$100 per 24 hour on-call period and \$50 for on-call periods of less than 24 hours. Minnehaha County will also reimburse the provider for the cost of program supplies and equipment. Kris Graham, CEO of Southeastern Behavioral Health, and Jim Iosty, Chair of the Board of Mental Illness, spoke on the impact the Mobile Crisis Team has on lowering the number of involuntary committals and on the anticipated increase in the number of petitions expected in the future. MOTION by Barth, seconded by Beninga, to authorize the Chairperson to sign the 2016 Agreement for Mobile Crisis Team Services between Minnehaha County and Southeastern Behavioral Health. 4 ayes.

#### **APPOINTMENT**

Jim Iosty, Chairman of the Board of Mental Illness, presented recommendations for appointment of regular and alternate lay members to the Board of Mental Illness and the Minnehaha County Review Board for Developmental Disabilities. MOTION by Beninga, seconded by Kelly, to approve Resolution MC15-89. 4 ayes.

MOTION by Beninga, seconded by Barth, to authorize the Chairperson to sign the agreement between Minnehaha County and Infrastructure Design Group, Inc. for Professional Services for Structures 50-070-098 and 70-072-100 at a cost not to exceed \$122,929.50. 4 ayes.
