Lincoln County will reimburse Minnehaha County at the rate of \$4,875 per month. Carol Muller, Commission Administrative Officer, gave a briefing on recommended Commission appointments to Boards and Councils. MOTION by Kelly, seconded by Barth, to approve the following appointments: Commissioners Barth and Kelly to the Metro Communications Council; Commissioner Heiberger to the SD Association of County Commissioners Board of Directors Primary; Commissioner Barth as Alternate to the SD Association of County Commissioners Board of Directors; Commissioner Beninga to the Sioux Empire Housing Partnership; Commissioners Bender and Beninga to the Multi-Cultural Center Intergovernmental Board; Commissioners Bender, Kelly, and Barth to the SECOG Urbanized Development Commission. 5 ayes.

VEHICLE PURCHASE

Kristin Trana, Administrative Coordinator for the Sheriff's Department, requested authorization to purchase six (6) Dodge Chargers off the 2016 South Dakota State bid at a cost of \$25,776 per vehicle. The contract holder is Billion Auto in Sioux Falls. MOTION by Kelly, seconded by Barth, to authorize the purchase of six (6) Dodge Chargers from Billion Auto in Sioux Falls, SD State Contract #16866, at a total cost of \$154,656. 5 ayes

Carol Muller, Commission Administrative Officer, gave a briefing on a two month agreement between Minnehaha County and Volunteers of America for the Reception Center and the Evening Report Center. The monthly cost will be the same as the previous agreement. During this time period Minnehaha County will work to secure a long-term operator for both services. MOTION by Beninga, seconded by Barth, to authorize the Chairperson to sign the agreement between Minnehaha County and Volunteers of America for the Reception Center at a cost of \$8,466.83 per month and the Evening Report Center for a cost of \$6,521.09 per month. 5 ayes.

Robert Wilson, Assistant Commission Administrative Officer, gave a briefing on the 2016 contract between Minnehaha County and Carroll Institute to provide housing and a low-intensity, short term residential and pretreatment program for individuals who have been court ordered into treatment. The major provisions of the contract are as follows: Carroll Institute will provide housing for up to 4 individuals per day in their facility at 327 S. Spring, Sioux Falls; The County will pay Carroll Institute \$111,330 in 12 equal monthly installments, and is allowed to review the bed utilization rates and other program modifications that may be contemplated prior to June 2016 to consider any necessary adjustments; The Sheriff's Department will provide transportation from the detoxification center or the jail upon a schedule determined by the Sheriff's Department to the Carroll Institute IVC Housing Unit, and transportation to the involuntary treatment program will be by existing protocol. MOTION by Barth, seconded by Bender, to authorize the Chairperson to sign the 2016 agreement between Minnehaha County and Carroll Institute for short-term residential substance abuse pre-treatment services beginning January 1, 2016 through December 31, 2016 at a cost of \$111,330. 5 ayes.

LEGISLATIVE UPDATE

Robert Wilson, Assistant Commission Administrative Officer, gave an update and status report of the 2016 Legislative Session on bills that impact Minnehaha County.

MOTION by Barth, seconded by Bender, to adjourn into executive session for personnel and contract discussions. 5 ayes.
