attorney services were provided to the applicant's juvenile son on a criminal matter. The applicant has made payments in the amount of \$130.00 bringing the lien to its current balance \$131.00. The applicant states he cannot afford to pay the remaining amount and requests a compromise and release of the lien in full with no additional payments. The applicant was encouraged to continue making payments. MOTION by Kelly, seconded by Bender, to deny the request for compromise of lien. 5 ayes.

Robert Wilson, Assistant Commission Administrative Officer, gave a briefing on a request for compromise of lien for DPNO 72464. The lien is for Public Defender services provided between 2010 and 2015. A total of \$200 has been paid on the account bringing it to a current balance of \$1,437.40. The applicant states he recently started a new job and doesn't have the funds to pay the lien amount. He lists assets of \$400 that include cash, a checking account and household goods. His liabilities include credit card balances and debts owed to other lenders that total \$10,700. His 2014 income tax return shows an annual income of \$16,966. The applicant is requesting a compromise and release of the lien with no further payments. The applicant was encouraged to make payments. WHEREAS, James (Jim) E. Zweep enjoyed serving as a Minnehaha County Commissioner from 1986 to 2006; and

**WHEREAS**, Commissioner Zweep advocated relentlessly for improving the Minnehaha County Highway System; and

**WHEREAS**, under Commissioner Zweep's leadership, Minnehaha County hard-surfaced all through roadways within its jurisdiction, a feat claimed by no other county in the State; and

**WHEREAS**, the Minnehaha County Board of Commissioners wishes to commemorate Commissioner Zweep's dedication and service to the County.

**NOW, THEREFORE, BE IT RESOLVED** by the Minnehaha County Board of Commissioners, that Minnehaha County Highway 125 is hereby designated the "Jim Zweep Memorial Highway"; and

**BE IT FURTHER RESOLVED**, that the Minnehaha County Highway Department is directed to erect suitable signs designating Minnehaha County Highway 125 as the "Jim Zweep Memorial Highway"; and

**BE IT FURTHER RESOLVED**, that the erection of such signs shall be within the guidelines prescribed by the Manual on Uniform Traffic Control Devices; and

**BE IT FURTHER RESOLVED**, that the appellation "Jim Zweep Memorial Highway" provided for in this resolution is for honorary purposes only and nothing contained herein shall be construed as requiring the

alteration of any address, or the governmental system for assigning addresses, in any county, municipality or other governmental entity affected by this resolution; and

**BE IT FURTHER RESOLVED**, that nothing contained in this resolution shall be construed as requiring the alteration of any previously named segment or segments of any highway described in this resolution as the "Jim Zweep Memorial Highway".

POLICY

DJ Buthe, Highway Superintendent, gave a briefing on proposed updates to Section V, County Purchasing, of the Minnehaha County Policies and Procedures Manual. The Highway Department is proposing a provision that would allow for a more streamlined method to manage Highway construction projects that are approved as part of the long range planning and annual budget process. The proposed provisions are in line with current state purchasing statutes and federal project streamlining standards. The Highway Department will provide updates to the Commission on the status of open projects on a monthly basis. Commissioner Beninga stated he would like more time to review the proposed updates and asked if the State's Attorney's Office has reviewed them for compliance with SDCL. Carol Muller, Commission Administrative Officer, reported that Kersten Kappmeyer, Chief Civil Deputy State's Attorney, has reviewed the proposed highway policies and procedures, and he has no legal concerns as they comply with state purchasing and contract statutes. MOTION by Barth, seconded by Bender, to defer action on this item to the February 9, 2016 commission meeting. 5 ayes.

## LEGISLATIVE UPDATE

Robert Wilson, Assistant Commission Administrative Officer, gave an update and status report of the 2016 Legislative Session on bills that impact Minnehaha County.

## LIAISON REPORTS

Commissioner Barth reported that he attended a play at the Pettigrew Museum, and it was a blast. Tickets are sold out for this play, but he recommends people attend future performances.

### NEW BUSINESS

Lynn DeYoung, Emergency Management Director, reported the area is under a blizzard warning until tomorrow at 4 a.m., and the Sheriff's Department and Highway Department are ready to respond. Mr. DeYoung encouraged everyone to be safe and have a winter survival kit if they have to travel.

Scott Anderson, Planning and Zoning Director, commented on the Planning Department's 2015 year-end report. Mr. Anderson reported there were 615 building permits issued which is up about 35% to 40% over the previous year. This increase resulted in exceeding their budget revenue by \$92,000. The population projection for Minnehaha County on January 1, 2016 is 181,164 people. Mr. Anderson stated this information has been posted on the website to be utilized by other departments for various purposes.

Commissioner Barth reported that at the last Planning Commission meeting they elected Mike Cypher as the new Chairperson.

Kyle Helseth, Director of Equalization, reported they have added over 1,000 new properties. As of this morning, February 2, 2016, the value of Minnehaha County has increased approximately \$650,000,000 from new construction and re-appraisals. Minnehaha County is now worth over \$14 billion, which is an increase of \$4 billion dollars over the last six years.

MOTION by Barth, seconded by Bender, to adjourn into executive session for personnel and contract discussion. 5 ayes.
