Robert Wilson, Assistant Commission Administrative Officer, gave a briefing on a request for compromise of lien for DPNO 8557 in the amount of \$2,790.81. Robert Wilson, Assistant Commission Administrative Officer, gave a briefing on an agreement with TSP, Inc., for a space needs study of the 2nd floor of the Public Safety Building. The intent is to determine if that location would be suitable for a possible relocation of the Minnehaha County State's Attorney's Office. The proposed cost of this study will be \$12,600, and it will take approximately six weeks to complete. MOTION by Kelly, seconded by Bender, to authorize the Chair to sign the professional services agreement between Minnehaha County and TSP, Inc. in the amount of \$12,600 for a space needs study of the Public Safety Building. 4 ayes.

Erin Srstka, Juvenile Detention Alternatives Initiative Coordinator, reported that a notice was received from the current provider for the reception center, evening report center, and shelter care, that as of March 1, 2016 their services will no longer be available. Ms. Srstka gave a briefing on a contract with Lutheran Social Services (LSS) to provide shelter care and reception center services on their property located at 621 E. Presentation St., Sioux Falls, SD. The contract term is February 16, 2016 through June 30, 2018. The estimated budget amount for the entirety of the contract is \$2,412,334.31, with an estimated off-set amount of \$1,131,500 for contracting out 10 beds per day to other counties. LSS will bill the County the actual cost minus any revenue each month, and any grant revenue that may arise will also be deducted from the monthly bill. Minnehaha County will also pay LSS up to \$135,735 for the conversion/transition of the existing space at the LSS facility that will be used for the services. Under this agreement the reception center services will start March 1, 2016 and shelter care services will start May 2, 2016. Betty Oldenkamp, President and CEO of Lutheran Social Services, spoke on the services they would be providing. Jamie Gravett, Juvenile Detention Center Director, reported they are still seeking to

find a provider for the evening report center at this time. MOTION by Barth, seconded by Bender, to authorize the Chair to sign the agreement between Minnehaha County and Lutheran social Services to provide shelter care and reception center services for a term beginning February 16, 2016 through June 30, 2018. 4 ayes.

REFUND

Robert Wilson, Assistant Commission Administrative Officer, gave a review of a request from Darlene Walhof for a refund of fees paid to license a trailer and a boat which were purchased in error. Pam Nelson, Treasurer, stated she took an oath to uphold the laws of the state of South Dakota and the law in the state of South Dakota states no refunds of registration fees. Ms. Nelson also stated that state statute does not give the Commission authority to authorize a refund, and by doing so it would set a precedent. Russ Walhof, husband of Darlene Walhof, stated his wife went through the proper channels by contacting the Governor's Office and they told her that she was within her rights. Amy West, Accountant for the Treasurer's Office, stated a letter was received from the South Dakota Department of Revenue dated December 10, 2015, authorizing a refund of the registration fees in the amount of \$165.40. A second letter from the South Dakota Department of Revenue dated December 14, 2015 was received that revised the refund amount to \$66.20. Mrs. Walhof came to the Treasurer's Office on December 14, 2016, and spoke to Pam Nelson who offered to issue her a refund of the revised amount. Mrs. Walhof refused the compromised refund. Commissioner Bender stated she would prefer deferring this matter so they can review all the information before making a decision. MOTION by Bender, seconded by Kelly, to defer this item until the March 8, 2016 Commission meeting. 4 ayes.

BUDGET

MOTION by Bender, seconded by Kelly, to authorize a \$214,773 transfer from the General Fund to the Emergency Management Fund in accordance with the 2016 budget. 4 ayes.

AGREEMENT

Kristin Trana, Administrative Coordinator for the Sheriff's Office, presented an annual agreement to participate in the Federal Equitable Sharing Program. The program allows for participants to receive a share of federally forfeited proceeds that may be used for law enforcement purposes. MOTION by Barth, seconded by Bender, to authorize the electronic signature of the Chair on the Federal Equitable Sharing Agreement and Certification. 4 ayes.

APPOINTMENT

MOTION by Bender, seconded by Barth, to re-appoint Paul Flogstad to the Minnehaha County Housing & Redevelopment Commission for a five year term beginning February 10, 2016. 4 ayes.

LEGISLATIVE UPDATE

Robert Wilson, Assistant Commission Administrative Officer, gave an update and status report of the 2016 Legislative Session on bills that impact Minnehaha County.

LIAISON REPORT

Commissioners Barth and Kelly reported on a meeting at SECOG where they talked about steps being taken to expand the cooperation among Minnehaha County, Lincoln County, and the City of Sioux Falls.

OLD BUSINESS

Commissioner Barth commented on an article in the Argus Leader where it stated the James McVay trial cost the State's Attorney Office an additional \$100 outside their normal operating costs. Commissioner Barth stated he spoke with the Public Defender's Office and was informed they spent over \$220,000 on that trial. Mr. Barth doesn't want anyone to get the impression that the criminal justice process is cheap, and he hopes the Legislature will look for some additional funds for counties.

MOTION by Barth, seconded by Bender, to adjourn into executive session for personnel and contract negotiations. 4 ayes.

The Commission adjourned until 9:00 a.m. on Tuesday February 23, 2016.
