PUBLIC COMMENT

Newly elected Sioux Falls City Council members Greg Neitzert, Pat Starr, Theresa Stehly, and Marshall Selberg introduced themselves to the Commission and expressed their desire for greater collaboration between the City of Sioux Falls and Minnehaha County.

Robert Kolbe, former Minnehaha County Commissioner, spoke on the history of collaboration among the Sioux Falls City Council, Minnehaha County Commission, and Sioux Falls School District.

HEARING

Scott Anderson, Planning & Zoning Director, was present for the second reading and public hearing of an amendment to the 1990 Revised Zoning Ordinance for Minnehaha County. The amendment is to Rezone from the A-1 Agricultural District to the Cedar Ridge Planned Development District, property legally described as Tracts 1, 2, & 3 Anson Addition, N ½ SW ¼, Section 3-T102N-R49W of the 5th PM, Minnehaha County, SD. The Petitioner of Rezoning #16-03 is Eric Willadsen, Willadsen Lund Engineering. The property is owned by Brad and Laura Wagner. The rezoning request is for the future creation of 18 residential home sites and an equestrian center at 25670 475th Avenue, approximately 4 miles north of Sioux Falls. The County Planning Commission voted unanimously to Deny Rezoning #16-03 at their March 28, 2016 meeting. Proponents who spoke in favor of the rezoning request were Tom Wilka representing the applicant and land owners, Laura and Brad Wagner, Earl Erpelding 47574 Neener Circle, and Eric Willadsen. Mr. Wilka also submitted a letter of support for the project from Phil Eggers with Westra Land & Auction, LLC. Mike Cypher, 26443 461st Ave., Hartford, spoke in opposition to the project stating concerns regarding spot zoning and that the area is not affiliated with a sanitary sewer district. Mr. Cypher requested the Commission uphold the Planning Commission's denial of the rezoning. MOTION by Kelly, seconded by Barth, to approve Ordinance MC16-147-16 An Ordinance Amending the 1990 Revised Zoning Ordinance For Minnehaha County by Rezoning Tracts 1, 2, & 3 Anson Addition, N ½ SW ¼, Section 3-T102N-R49W of the 5th PM, Minnehaha County, SD from A-1 Agricultural to the Cedar Ridge Planned Development District; and authorize the Chair to sign the Cedar Ridge Development District regulations. 5 ayes.
