PUBLIC COMMENT

Robert Kolbe, Minnehaha County resident, spoke on the need to inform legislators on issues facing counties. Mr. Kolbe commented on Commissioner Kelly's service as a state legislator.

Commissioner Kelly commented on Mr. Kolbe's remarks.

HEARING

David Heinold, Planner I, gave a briefing on Drainage Permit #16-17. The applicants are George and Brent Bargmann. They are requesting approval to install drainage tile to increase agricultural production and reduce soil erosion on the property in addition to the recently approved drainage tile project in the SW ¼, SE ¼, and NE ¼ of Section 6. The proposed tile would be installed in the northwest quarter on Section 6, Buffalo Township and will flow into an existing subsurface drainage tile system that extends into both McCook and Lake Counties. The applicant received downstream permission from all property owners within one-half mile of the proposed outlet. A Drainage Board hearing is required because the project has intercounty significance that must be approved by the McCook County Commission as well as Minnehaha County Commission. On May 11, 2016, staff conducted a site visit and determined the proposed drainage tile will be located in areas of natural flow that appear to be traditionally wet. The proposed areas for installation of drainage tile are not classified as wetlands. Staff recommends approval of Drainage Permit #16-17. Co-applicant Brent Bargmann, Sioux Falls resident, spoke on the tiling project. No one spoke in opposition. MOTION by Beninga, seconded by Barth, to approve Drainage Permit #16-17. 5 ayes.

GRANT

Kristin Trana, Administrative Coordinator for the Sheriff's Office, requested authorization to submit an application for the 2016 COPS Hiring Grant. Based on the number of certified officers/deputies currently on staff, the parameters would allow Minnehaha County to request four (4) Deputy Sheriffs to be paid through the grant. The grant period is 36 months, and it requires a 25% local match. Minnehaha County would be required to affirm plans to retain the personnel hired through the grant program for 12 months following the grant period. The application would be submitted for the personnel costs for four (4) positions of Deputy Sheriff at a total project cost of \$888,023.23 over three years. Minnehaha County would be responsible for \$222,005.81 of this 36 month cost. Sheriff Mike Milstead spoke on the retention process for the grant positions. MOTION by Bender, seconded by Barth, to authorize submission of the application for the 2016 COPS Hiring Grant. 5 ayes.

CHANGE ORDER

Robert Wilson, Assistant Commission Administrative Officer, gave a briefing on Change Order #1 to the contract with Kalb Construction for W.H. Lyon Fairgrounds Facility Exterior Repairs. The change order is for additional repairs needed on the sub-roof and parapet of the dairy barn. The cost of the additional repairs is \$11,800. MOTION by Barth, seconded by Beninga, to authorize the Chair to sign Change Order #1 to the contract with Kalb Construction for W.H. Lyon Fairgrounds Facility Exterior Repairs for a new contract amount of \$161,700. 5 ayes.

APPOINTMENT

Robert Wilson, Assistant Commission Administrative Officer, reported Paul Flogstad has submitted his letter of resignation from the Minnehaha County Housing and Redevelopment Commission (MCHRC) effective June 1, 2016. Mr. Flogstad has recommended the appointment of Tiffany Butler, Operations Director at Carroll Institute in Sioux Falls, as his replacement. Appointments to the MCHRC are made by the County Commission Chair, with concurrence of the rest of the Commission. Commissioners thanked Mr. Flogstad for his service and contributions to Minnehaha Count. MOTION by Kelly, seconded by Barth, to concur with Chair Heiberger's appointment of Tiffany Butler to the MCHRC for a five year term beginning June 1, 2016. 5 ayes.

PROCLAMATION

Celia Benson, Secretary for the Minnehaha County Historical Society, gave a briefing on contributions made by John Thompson in the early years of Minnehaha County and on his dedication to its people. To mark the 150th

anniversary of Mr. Thompson's arrival at Ford Dakota in 1866, Ms. Benson requested the Commission issue a proclamation recognizing June 29, 2016, as John Thompson Day in Minnehaha County. MOTION by Kelly, seconded by Bender, to issue the proclamation recognizing June 29, 2016 as John Thompson Day in Minnehaha County. 5 ayes.

LIAISON REPORTS

Commissioner Kelly showed an internet promo for the Siouxland Libraries. The promo is intended for the younger audience in an effort to get more youth involvement.

Commissioner Barth reported there is a full Public Advocate Board, and they will meet this Thursday, May 19th to work on their budget

Commissioner Bender reported the Homeless Advisory Board is having their first pie party this Thursday, May 19th. The event is to bring together the different non-profit and government entities that are working with the homeless population and make sure they are collaborating in an effective way. Ms. Bender commended Stacey Tieszen and Kari Benz for their work on this event.

NEW BUSINESS

Commissioner Barth commented on the success over the past two years in getting the state legislature to better understand issues facing counties.

Commissioner Heiberger stated she would like to invite all legislators and candidates to attend the budget hearings.
