LIEN

Robert Wilson, Assistant Commission Administrative Officer, gave a briefing on an application for a compromise of lien for DPNO 81619 in the amount of \$13,306.64. The applicant requests a compromise and release of the lien in full upon payment of \$7,500. The lien is solely in the name of the applicant and is for court appointed attorney services provided between 2014 and 2015. The applicant earns \$24,000 annually, has \$500 in savings, \$2,000 in retirement savings, two vehicles, and a 1999 boat valued at \$5,000. Debts total \$17,100, owed to US Bank and several credit cards. Items not submitted with the application include the most recent tax return and contact information. The Commission office is not aware of any pending real estate transactions or other immediate need to resolve the lien. MOTION by Bender, seconded by Barth, to deny a compromise of lien for DPNO 81619. 5 ayes.

PUBLIC COMMENT

Kersten Kappmeyer, Chief Civil Deputy State's Attorney, introduced Judy Ziegler as a new Minnehaha County Senior Deputy State's Attorney. Judy Ziegler spoke to thank the Commissioners for the opportunity.

HEARING

Kristin Trana, Administrative Coordinator for the Sheriff's Office, was present for the scheduled hearing to consider the 2016 Byrne Justice Assistance Grant (JAG) Joint Spending Plan. The City of Sioux Falls and Minnehaha County will be receiving an allocation of \$70,362 for the 2016 program. The Sioux Falls Police Department will receive 65% of the allocation (\$45,735) to purchase a multi-use department trailer and gas masks, and the Minnehaha County Sheriff's Office will receive 35% of the allocation (\$24,627) to be used to purchase portable radios with encryption and vehicle gun locks. MOTION by Barth, seconded by Beninga, to approve the 2016 Byrne Justice Assistance Grant Joint Spending Plan between the City of Sioux Falls and Minnehaha County. 5 ayes.

AGREEMENTS

Lynn DeYoung, Emergency Management Director, gave a briefing on Amendment #1 to the 2016 State and Local Agreement with the State of South Dakota to be used to support salary and administrative expenses within the Minnehaha County Emergency Management Office. This year's grant amount is \$224,202.27. Due to the grant amount being greater than needed to support salary and administrative expenses in past years, Mr. DeYoung stated he will develop a list of special projects that may be funded with the remaining amount. MOTION by Beninga, seconded by Bender, to authorize the Chairperson to sign the 2016 Emergency Management State and

Local Agreement between the State of South Dakota and Minnehaha County in the amount of \$224,202.27. 5 ayes.

Jamie Gravett, Director, JDC, presented an agreement among Minnehaha County, Lutheran Social Services, and fifteen (15) partner counties for juvenile inmate housing services made available at a daily rate of \$200 per day, per bed for JDC housing and \$185.52 per day, per bed for Shelter Care housing. There is a one-time cost for each partner county's share of startup costs for Shelter Care at Lutheran Social Services. These costs are as follows for each county: \$503.33 for Bon Homme, \$2,559.98 for Brookings, \$7,757.02 for Charles Mix, \$2,148.17 for Clay, \$8,354.26 for Davison, \$3,260.79 for Hanson, \$652.64 for Hutchinson, \$1,001.84 for Lake, \$8,130.30 for Lincoln, \$1,399.20 for McCook, \$255.28 for Miner, \$840.48 for Moody, \$1,370.30 for Turner, \$2,909.18 for Union, and \$3,631.66 for Yankton. Mr. Gravett requested authorization for the Chair to sign the 2016 Partner County Agreements. MOTION by Barth, seconded by Bender, to authorize the Chair to sign the 2016 JDC Partner County Agreements. 5 ayes.

NEW BUSINESS

Commissioner Barth commented on the potential need to revise planning requirements for new businesses that may move to the County.

OLD BUSINESS

Commissioner Barth commented on the request for establishing a joint jurisdiction area with the City of Crooks. Kersten Kappmeyer, Chief Civil Deputy State's Attorney, commented on the amount of work that may be involved if the joint jurisdiction passes, and reminded the Commissioners that they have the option to accept or decline the joint jurisdiction.

REPORT

Deputy Auditor

Pam Nelson, Treasurer, presented the annual review of the Minnehaha County Investment Policy and Investment Report. The Investment Policy sets the T-Bill rate as the benchmark for County investments. The County investment yield consists of the weighted average rate on all certificates of deposit, savings, repurchase, and checking accounts. Although the investments have done well, recent decisions in Europe that affect the marketplace may cause a decline in performance.

MOTION by Barth, seconded by Bender, to adjourn into executive session for litigation, contracts, and personnel. 5 ayes.
