MOTION by Barth, seconded by Bender, to approve Special Event On-Sale Liquor Licenses for All Occasions by Hy-Vee for weddings on September 24, 2016, and October 21, 2016 at Blue Haven Barn. 4 ayes.

#### APPOINTMENT

On the recommendation of Robert Litz, Auditor, MOTION by Barth, seconded by Kelly, to appoint Ken McFarland, Richard Kallemeyn, Connie Malone, and Kyle Helseth to the Minnehaha County Surplus Property Appraisal Board. 4 ayes.

#### AGREEMENT

Erin Srstka, Juvenile Detention Alternatives Initiative Coordinator, gave a briefing on an agreement between Minnehaha County and Lutheran Social Services for the Evening Report Center. The total proposed budget for this agreement is \$77,992.32. The program will run 6 days a week and have the youth for around 5 hours per day beginning the first week in September 2016. MOTION by Bender, seconded by Barth, to authorize the Vice Chair to sign the agreement between Minnehaha County and Lutheran Social Services for the Evening Report Center with a proposed budget of \$77,992.32. 4 ayes.

Lynn DeYoung, Emergency Management Director, gave a briefing on the Emergency Management FFY 2017 State and Local Agreement between the State of South Dakota and Minnehaha County which will be used to support salary and administrative expenses within the Minnehaha County Emergency Management Office. This is a 50% reimbursement grant and requires a 50% match from the county. Due to new regulations, a risk analysis had to be completed. The actual dollar amount will be determined when the federal fiscal budget is passed. For FFY2016, Minnehaha County received \$224,202.27. MOTION by Barth, seconded by Kelly, to authorize the Vice Chair and Emergency Management Director to sign the 2017 Emergency Management State and Local Agreement between the State of South Dakota and Minnehaha County. 4 ayes.

Lynn DeYoung, Emergency Management Director, gave a briefing on the Sub-Recipient Grant Agreement between the State of South Dakota Department of Health and Minnehaha County to act as a fiduciary agent for the management of Region 3 SD Hospital Preparedness Program funds. Minnehaha County has budgeted 10% for the cost of that responsibility. The State of South Dakota will provide \$75,175.00 to assist in the planning, training, exercising, and equipment needs of the members. Mr. DeYoung requested authorization to enter into the agreement and authorize the execution of the required documentation including an independent consulting agreement for this grant. MOTION by Kelly, seconded by Bender, to authorize Lynn DeYoung, Emergency Management Director to sign the State of South Dakota Sub-Recipient Grant Agreement between Minnehaha County dba Minnehaha County Emergency Management and the South Dakota Department of Health in the amount of \$75,175.00, and for Minnehaha County to act as fiduciary agent for the grant. 4 ayes. MOTION by Bender, seconded by Barth, to authorize Lynn DeYoung, Emergency Management Director, to sign the consulting agreement with Clites Consulting to provide partnership development and technical assistance to Region 3 SD Hospital Preparedness Response Partners. 4 ayes.

# LIASON REPORTS

Commissioner Bender reported questions were collected from all of the participants in the jail project focus group. There will be a meeting later this week to put together staff answers. The focus group will meet again on Tuesday, August 16, 2016, to go over and vet all questions brought forward.

#### NEW BUSINESS

Commissioner Barth reported he was asked by a person outside the Minnehaha County Administration Building to comment on whether or not Minnehaha County employees are allowed to sign petitions. Minnehaha County employees are allowed to sign petitions if they so choose. Robert Litz, Auditor, stated that he has advised his office staff to stay neutral, but there are no repercussions should they choose to sign a petition.

Commissioner Barth attended a briefing on the Air National Guard F-35 Basing Initiative. Commissioner Beninga stated that everyone on the Commission has had a chance to attend one of the briefings.

MOTION by Barth, seconded by Bender, to adjourn into executive session for potential litigation, personnel, and contract negotiations. 4 ayes.
