FY2017 BUDGET

Carol Muller, Commission Administrative Officer, gave a briefing on the FY 2017 Final Budget which stands at \$81,771,727, as compared to the Provisional Budget of \$82,556,219. The final budget includes eleven (11) new positions. The cash applied total is \$4,852,071 of which general funds are \$4,345,558. No additional opt-out funds were accessed. The final budget reflects property tax growth of three percent (3%) for new construction which adds \$893,000. Per property tax limitation statutes the CPI adjustment is zero. Recent legislation added the following revenues: Senate Bill 2's change in alcohol tax distribution adds \$600,000 and HB1005's change in fees added \$455,000 in Treasurer's fees and \$135,000 in Sheriff's fees. MOTION by Bender, seconded by Barth, to adopt the Final FY 2017 Minnehaha County Budget, and Resolution MC16-52. 4 ayes.

The accompanying taxes are levied by Minnehaha County for the year January 1, 2017 through December 31, 2017.

EARLY HIRE REQUEST

LIAISON REPORTS

Commissioner Bender reported on the September 15th, 2016, Urbanized Development Commission meeting where the City of Sioux Falls presented their transportation improvement plan focusing on public transportation which includes the usage of the Sioux Area Metro System.

Commissioner Barth reported on the September 16th, 2016, Planning and Zoning Commission Meeting noting his appreciation for Scott Anderson's assistance with questions and concerns.

Commissioner Kelly reported he attended the South Dakota Association of County Commissioners Executive meeting where they agreed to oppose Marsy's Law and Amendment 23. Commissioners Kelly, Heiberger, and Bender spoke on the financial ramifications to Counties should Marsy's Law pass, and they stated that South Dakota already has a victim's protection law.

Commissioner Heiberger stated she received a note from the Public Defender's office regarding a psychologist that was hired to conduct a competency evaluation on a client who was in jail. The psychologist was able to meet with the client within one week, wrote a thorough report, and the cost was less than half the cost had the evaluation come from the Human Services Center.

OLD BUSINESS

Robert Litz, Auditor, and Tom Grimmond, Dougherty & Company, addressed the Commission on issues relating to encumbrances on the Community Correction Center property and potential impact to the refunding of bonds approved last week. Mr. Litz stated that he will work with Kersten Kappmeyer, Chief Civil Deputy State's Attorney, and bring the issue forward on the agenda for next week's Commission meeting.

MOTION by Barth, seconded by Bender, to adjourn into executive session for litigation, personnel, and contract negotiations. 4 ayes.
