REQUEST FOR PERSONNEL

Aaron McGowan, State's Attorney, requested the approval to hire four new Victim Witness Assistants and one new Legal Office Assistant in order to stay compliant with Constitutional Amendment S (Marsy's Law). The number of cases in which the County will have an obligation to consult and notify victims will rise significantly. Mr. McGowan stated a rough estimate of the cost of these positions would be around \$250,000 a year. Commissioners expressed concern for the cost of these new positions and requested the State's Attorney's Office, the Auditor's office, and the Human Resources offices to work together to bring back more detailed information regarding the costs of these positions prior to a decision. Bob Litz, Auditor, confirmed these positions were not part of the supplement discussions. MOTION by Bender, seconded by Barth, to defer action hiring four new Victim Witness Assistant Positions and one new Legal Office Assistant Position for the State's Attorney's Office until the Commission Meeting on December 13, 2016. 5 ayes.

DJ Buthe, Highway Superintendent, gave a briefing on a resolution to set weight load limits on certain bridges in Minnehaha County. The resolution includes twenty-seven (27) postings. Three bridge (3) postings will be on County Highways and twenty-four bridge (24) postings on Township Secondary Roads. MOTION by Barth, seconded by Kelly, to approve Resolution MC16-67. 5 ayes.

RESOLUTION MC16-67 SET WEIGHT LOAD LIMITS ON CERTAIN BRIDGES WITHIN MINNEHAHA COUNTY

WHEREAS, the Minnehaha County Highway Department performs regular bridge inspections to assess the condition of individual bridges and consider recommendations for improvements, and

WHEREAS, the Minnehaha County Highway Department performs bridge maintenance projects and bridge replacement projects in an effort to improve the overall condition of the bridge network, and

WHEREAS, the Minnehaha County Highway Superintendent has identified *twenty-seven* bridges in Minnehaha County that are recommended for weight load limits, and

WHEREAS, SDCL 32-22-47 gives the county commission the authority to establish and identify through the proper signage the maximum weight of any vehicle, laden or un-laden, which may enter upon or cross over the bridge, now

THEREFORE, BE IT RESOLVED by the Minnehaha County Board of Commissioners that all *thirty* of the existing bridge weight load limits described in *Minnehaha County Resolution MC15-75* are hereby removed and superseded with the following *twenty-seven* gross vehicle weight load limits:

AGREEMENTS

MOTION by Barth, seconded by Kelly, to authorize the Chair to sign the Right-Of-Way Purchase Agreement with David and Dixie Rogness at a cost of \$2,800. 5 ayes.

Item deferred from November 22nd, 2016

DJ Buthe, Highway Superintendent, gave a briefing on a contract with Tetonka L.L.P. in the amount of \$13,625 to mitigate impacting 1.00 acres of existing wetlands and purchase 0.89 Functional Capacity Units of jurisdictional wetlands associated with the 50-129-060 bridge reconstruction project. Tetonka L.L.P. will assume 100% of the risk and compliance with the US Army Corps of Engineer's requirements, monitoring, and reporting.
