PUBLIC COMMENT

Robert Kolbe, Sioux Falls, SD, presented a gift to retiring Commissioner Kelly and wished the Commissioners Happy Holidays.

AGREEMENTS

Robert Wilson, Assistant Commission Administrative Officer, presented the 2017 contract among Minnehaha County, Sanford Health Pathology Clinic, and Dr. Kenneth S. Snell, for Coroner and Medical Examiner Services. Under the terms of the contract, Dr. Snell, through Sanford Health Pathology Clinic, will receive \$6,000 per month for coroner duties that will be shared with the deputy coroners at Sanford Health. Dr. Snell, through Sanford Health Pathology Clinic, will also receive a flat rate of \$18,440.18 per month for medical examiner duties. Lab fees, ambulance transports, and monthly cell phone/pager costs will be paid separately from within the FY 2017 Coroner Budget. These fees are estimated at \$48,130 per year. MOTION by Barth, seconded by Kelly, to approve the 2017 contract among Minnehaha County, Sanford Health Pathology Clinic, and Dr. Kenneth S. Snell, for Coroner and Medical Examiner Services. 5 ayes.

Robert Wilson, Assistant Commission Administrative Officer, gave a briefing on a contract between Minnehaha County and Dr. Jeff Luther to perform the services of Quality Assurance Director for the rural ambulance quality assurance program in accordance with county ordinance MC31-4-16. Under the terms of the contract, Dr. Luther will receive \$30,000 payable in twelve (12) equal monthly installments. Quarterly reports will be presented to the Commission as part of the contract. MOTION by Beninga, seconded by Kelly, to authorize the Chairman to sign the 2017 contract between Minnehaha County and Dr. Jeff Luther for Quality Assurance Director for Rural Ambulance Service. 5 ayes.

Robert Wilson, Assistant Commission Administrative Officer, gave a briefing on the 2017 contract between Minnehaha County and Carroll Institute to provide housing and a low-intensity, short term residential and pretreatment program for individuals who have been court ordered into treatment. The major provisions of the contract are as follows: Carroll Institute will provide housing for up to 4 individuals per day in their facility at 327 S. Spring, Sioux Falls; The County will pay Carroll Institute \$111,330 in 12 equal monthly installments; The Sheriff's Department will provide transportation from the detoxification center or the jail upon a schedule

determined by the Sheriff's Department to the Carroll Institute IVC Housing Unit, and transportation to the involuntary treatment program will be by existing protocol. Gary Tuschen, Carroll Institute Executive Director, spoke on the recidivism rate and stated they work to capture economic status information. MOTION by Kelly, seconded by Barth, to authorize the Chairperson to sign the 2017 agreement between Minnehaha County and Carroll Institute for short-term residential substance abuse pre-treatment services beginning January 1, 2017 through December 31, 2017 at a cost of \$111,330. 5 ayes.

Robert Wilson, Assistant Commission Administrative Officer, gave a briefing on an agreement with Southeastern Behavioral Health to provide Qualified Mental Health Professional services for the Mobile Crisis Team. The terms of the agreement are for Minnehaha County to pay Southeastern Behavioral Health a program administrative fee of \$5,000 per year in twelve monthly installments of \$416.67. The County will also be responsible for the on-call costs of mental health professionals at a rate of \$100 per 24 hour on-call period, \$50 for on-call periods of less than 24 hours, \$25 per hour for on-call as-needed crisis intervention services, and a rate of \$37.50 per hour for Southeastern Employees eligible for overtime. Minnehaha County will also reimburse the provider for the cost of program supplies and equipment. MOTION by Beninga, seconded by Bender, to authorize the Chairperson to sign the 2017 Agreement for Mobile Crisis Team Services between Minnehaha County and Southeastern Behavioral Health. 5 ayes.

Robert Wilson, Assistant Commission Administrative Officer, gave a briefing on the 2017 contract between Minnehaha County and the Sioux Falls Humane Society for animal control services. Minnehaha County has allocated \$47,000 for animal control in the 2017 budget. \$36,036 will be paid out in 12 monthly installments of \$3,003. In addition, the Humane Society will bill \$56.00 per hour plus the IRS approved mileage rate for any emergency after-hours calls. Once the billing reaches 80% of the budget, the Humane Society and the County will consider a change in protocol to reduce costs or determine if a budget supplement is necessary. MOTION by Barth, seconded by Kelly, to authorize the Chair to sign the contract between Minnehaha County and the Sioux Falls Humane Society for animal control services for the period of January 1, 2017, through December 31, 2017. 5 ayes.

LEASE

Robert Wilson, Assistant Commission Administrative Officer, gave a briefing on a six (6) month lease agreement between Minnehaha County and CASA (Court Appointed Special Advocate). Under the terms of the agreement, CASA will pay \$3,625 to lease 1,500 square feet of office space on the first floor of the Extension Building. CASA will make two quarterly payments in the amount of \$1,812.50. The County pays for heat, electricity, and janitorial service. MOTION by Beninga, seconded by Kelly, to authorize the Commission Chair to sign the lease agreement between Minnehaha County and CASA in the amount of \$3,625 beginning January 1, 2017 through June 30, 2017. 5 ayes.

POLICY

DJ Buthe, Highway Superintendent, gave a briefing on changes to the Minnehaha County Policies and Procedures Manual in Section V.K., Highway Department Construction Projects. The following are the proposed changes: 1) remove the first sentence of the policy, 2) remove the first paragraph of the introduction subsequently changing the section numbers, 3) edit section 4 to reflect changes in State statute, 4) add a statement to section 5 indicating bid notices will be approved by the Commission Liaison and the Commission Chair. MOTION by Kelly, seconded by Barth to approve the changes to Section V.K., Highway Department Construction Projects in the Minnehaha County Purchasing Manual. 5 ayes.

Kim Adamson, Finance and Budget Officer, gave a briefing on nonsufficient funds (NSF) checks from 2001-2008. Efforts to collect on the NSF checks have been exhausted. Staff is requesting the Commission approve

writing off ten NSF items totaling \$2,341.34, pursuant to South Dakota Codified Law 7-11-4.2. MOTION by Barth, seconded by Bender, to authorize the write off of ten NSF checks totaling \$2,341.34 with dates ranging from 2001 to 2008. 5 ayes.

EASEMENT

Deferred from December 13, 2016

Robert Wilson, Assistant Commission Administrative Officer, reported that Northern State's Power (Xcel Energy) is requesting a 1.04 acre easement to install a power pole on County property legally described as Lot R-1 of Government Lot 2 of the Southwest Quarter of Section 30, Township 102 North, Range 48 West, Minnehaha County, South Dakota. Xcel Energy has an existing easement on a portion of the property for overhead power lines and the placement of one utility pole. Due to the construction on South Dakota Highway 100, the power pole needs to be moved 10 feet south of its current location. Xcel Energy has agreed to pay \$40,000 to Minnehaha County for the new easement and will propose action to vacate the existing easement once the new poles and power lines are installed and the current ones have been removed. MOTION by Barth, seconded by Beninga, to authorize the Chair to sign the Easement Agreement with Northern State's Power for Access to County property legally described as Lot R-1 of Government Lot 2 of the Southwest Quarter of Section 30, Township 102 North, Range 48 West, Minnehaha County, South Dakota at a cost of \$40,000 to be paid to Minnehaha County. 5 ayes.

LIAISON REPORTS

Commissioner Heiberger reported on the quarterly South Dakota Association of County Commissioners meeting held in Pierre where culvert law and the State's radio system were discussed.

Commissioner Kelly reported every county in South Dakota is now a member of the National Association of Counties.

Commissioner Barth reported on attending an event held by Lloyd Companies at Safe Home where he had the opportunity to meet with people who live there and hear their stories.

OLD BUSINESS

Commissioner Barth reported on the need for a new vehicle for the Emergency Management Director due to issues with the current vehicle's engine. Because the vehicle was not scheduled for replacement until 2018, Commissioner Barth spoke on a plan to replace the vehicle. Doug Blomker, Assistant Director of Emergency Management, and DJ Buthe, Highway Superintendent, spoke on the costs of replacing the vehicle. Commissioner Barth stated this issue will be an agenda item at the December 27th, 2016, Commission Meeting.

Commissioner Kelly introduced his family members who were present during the meeting.

PROCLAMATION

Robert Wilson, Assistant Commission Administrative Officer, spoke on Commissioner Dick Kelly's retirement from the Minnehaha County Commission after serving for eight (8) years. Commissioner Kelly has also served as a Sioux Falls City Councilmen and a State Senator. Mr. Wilson read a proclamation declaring December 20th, 2016, as Commissioner Dick Kelly Day in Minnehaha County. A letter written by Governor Dennis Daugaard to Commissioner Kelly was read by Mr. Wilson. The Sioux Falls City Mayor, Mike Huether, thanked Commissioner Kelly for his years of service and read a proclamation declaring December 20th, 2016, as Commissioner Dick Kelly Day in the City of Sioux Falls. Commissioner Heiberger presented a retirement gift and thanked Commissioner Kelly for his years of service.

MOTION by Bender, seconded by Beninga, to adjourn. 5 ayes.
