VEHICLE PURCHASE

Lynn DeYoung, Emergency Management Director, requested declaring one 2008 Chevrolet Suburban, VIN 3GNFK16348G249220, as surplus for disposal and assign one 2015 GMC, VIN 1GKS2AKC7FR739438, from the Highway Department to the Emergency Management Department. The Emergency Management Director's Suburban is no longer operable and would cost an estimated \$4,000-6,000 to repair. This vehicle

was not scheduled to be replaced until 2018, therefore, the replacement is not budgeted. The GMC has a value of \$32,000 and would need approximately \$1,500 in new equipment bringing the total cost to the Emergency Management Department to \$33,500. If the Emergency Management Department purchased a new vehicle, the total cost would be \$44,657. MOTION by Bender, seconded by Kelly, to declare one (1) Emergency Management 2008 Chevrolet Suburban, VIN 3GNFK16348G249220, as surplus for disposal at public auction. 4 ayes. MOTION by Kelly, seconded by Bender, to declare one (1) 2015 GMC, VIN 1GKS2AKC7FR739438, as surplus for sale from the Highway Department to Emergency Management in Budget Year 2017 at a cost of \$32,000. 4 ayes. MOTION by Bender, seconded by Beninga, to authorize Emergency Management to Purchase one (1) 2015 GMC, VIN 1GKS2AKC7FR739438, in Budget Year 2017 at a cost of \$32,000 from the Highway Department. 4 ayes.

DJ Buthe, Highway Superintendent, requested authorization to purchase one 2017 GMC Yukon from Billion Automotive of Sioux Falls at a cost of \$43,979. Due to the preceding authorization to assign one 2015 GMC to the Emergency Management Department, the Highway Department is in need of a vehicle. This vehicle is not budgeted for in 2016, but there is available funds in the Highway Department's 2016 budget to cover the cost. MOTION by Kelly, seconded by Bender, to authorize the Highway Department to purchase one (1) 2017 GMC Yukon from Billion Automotive in the amount of \$43,979. 4 ayes.

LEASE

DJ Buthe, Highway Superintendent, gave a briefing on a Lease Agreement with Jensen Holdings, LLC (Jensen Electric) to temporarily house two fire trucks within their facility during the replacement of a bridge located east of Renner, Structure #50-205-140, at a cost of \$760 per month. Due to the bridge replacement, local residents voiced concerns about the fire protection to the eastern portions of Mapleton Township and the surrounding areas. Housing two fire trucks at Jensen Electric for the duration of the bridge replacement would allow for no loss in service. Replacement of the bridge is expected to last three months. MOTION by Kelly, seconded by Bender, to authorize the Chair to sign the Lease Agreement with Jensen Holdings, LLC at a monthly rent of \$760 to house two fire trucks. 4 ayes.

AGREEMENT

DJ Buthe, Highway Superintendent, gave a briefing on a Professional Services Agreement with Ulteig for the 2017 Minnehaha County bridge railing maintenance projects at a cost not to exceed \$55,560. Ulteig will provide analysis of existing conditions, design, and plan preparation for guardrail improvements on 347 miles of County Highway. MOTION by Bender, seconded by Kelly, to authorize the Chair to sign the Professional Services Agreement with Ulteig at a cost not to exceed \$55,560. 4 ayes.

RESOLUTION

Shannon Schultz, Assistant Highway Superintendent, gave a briefing on a resolution that would replace Resolution MC13-10 which established fees for overweight/oversize permits. The Highway Department has met with a representative from the Sioux Falls Contractors' Association regarding the proposed change. MOTION by Kelly, seconded by Beninga, to approve Resolution MC16-74. 4 ayes.

MC16-74 RESOLUTION REVISING MC13-10 ESTABLISHING NEW FEES FOR HIGHWAY OVERWEIGHT/OVERSIZE PERMITS

WHEREAS, the Minnehaha County Highway Department currently administers Highway Overweight/Oversize Permits to the public at specified fees according to Resolution MC12-72; and

WHEREAS Resolution MC13-10 established fees for single trip, multiple trip, and annual trip overweight and oversize permits as administered through the Minnehaha County Highway Department; and

WHEREAS, the Minnehaha County Board of Commissioners finds it necessary to periodically adjust fees to keep pace with rising costs for these services;

NOW THEREFORE BE IT RESOLVED by the Minnehaha County Board of Commissioners that the Minnehaha County Highway Department is hereby authorized to charge the following fees:

AGREEMENT

Jamie Gravett, JDC Director, presented an agreement among Minnehaha County, Lutheran Social Services, and fifteen (15) partner counties for juvenile inmate housing services made available at a daily rate of \$220 per day, per bed for JDC housing and \$185.52 per day, per bed for Shelter Care housing. A provision within the contract allows for the change of the Shelter Care rate as it is dependent upon the State's calculation in April 2017 for their next fiscal year starting July 1, 2017. The rate for Community Supervision services to Lincoln County is set at \$60.00 per day, per youth. MOTION by Bender, seconded by Beninga, to authorize the Chair to sign the 2016 JDC Partner County Agreements with Davison, Moody, Lincoln, Turner, Lake, Clay, McCook, Yankton, Charles Mix, Brookings, Hutchinson, Union, Bon Homme, Hanson, and Miner counties. 4 ayes.

GRANT

Kersten Kappmeyer, Chief Civil Deputy State's Attorney, requested approval for the third year of a three year grant for two (2) fulltime DUI/Vehicular Crimes Prosecutors and one (1) Legal Office Assistant to oversee and track all DUI cases in Minnehaha County. The grant was awarded in 2014 by the South Dakota Department of Public Safety and will provide funding through the end of 2017. The positions are not to exceed a fulltime employee salary equivalent to a Grade 22/Step 3. MOTION by Kelly, seconded by Beninga to approve the acceptance of grant funding for two (2) fulltime DUI/Vehicular Crimes Prosecutors and one (1) Legal Office Assistant through the South Dakota Department of Public Safety for the Minnehaha County State's Attorney's Office for FY2017. 4 ayes.

MEMORANDUM OF UNDERSTANDING

Robert Wilson, Assistant Commission Administrative Officer, gave a briefing on a Memorandum of Understanding (MOU) with the City of Sioux Falls for Pictometry services. An agreement with Pictometry International Corp. was approved by the Commission on December 13, 2016, and included a letter of intent from the City to enter into a MOU with the County for the use of Pictometry aerial imaging services. The City will pay the County \$20,825 annually for three years. MOTION by Bender, seconded by Beninga, to authorize the Chair to sign the Memorandum of Understanding with the City of Sioux Falls for Pictometry services for the years 2017, 2018, and 2019 with annual payments of \$20,825 to be paid by the City to the County. 4 ayes.

LIAISON REPORTS

Commissioner Kelly reported Jodi Fick has been appointed as the Library Director of Siouxland Libraries.

Commissioner Beninga reported on a meeting with Kari Benz, Director of Human Services, regarding the possible use of an attorney to assist with concerns about the involuntary commitments process.

NEW BUSINESS

Carol Muller, Commission Administrative Officer, reported that the January 3, 2017, Commission Meeting will be an organizing meeting for the new year.

OLD BUSINESS

Commissioner Heiberger stated this would be Commissioner Kelly's last meeting as a County Commissioner and thanked him for his years of service. Commissioner Beninga stated that working with Kelly has been an extremely positive experience and appreciates his service. Commissioner Bender thanked Kelly for his guidance and service.

MOTION by Kelly, seconded by Beninga, to adjourn into executive session for discussion on contracts. 4 ayes.
