The application was reviewed by the Minnehaha County State's Attorney's Office, Planning & Zoning Department, and Sheriff's Department. No objections were reported. Commissioner Karsky stated he had questions for the applicant and would have preferred the applicant been in attendance. MOTION by Heiberger, seconded by Bender, to approve a Retail On-Off Sale Malt Beverage License for M&M Gaming Inc. dba State Line Casino, legal description of licensed property is Lot 5, 6, and vacated Alley adj to Blk 14 Rowena Original Addn, Section 26, Township 101, Range 48. 5 ayes.

ORDINANCES

Kevin Hoekman, Planner, was present for the second reading and public hearing on the 2017 Floodplain Management Ordinance MC48-17. The new ordinance is needed to be compliant with changes made by the Federal Emergency Management Agency (FEMA) to the flood insurance rate panel maps. FEMA, the State, and the State's Attorney's Office have reviewed the new ordinance. Scott Anderson, Planning Director, stated FEMA will be changing their maps again later this year based on a study of the 9 Mile Creek area. MOTION by Barth, seconded by Karsky, to approve Ordinance MC48-17 An Ordinance Providing For The Adoption Of The 2017 Floodplain Management Ordinance For Minnehaha County And For The Repeal Of All Ordinances And Resolutions In Conflict There With. 5 ayes. The entire ordinance is on file and available for inspection at the County Auditor's Office.

Scott Anderson, Planning Director, was present for the second reading and public hearing on a text amendment to the Rural Addressing Ordinance MC21-93. The proposed amendment would give townships the responsibility to repair and maintain intersection signs located in their jurisdiction except those signs where a township road intersects with a state highway. Each township chair has been sent a letter regarding the proposed change, a copy of the proposed ordinance, and a copy of the hearing notice. Shannon Schultz, Assistant Highway Superintendent, stated this ordinance is necessary due to the sign replacement contract with the State. Nathan Howe of Highland Township and Oran Sorenson of Palisade Township spoke on their concerns with the ordinance, placement and maintenance of signs, and roads leading to state parks. Mr. Schultz stated the County would be responsible for the signs where a township and county road intersects and is not opposed to adding this to the ordinance for clarification. Eugene Even, Wellington Township, stated the new signs make snow removal difficult. MOTION by Heiberger, seconded by Barth, to approve the proposed text amendment Ordinance MC21-15-17, An Ordinance Amending The Rural Addressing Ordinance MC21-93 for Minnehaha County by Revising the Text Concerning Building Address Numbers, Signs, and Delineator Posts, and Their Purchasing and Placement with the addition of "or county" being added after "state" in the last sentence of the proposed revisions to Section 2A. 5 ayes. The entire ordinance is on file in the County Auditor's Office.

BUDGET SUPPLEMENT

Jamie Phelps, Quality Assurance and Improvement Manager, requested a supplement of \$37,835.83 from the Emergency Food & Shelter Program (EFSP) Fund to the EFSP Budget representing the 2017 EFSP

Allocation. The funds will be a pass through to the Bishop Dudley Hospitality House to help supplement services provided by the organization. MOTION by Heiberger, seconded by Barth, to supplement \$37,835.83 from the Emergency Food & Shelter Program Fund to the Emergency Food & Shelter Program Budget, ASN 21137. 5 ayes.

VEHICLE PURCHASE

Diane Rypkema, Director of Equalization, requested authorization to purchase one 2017 Chevy Malibu and two 2017 Ram Pickups off of 2017 State Bid Contract Numbers 16992 and 16998. One 2017 Chevy Malibu will be purchased through Contract #16992 at a cost of \$19,170.00, including delivery, from Beck Motors in Pierre, SD. Two 2017 Ram Pickups will be purchased through Contract #16998 at a cost of \$22,889 per vehicle, including delivery, from Wegner Auto Company in Pierre, SD. The total cost for all three vehicles is \$64,948, which is \$4,948 over the budgeted amount of \$60,000. The additional funds will be recouped from the surplus of three other vehicles and savings in other areas of the department. MOTION by Barth, seconded by Heiberger, to authorize the Equalization Department to purchase one 2017 Chevy Malibu off of the 2017 State Bid Contract #16992 from Beck Motors in Pierre, SD at a cost of \$19,170 and two 2017 Ram Pickups off of 2017 State Bid Contract #16998 from Wegner Auto Company in Pierre, SD at a cost of \$22,889 per vehicle. 5 ayes.

LIAISON REPORTS

Commissioner Bender reported on the January 9, 2017, Homeless Advisory Board Meeting where Helpline presented the Sioux Empire Network of Care that allowed the participating non-profits to communicate with one another through one intake form.

Commissioner Heiberger reported the Expo Building's furnace at the W.H. Lyon Fairgrounds needed unbudgeted repairs, and indicated a list of long-term repairs may need to be complied for the fairgrounds.

Commissioner Barth reported the Planning Department was notified that the City of Crooks has enacted a platting jurisdiction. Scott Anderson, Planning Director, spoke on Crooks' enactment of this platting jurisdiction, Crooks' obligations due to their enactment, why Crooks may have taken this action, how this will affect the public, and how this will affect the County. Commissioners voiced concerns regarding how the lines are drawn on the map provided by Crooks and how it affects the public. Kersten Kappmeyer, Chief Civil Deputy State's Attorney, spoke on platting authority versus joint zoning authority. Commissioners expressed the desire to have representatives from the City of Crooks give a briefing on the platting jurisdiction and what will happen going forward.

MOTION by Heiberger, seconded by Bender, to adjourn. 5 ayes.
