Robert Wilson, Assistant Commission Administrative Officer, gave a briefing on an application for a compromise of lien for DPNO 88273 in the amount of \$356.40. Court Appointed Attorney and Public Defender services were provided to the applicant's minor child between August 2015 and November 2016. The August 2015 lien was only placed against the applicant, the child's mother, and not the child's father. The November 2016 lien was placed against both parents. The applicant lists total assets of \$2,623.42, a 1999 Blazer, and some household goods. Liabilities total \$947 consisting of monthly bills/expenses. A copy of the applicant's 2015 tax return shows an annual income of \$25,326 and a refund of \$3,809. The applicant is requesting a compromise and release of the lien in full with no payment. The applicant spoke on her reasons for requesting a compromise. Commissioners encouraged the applicant to make small payments over time. MOTION by Bender, seconded by Barth, to take no action and direct the Auditor's Office research the August 2015 lien in regard to the father's financial responsibility. 4 ayes.

Commissioner Barth stated he and Commissioner Heiberger will be traveling to Washington D.C. to meet with federal legislators and attend the 2017 National Association of Counties Legislative Conference. Commissioner Heiberger asked that any thoughts on what should be addressed during their meetings be given to Robert Wilson, Assistant Commission Administrative Officer, in order to compile a list of topics.
