RESOLUTION

DJ Buthe, Assistant Highway Superintendent, reported the City of Crooks contacted the Highway Department requesting a reduction of the speed limit from 35 miles per hour (mph) to 25 mph on County Highway 137 (470th Ave), approximately 700 feet south of Crooks' city limits. Speed data gathered indicates drivers are exceeding the posted limits with an average speed of 37.1 mph with the average traffic volumes of 334 cars between the hours of 8-9 a.m. and 270 cars between the hours of 5-6 p.m. Utilizing the Federal Highway Administration's USLimits2 software, the recommended speed limit is 45 mph. Staff has contacted Mayor Jamison Rounds of Crooks to discuss the findings and he is in support of the proposed speed limit change. WHEREAS, the Minnehaha County Board of Commissioners has reviewed existing traffic patterns on County Highway 137, also known as 470th Avenue at a location south of Crooks, SD in Minnehaha County, and

WHEREAS, SDCL 32-25-9.1 provides the authority for a board of county commissioners to establish speed limits within their respective jurisdictions, and,

WHEREAS, the Minnehaha County Commission believes it to be in the best interest of the traveling public to establish the speed limit as requested, now

THEREFORE BE IT RESOLVED, by the Minnehaha County Board of Commissioners that the speed limit on that portion of Minnehaha County Highway 137, also known as 470th Avenue, beginning 660 feet south of West 10th Street in the City of Crooks Street thus beginning at a point where the southern boundary of City Limits exist, and extending south a distance of 1,440 feet (0.273 miles), is hereby established at 45 miles per hour.

Mr. Buthe recommended the following bid awards: Proposal #2, Hot Mix Asphalt Concrete Pavement, Concrete Materials, Inc.; Proposal #3, Snowplow and Motor Grader Blade Cutting Edges, Titan Machinery; Proposal #4, Abrasive and Salt Mixture (Salt Sand), Concrete Materials, Inc.; Proposal #5, Rock Salt and Transportation, Black Strap, Inc. There were no bids received for Proposal #1, Medium-Curing Cutback Asphalt (MC-70). Once current stock is depleted, the Highway Department will purchase less than \$25,000 worth of asphalt without the necessity of a formal bid. RESOLUTION

DJ Buthe, Highway Superintendent, presented a resolution for participation in the SD Department of Transportation (SDDOT) Bridge Inspection/Re-Inspection Program. The U.S. Federal Highway Administration requires inspection of all bridges every two years and culverts every four years. Mr. Buthe requested participation in the program using Banner Associates, Inc. of Sioux Falls, SD for the inspection work. MOTION by Heiberger, seconded by Barth, to authorize the Chair to sign Resolution MC17-9. 5 ayes.

RESOLUTION MC17-9 BRIDGE REINSPECTION PROGRAM RESOLUTION FOR USE WITH SDDOT RETAINER CONTRACTS

WHEREAS, Title 23, Section 151, United States Code and Title 23, Part 650, Subpart C, Code of Federal Regulations, requires initial inspection of all bridges and reinspection at intervals not to exceed two years with the exception of reinforced concrete box culverts that meet specific criteria. These culverts are reinspected at intervals not to exceed four years.

THEREFORE, Minnehaha County is desirous of participating in the Bridge Inspection Program using Bridge Replacement funds.

The County requests SDDOT to hire Banner Associates, Inc. for the inspection work. SDDOT will secure federal approvals, make payments to the Consulting Engineer for inspection services rendered, and bill the County for 20% of the cost. The County will be responsible for the required 20% matching funds.
