AGREEMENTS

Jamie Gravett, Juvenile Detention Center Director, presented an agreement between Minnehaha County and Integrated Technology & Security (ITS) for the replacement of security cameras at the Juvenile Detention Center at a cost of \$66,891. ITS will remove existing equipment and install and program equipment. An ITS factory trained technician will install, train, and commission the system. All existing cameras will be replaced and new areas will be chosen for additional cameras in previous no coverage areas. The agreement also includes new servers, the software required to run the system, and all cables. MOTION by Karsky, seconded by Heiberger, to authorize the Chair to sign the Video Security Agreement with Integrated Technology & Security for the replacement of the Juvenile Detention Center security camera system at a cost of \$66,891. 4 ayes.

Joe Bosman, Deputy Sheriff Lieutenant, presented an annual agreement to participate in the Federal Equitable Sharing Program. The program allows for participants to receive a share of federally forfeited proceeds that may be used for law enforcement purposes. MOTION by Barth, seconded by Karsky, to authorize the Chair to sign the Federal Equitable Sharing Agreement and Certification. 4 ayes.

Jamie Phelps, Quality Assurance and Improvement Manager, presented a one year agreement between Minnehaha County and Lincoln County for Human Services Caseworker Services. The terms of the agreement are for Lincoln County to reimburse Minnehaha County for its services at the rate of \$5,984.03 per month. Lincoln County will pay the cost of the Lincoln County landline phone and fax. Minnehaha County will pay for the Lincoln County cell phone. The total projected cost of the agreement is \$71,808.36. MOTION by Barth, seconded by Karsky, to approve the Agreement for Casework Services between Minnehaha County and Lincoln County beginning on April 1, 2017 through March 31, 2018. 4 ayes.

Monte Watembach, Information Technology Director, presented a Consulting Agreement between Minnehaha County and BerryDunn for project management of the Enterprise Resource Planning software implementation. BerryDunn will provide 94 weeks of project management and 48 on-site trips at a total cost of \$384,212. MOTION by Karsky, seconded by Heiberger, to authorize the Chair to sign the Consulting Agreement with BerryDunn for project management of the Enterprise Resource Planning software implementation at a cost of \$384,212. 4 ayes.
