## **RESOLUTION MC17-12**

A RESOLUTION ADOPTING THE JOINT CITY OF SIOUX FALLS/MINNEHAHA COUNTY 2040 COMPREHENSIVE PLAN.

WHEREAS, the Joint City of Sioux Falls and Minnehaha County Planning Commissions have proposed a plan for the physical development of the joint jurisdictional area within the approved joint planning jurisdictions;

WHEREAS, the Joint Minnehaha County and Sioux Falls Planning Commissions held a public hearing on October 24, 2016, to gain input from the public;

WHEREAS, the Joint Sioux Falls City Council and Minnehaha County Commission held a public hearing on March 28, 2017, to gain input from the public;

WHEREAS, the comprehensive plan shows the Joint City of Sioux Falls and Minnehaha County Planning Commission's recommendations of guiding and accomplishing a coordinated, adjusted, and harmonious development of each joint planning jurisdictional area, which will, in accordance with existing and future needs, best promote health, safety, morals, order, convenience, prosperity or the general welfare, as well as efficiency and economy in the process of development;

#### **MUSEUM**

Bill Hoskins, Museum Director, presented the final design plans for the Siouxland Heritage Museum Archive Facility. The final plan includes a site plan, floor plan, exterior elevation, and current cost estimate of \$4,106,861. The new facility will provide one site for the storage of museum collections, provide a controlled environment for the collections, provide a workspace for staff and the public to access the collections, and will be a secure location. The new facility will be funded by the County, the City, and privately raised funds. Bob Litz, County Auditor, reported the County has funds available for the facility. David Bixler, City Budget Analyst, reported on City finances regarding the portion of funds they will be providing for the facility.
