Deferred on March 28, 2017

Diane Rypkema, Director of Equalization, presented the following abatement for denial: RDID 24637 Jesus Only Apostolic Church, 1926 Burnside St., for 2016 property taxes in the amount of \$17,311.06. The assessment date was November 1, 2015, at which time the property did not meet the qualifications for exempt status. The property was for sale by the Moose Lodge and was not being used for its intended purpose. In April 2016, the County Board of Equalization removed the Moose Lodge's exempt status. Prior to this, the Moose Lodge was informed by County staff of the hearing date and time via a letter and a phone call. TTT Investments LLC purchased the property from the Moose Lodge in September 2016 and filed a quit claim deed in December 2016 to transfer ownership to Jesus Only Apostolic Church. Matthew Sengsouvanna, 6800 E Pine Lake Dr, Sioux Falls, spoke on behalf of Jesus Only Apostolic Church and stated the building was used for non-profit purposes throughout 2016 as their Church, a food bank, and a school even though the Church did not own the property until December. Commissioners Bender and Heiberger spoke in favor of denial due to the following reasons: 1) the Moose Lodge having received notification from the County when they were losing their tax exempt status, 2) the many roles that Mr. Sengsouvanna played being a Moose Lodge Member, being a church member, and an employee of TTT Investments LLC, and 3) that TTT Investments LLC did not transfer the property until December 2016 after purchasing in September 2016. MOTION by Barth, seconded by Heiberger, to deny the following abatement: RDID 24637 Jesus Only Apostolic Church, 1926 Burnside St., for 2016 property taxes in the amount of \$17,311.06. 5 ayes.

BRIEFING

Dana Loseke, Board Chair of Friends of the Big Sioux River, gave a briefing on the mission and goals of Friends of the Big Sioux River for Sioux Falls and Eastern South Dakota and noted major contaminants of the river and ways to reduce these contaminants.

AGREEMENT

DJ Buthe, Highway Superintendent, gave a briefing on a Professional Services Agreement between Minnehaha County and Short, Elliot, Hendrickson, Inc. for engineering services to design the repairs for the rehabilitation of two bridges, Structure No. 50-190-049 (473rd Ave) located approximately 3 miles south and 2 miles west of Dell Rapids and Structure No. 50-284-160 (260th Street) located approximately 0.5 miles north of Brandon. The cost of services is not to exceed \$60,280. MOTION by Heiberger, seconded by Barth, to authorize the Chair to sign the Professional Services Agreement between Minnehaha County and Short, Elliot, Hendrickson, Inc. for engineering services of Structure No. 50-190-049 and Structure No. 50-284-160, in an amount not to exceed \$60,280. 5 ayes.

REPORT

Traci Smith, Public Defender Director, presented the Minnehaha County Public Defender's Office 2016 Annual Report. The report is on file in the Auditor's Office.

GRANT

Jason Gearman, Deputy Sheriff Captain, presented a Sub-Recipient Agreement between Minnehaha County and The South Dakota Network Against Family Violence and Sexual Assault (The Network) for the award of a domestic violence grant in the amount of \$90,482. The grant will be used to fund half the salary of one full time Deputy Sheriff Detective for the Minnehaha County Sheriff's Department. The position would be for a domestic violence investigator who specializes in domestic violence related crimes. MOTION by Heiberger, seconded by Barth, to authorize the Minnehaha County Sheriff to sign the Sub-Recipient Agreement with The South Dakota Network Against Family Violence and Sexual Assault, also known as The Network, beginning on January 14, 2017, and ending September 30, 3019, in the amount of \$90,482. 5 ayes.

AGREEMENT

Carol Muller, Commission Administrative Officer, presented an agreement between Minnehaha County and The Tegra Group, Inc. (Tegra) for owner's representation services on the Minnehaha County jail expansion project. Tegra will serve as the representative for Minnehaha County for general project administration, including items such as contracts, negotiations, master budget, cost control, and construction delivery. The selection and hiring of the architect and contractor will also be facilitated by Tegra. A fixed fee of \$325,000 will be paid to Tegra in monthly installments of \$25,000. The total cost will not exceed 1.5% of the project's total cost. MOTION by Bender, seconded by Barth, to approve the Consulting Agreement between Minnehaha County and The Tegra Group, Inc. for owner's representation services on the Minnehaha County Jail Expansion Project with a fixed fee of \$325,000 and a total cost not to exceed 1.5% of the jail expansion project's total cost beginning upon execution of the contract and ending upon completion of the project. 5 ayes.

BUDGET

Carol Muller, Commission Administrative Officer, was present for discussion to streamline the budget process. State statute requires the provisional budget, a budget hearing, the final adoption, and potential opt-out dates be done by a specific time of year. A proposed budget meeting schedule has been provided to Commissioners based on these requirements. Bob Litz, County Auditor, Kim Adamson, Finance & Budget Officer, Diane Rypkema, Director of Equalization, and Carey Deaver, Human Resources Director, were available to answer

Commissioner's questions. Commissioners directed staff to work on the following: 1) department heads work towards a 1.3% increase as a target number, 2) work on budget dates for first meeting most likely to take place the end of May or beginning of June, 3) two half days of meetings instead of a full day, 4) new positions will not be added into the budget, and 4) a salary increase will be inserted at the beginning of the meetings.

LIAISON REPORTS

Commissioner Heiberger reported on meetings with Brown and Davison counties she and Erin Srstka, Juvenile Detention Alternatives Initiative Coordinator, attended on April 6, 2017, to discuss implanting alternatives to juvenile detention in those counties.

Commissioner Barth reported attending the April 4, 2017, public meetings regarding the Emergency Management System study conducted by Fitch & Associates with Commissioner Bender. Mr. Barth also attended last week's Museum meeting.

MOTION by Barth, seconded by Heiberger, to adjourn. 5 ayes.
