MOTION by Barth, seconded by Bender, to authorize the Auditor to publish a Notice of Hearing on May 30, 2017, to consider the rezoning amendment. 5 ayes.

#### PROCLAMATION

Carol Muller, Commission Administrative Officer, read a proclamation recognizing May 7<sup>th</sup> through the 13<sup>th</sup>, 2017, as National Correctional Officers and Employees Week in Minnehaha County. James Gravett, Juvenile Detention Center Director, introduced his staff in attendance. Jeff Gromer, Jail Warden, stated his staff were not able to attend due to work schedule conflicts. MOTION by Bender, seconded by Heiberger, to issue the proclamation. 5 ayes.

## HEARING

## Continued from April 25, 2017

Scott Anderson, Planning Director, was present for the continued public hearing on Ordinance MC50-17, an ordinance to provide notice to downstream landowners of drainage projects and to provide for reporting of drainage projects in Minnehaha County. Mr. Anderson reiterated that, as the Planning Director, he believes the County should not adopt a drainage ordinance at this time, and that a drainage ordinance can be brought back for approval in the future if it becomes necessary. Chet Hofer, 26662 465th Ave, Hartford, spoke on his support for a drainage ordinance and concerns regarding the proposed drainage ordinance indicating issues with downstream notification distance, policing drainage work, and the penalty fees. Mr. Hofer is in favor of a drainage ordinance, but it opposed to the current proposed ordinance. Commissioner Barth stated he feels the wealthy landowner will have an advantage without a drainage ordinance due to the cost of legal proceedings, and he feels the County should regulate drainage work to allow for local control. Commissioners Karsky, Bender, and Heiberger stated they are not in support of approving a drainage ordinance at this time due items such as the usefulness of the proposed ordinance, the liability and cost Minnehaha County bears by being involved in drainage disputes, property rights of landowners, South Dakota State Statute already providing for the use of a mediation program, and civil court allowing for local control of drainage disputes. Al Miron, 25935 469th Ave, Sioux Falls, stated his opposition to the proposed ordinance, that the federal government does regulate wetlands, and that drainage districts are being considered on a state level. Marv Stoterau, 6200 N Cliff Ave Lot 160, Sioux Falls, stated he is in support of a drainage ordinance due to his concern for preserving water. Commissioner Beninga called for a motion. Due to lack of a motion, no action was taken.

# CONTRACT

Lynn DeYoung, Emergency Management Director, presented a State of South Dakota Consultant Contract between Minnehaha County and the South Dakota Department of Health for a \$10,000 grant. The grant is to be utilized by the Coroners Advanced Support Team to attend the Florida Emergency Mortuary Operations Response System exercise in Miami, FL from May 22-26, 2017. Members attending the training include Minnehaha County Sheriff's Office, Minnehaha County Emergency Management, South Dakota Department of Health, South Dakota Homeland Security, Minnehaha County Coroner's Office, Sioux Falls Police Department, and Sioux Falls Health Department. MOTION by Barth, seconded by Bender, to authorize the Chair, the Auditor, and the Emergency Management Director to enter into a consultant contract with the State of South Dakota Department of Health for a \$10,000 grant for the education and training of the Coroners Advanced Support Team at the Florida Emergency Mortuary Operations Response System exercise. 5 ayes.

#### GRANT

Ralph Hammer, Weed & Pest Supervisor, presented the Letter of Agreement for a Grant between Minnehaha County Weed & Pest Board and the South Dakota Weed and Pest Commission. The award requires a 50/50 cost share and the amount awarded will not exceed \$6,000. The funds will be used to purchase chemicals and seasonal help. The grant fund dollars must be expended between July 1, 2017, and June 1, 2018. MOTION by Heiberger, seconded by Barth, to approve the Letter of Agreement for a grant between the Minnehaha County Weed & Pest Board and the South Dakota Weed and Pest Commission commencing July 1, 2017 and ending June 1, 2018. 5 ayes.

# AGREEMENT

DJ Buthe, Highway Superintendent, presented an addendum to the lease agreement with Sod Busters Radio Control Model Airplane Club (Club) for the use of additional land. At the April 25, 2017, Commission Meeting, a Club member requested the use of additional land for their drone obstacle courses. The Club member had referenced an outdated map when making the request. The current map approved with the lease agreement last week does contain the section of land requested. Therefore, the addendum is not needed. No action was taken.

# SURPLUS

Carol Muller, Commission Administrative Officer, presented a request received from Scott Wick, President and CEO of the Sioux Empire Fair Association, to declare the Midway Bathroom as surplus for demolition and removal. Due to the Comfort Station addition, the Midway Bathroom building located at the W.H. Lyon Fairgrounds is no longer needed for its intended purpose. The building cannot be repurposed due to the age, the location, and the permanent odor of the building. MOTION by Heiberger, seconded by Karsky, to declare the Midway Bathroom at the W.H. Lyon and Fairgrounds as surplus for demolition and removal at no cost to Minnehaha County. 5 ayes.

# CONTRACT

Carol Muller, Commission Administrative Officer, presented a contract with East River Legal Services (ERLS) to provide representation on abuse and neglect cases when additional private attorneys are needed. The contract ends on June 30<sup>th</sup>, 2017. ERLS has proposed terminating the contract effective April 25, 2017. As per the contract, ERLS will continue with cases that are currently open. MOTION by Bender, seconded by Heiberger, to accept the termination of the contract with East River Legal Services effective April 25, 2017. 5 ayes.

#### LIAISON REPORTS

Upon the request of Commissioner Barth, Scott Anderson, Planning Director, gave a report and answered Commissioners' questions regarding the City of Crooks' joint platting jurisdiction noting it has been updated to have a more defined area than what was previously proposed.

Commissioner Heiberger reported on attending the National Association of Counties' County Justice Peer Exchange in Rapid City from April 27-28, 2017, as part of her participation on the Mental Health Response Oversight Council where topics such as criminal justice across the U.S., the Pine Ridge murder rate, court notification systems, and a new diversion program through the Pennington County's State's Attorney's Office were discussed.

Commissioner Karsky reported on the April 24-25, 2017, grant funded tour of the Dade County, Florida Jail and meetings regarding processes currently being used and ways to reduce the jail bed population.

Commissioner Karsky reported on the May 1, 2017, Highway Department meeting and stated work on Highway 149 north of Hartford and the bridge project north of Lyons are both expected to be done by the middle of June 2017.

Commissioner Bender reported on the May 1, 2017, Homeless Advisory Board meeting where they discussed reworking their organizational structure.

#### NEW BUSINESS

Commissioner Beninga reported being contacted to be part of an ad hoc committee with other cities and counties about bringing joint legislation to the State, and stated another commissioner may be needed on the committee.

DJ Buthe, Highway Superintendent, reported the South Dakota Department of Transportation bridge improvement grants have been awarded and that Minnehaha County has been awarded a preliminary engineering grant.

MOTION by Karsky, seconded by Barth, to adjourn into executive session for personnel and contracts. 5 ayes.

The Commission adjourned until 9:00 a.m. on Tuesday May 9, 2017.
