The SENC is a centralized social service database system that allows partnering agencies to provide individuals and families with their basic needs.

CONTRACT

Carol Muller, Commission Administrative Officer, presented contracts with Sage Consulting and the Augustana Research Institute (ARI) for facilitation and data/research services. As part of the MacArthur Innovation Fund grant awarded to Minnehaha County, a cross-collaborative planning process regarding the community triage center must be conducted. The process will include developing baseline data, combining data, and developing an on-going data plan. Sage Consulting will provide facilitation services through inter-collaborative meetings and developing and writing an implementation plan for a triage center based on the outcomes from the meetings and the data supplied by ARI. ARI will provide data/research services for a two year term with the first year covering baseline and development and the second year evaluating the committee's progress or success of any item implemented. MOTION by Heiberger, seconded by Karsky, to authorize the Chair to sign the Consultation Services contract with Sage Consulting for facilitation services at a cost not to exceed \$5,000; and authorize the Chair to sign the contract with the Augustana Research Institute for data/research services at a total cost of \$14,400. 5 ayes.
