Kevin Hoekman, Planner, gave the first reading and requested authorization for the Auditor to publish a Notice of Hearing on August 15, 2017, for the 2017 Revised Floodplain Management Ordinance for Minnehaha County. Scott Anderson, Planning Director, spoke on what prompted the revisions, noted the public open houses that were held regarding the revisions, and stated that affected property owners within the limits of the City of Sioux Falls would be contacted by the City. MOTION by Bender, seconded by Barth, to authorize the Auditor to publish Notice of Hearing on August 15, 2017, at or after 9:00 a.m. to consider the 2017 Revised Floodplain Management Ordinance for Minnehaha County. 4 ayes.

LIEN COMPROMISE

Melinda Storley, Commission Assistant, gave a briefing on an application for a compromise of lien for DPNO 93354 in the amount of \$294.40. Court Appointed Attorney services were provided to the applicant from November 2016 to December 2016 for the involuntary commitment (IVC) of the applicant's daughter. The petition for the IVC was submitted, but the applicant's daughter was denied admittance due to a department oversight. Because of this, the applicant has requested a compromise and release of the lien in full. Commissioners spoke in favor of a compromise due to the County's error. MOTION by Barth, seconded by Bender, to approve Resolution MC17-19. 4 ayes.

MOTION by Barth, seconded by Karsky, to approve a Special Event On-Sale Liquor License for Prairie Pasta Inc. dba Johnny Carino's for a wedding on August 5, 2017, at Blue Haven Barn. 4 ayes.

SPECIAL EVENT CONSUME/BLEND LICENSE

MOTION by Bender, seconded by Barth, to approve an application for license to consume/blend alcoholic beverages at the Mary Jo Wegner Arboretum, 1900 Perry Place, Sioux Falls, on August 19, 2017, for the Becker/Oetkin wedding. 4 ayes.

BRIEFING

Captain Jason Gearman, Minnehaha County Sheriff's Department, gave a briefing on the recent Minnehaha County Alcohol Compliance Check. The check is part of an effort to cut down on incidents of underage purchases of alcoholic beverages. Of the sixty-two (62) businesses checked, eight (8) business failed the check. To conduct the check, an individual between the ages of 18-20 was sent into the businesses by the Sheriff's Department. The individual was provided with a script and did have their real identification card with them that stated they were underage. It is a class 2 misdemeanor to sell alcohol to someone between the ages of 18-20. Online training is available for bartenders/clerks to learn proper procedures, such as checking a driver's license. Olivia Larson, Deputy Auditor, stated when annual alcohol beverage license renewals take place, and when public hearings are usually held for businesses that have failed a check. Judy Wehrkamp, Senior Deputy State's Attorney, spoke on the steps the Commission has authority to take when a business fails a check, such as a suspension of license or a revocation of the license. Dick Kelly, 2409 S 3rd Ave, Sioux Falls, spoke on his previous experiences as a Minnehaha County Commissioner involving businesses that have failed a check and his previous experiences as a bar owner. Matt Waltz, 4401 S Lewis Ave, Sioux Falls, spoke on his work in the treatment and addiction field and spoke on prevention and training for businesses to ensure they do not fail checks. Commissioners expressed concern for the number of businesses that failed the check, discussed ideas on next steps, and discussed preventative measures.

ADDENDUM

Jamie Gravett, Juvenile Detention Center Director, presented an addendum to the Fair Management Agreement with the Sioux Empire Fair Association to include Juvenile Detention Center (JDC) emergency housing. In the event of a disaster where the JDC would not be able to safely house the youth, an emergency housing plan must be set. The previous emergency housing plan allowed for the youth to be housed in the Minnehaha County owned building at 908 N West Avenue, Sioux Falls. Due to this building being declared as surplus and the shelter care services no longer operating out of the building, the JDC needed to find a new location. The addendum would allow the JDC to utilize the fairgrounds for emergency housing at no cost. MOTION by Barth, seconded by Bender, to authorize the Chair to sign the addendum to the Fair Management Agreement with the Sioux Empire Fair Association to include emergency housing for the Minnehaha County Juvenile Detention Center at the W.H. Lyon Fairgrounds at no cost. 4 ayes.

CHANGE ORDER

DJ Buthe, Highway Superintendent, gave a briefing on Change Order #1 to the contract with Bituminous Paving, Inc. for the Minnehaha County MC17-03 M&O 103-120-122 project. The change order is to add one (1) mile to the project on County Highway 113 (482nd Ave) just north of South Dakota Highway 11. The cost of the additional mile is \$137,149.10. MOTION by Barth, seconded by Bender, to authorize the Chair to sign Change Order #1 to the contract with Bituminous Paving, Inc. for the MC17-03 M&O 103-120-122 project for a new contract amount of \$1,569,993.70. 4 ayes.

AGREEMENTS

DJ Buthe, Highway Superintendent, presented a Professional Services Agreement between Minnehaha County and JSA Engineers and Land Surveyors for preliminary engineering and final design services for the replacement of Structure #50-032-060 located on 250th Street, approximately 2 miles south of the Buffalo Trading Post and 0.2 miles east of South Dakota Highway 19. The cost of services is not to exceed \$60,200. MOTION by Bender, seconded by Barth, to authorize the Chair to sign the Professional Services Agreement between Minnehaha County and JSA Engineers and Land Surveyors for the replacement of Structure #50-032-060 at a cost not to exceed \$60,200. 4 ayes.

DJ Buthe, Highway Superintendent, gave a briefing on an agreement between Minnehaha County and the South Dakota Department of Transportation (SDDOT) for Rumble Strip/Pavement Marking Project #PH 0020(188), PCN 05W2. The project will be on various county roads and will be completely funded and administered by the SDDOT. The agreement is to confirm Minnehaha County's interest in participating in the program. MOTION by Karsky, seconded by Barth, to authorize the Chair to sign the agreement between Minnehaha County and the South Dakota Department of Transportation for Rumble Strip/Pavement Marking Project #PH 0020(188), PCN 05W2. 4 ayes.

Mark Kriens, Facilities Director, reported on the July 12, 2017, bid opening for the replacement of the Juvenile Detention Center boiler. Six bids were received from the following companies: Krier & Blain Inc., \$97,000; PrairieSons Inc., \$95,800; Howe Inc., \$91,486; Hander Inc., \$114,440; Krohmer Plumbing, \$106,459; and Midwestern Mechanical Inc., \$126,000. The 2017 Capital Improvement Schedule has \$70,000 allocated to replace the boiler. Staff requests accepting the low bid from Howe Inc. and approval for the Chair to sign the contractor agreement. MOTION by Bender, seconded by Barth, to award the bid to Howe Inc. for the replacement of the Juvenile Detention Center boiler and to authorize the Chair to sign the contractor agreement in the amount of \$91,486. 4 ayes.

RESOLUTION

Carol Muller, Commission Administrative Officer, presented a resolution to establish hourly rates for the Board of Mental Illness Activities. The rates have not been changed in over seven (7) years, and the current rate is less than that of similar positions. The rates would increase from \$90 to \$94 per hour. Jim Iosty, Chair of County Board of Mental Illness, 6520 W 5th St, Sioux Falls, spoke on the reasons for requesting the increase. MOTION by Bender, seconded by Karsky, to approve Resolution MC17-20. 4 ayes.

RESOLUTION MC17-20 ESTABLISH HOURLY RATES FOR BOARD OF MENTAL ILLNESS ACTIVITIES

WHEREAS, SDCL 27A-7-8 and 27A-10-6 provides that the County Board of Commissioners determine compensation rates for certain activities of the County Board of Mental Illness and establishes responsibility for the payment of certain expenses of the Board of Mental Illness, and

WHEREAS, the Chairman of the Minnehaha County Board of Mental Illness has recommended an increase in the rates for certain activities associated with the Board of Mental Illness, now

THEREFORE BE IT RESOLVED BY the Minnehaha County Board of Commissioners that the following hourly rates are hereby established for the Board of Mental Illness:

Qualified Mental Health Professional Up to - \$90.00 per hour

Chair, Board of Mental Illness \$94.00 per hour Assistant Chair, Board of Mental Illness \$94.00 per hour Primary/Alternate Board Members \$32.00 per hour

BE IT FURTHER RESOLVED, these rates are effective August 1, 2017, and shall remain in place until changed by resolution by the Minnehaha County Board of Commissioners.

PROVISIONAL BUDGET

Carol Muller, Commission Administrative Officer, presented the FY2018 Provisional Budget in the amount of \$128,418,833. The general fund is \$55,885,649, which is a 2% increase from FY17. The provisional budget includes a cash applied amount of \$4,507,488. An additional opt-out of \$1.4 million will be utilized, for a total of \$2.9 million of the \$3.5 million from the opt-out approved in 2015. \$46,000,000 is for the jail expansion and associated parking costs. The provisional budget includes seven (7) new positions and moved three positions within the State's Attorney's Office from grant funded to County funded. The provisional budget is supported by revenues that include a 2.84% growth in property taxes due to new construction within the county that adds \$871,000, and a 1% CPI adjustment allowed by the property tax limitation statutes in total county property taxes collected. A public hearing on the proposed budget will be held during the Minnehaha County Commission meeting at 9:15 a.m., Tuesday, September 5, 2017. MOTION by Karsky, seconded by Barth, to approve the

FY2018 Provisional Budget. 4 ayes. (The Provisional Budget and Adoption Resolution MC17-21 will be published in the County's legal newspapers with these minutes).

LIAISON REPORT

Commissioner Barth reported on an article published on July 14, 2017, by Keloland.com regarding algae in Wall Lake. Scott Anderson, Planning Director, spoke on the statements made in the article, a call he received from the reporter, and noted the County does not typically conduct water testing for algae. Commissioner Barth noted there is an East Dakota Water Development District meeting on July 20, 2017.

OLD BUSINESS

Commissioner Karsky inquired what time the joint Minnehaha County/City of Sioux Falls meeting will be on July 25, 2017. The meetings are typically at 5:00 p.m., however, the calendar said 5:30 p.m. Carol Muller, Commission Administrative Officer, stated she would look into the matter.

MOTION by Barth, seconded by Karsky, to adjourn into executive session for personnel. 4 ayes.

The Commission adjourned until 9:00 a.m. on Tuesday July 25, 2017.
