07/25/2017 BID AWARD

Bill Hoskins, Museum Director, reported on the July 19, 2017, bid opening for the Siouxland Heritage Museum Storage Facility. Seven bids were received from the following companies: Visions Construction Group Inc, base bid of \$3,394,800; Golden Rule Construction Co., base bid of \$3,509,900; Peska Construction, base bid of \$3,234,000; Beck & Hofer Construction, base bid of \$3,540,000; Swift Contractors Inc, base bid of \$3,340,000; GA Johnson Construction Inc., base bid of \$3,390,000; and Lloyd Construction, base bid of \$3,367,000. A letter of recommendation from Keith Thompson, Koch Hazard Architects, recommends awarding the bid to the lower bidder, Peska Construction. MOTION by Barth, seconded by Karsky, to award the bid for the Siouxland Heritage Museums Storage Facility to be located at the southeast corner of 54th Street North and North Westport Avenue, to Peska Construction for \$3,234,000, pending successful contract negotiation. 3 ayes.
