# RESOLUTION MC 18-20 ESTABLISHMENT OF NAMING POLICY FOR COUNTY FACILITIES

**WHEREAS**, the generosity of private donors can be integral in providing funding for a project that would not otherwise be realized; and,

Names of facilities may be removed or changed by a vote of the Commission, in unusual circumstances, when a prior naming decision could be damaging to the reputation of Minnehaha County or deemed not to be in the best interest of the County.

#### CONTRACT

Carol Muller, Commission Administrative Officer, presented a contract between Minnehaha County and the Sioux Empire Fair Association Inc. for management of the Sioux Empire Fair and W.H. Lyon Fairgrounds. The contract lasts for five years and does not automatically renew. Section 5 of the contract has been updated to provide enhanced detail on the financial responsibility of both the County and the Association. Clarification has been added to show the Commission liaison is an ex-officio member of the Association's board. The Association will be required to present an annual independent audit to the Commission. The Association has requested this section of the contract be changed from requiring the presentation to take place before May 1 to July 1. Section 6 has been updated to reflect South Dakota law regarding expenditures of tax monies for capital improvements.

Additionally, monthly financials are to be submitted to the Commission Office. Scott Wick, President and CEO of the Sioux Empire Fair Association, inquired about and spoke on the financial responsibility of the Association. MOTION by Beninga, seconded by Bender, to amend the contract between Minnehaha County and the Sioux Empire Fair Association for management of the Sioux Empire Fair and W.H. Lyon Fairgrounds to change the last sentence of Section 9 to read as follows "The Association shall present the independent Audit to a meeting of the Board of Commissioners no later than July 1 of each year"; and to authorize the Chair to sign the contract as amended. 5 ayes.

#### LIAISON REPORT

Commissioner Barth reported on meeting with the Treasurer's Office to speak about the concerns regarding call wait times and coming to a resolution.

Upon the request of Commissioner Barth, Scott Anderson, Planning & Zoning Director, reported on a new temporary position his department will be hiring to assist with code enforcement work.

Upon the request of Commissioner Barth, Lynn DeYoung, Emergency Management Director, spoke on topics such as ambulance funding, workforce concerns, mutual aid, and budget requests from Med-Star Paramedic Ambulance, Inc.

Commissioner Karsky reported on meeting with DJ Buthe, Highway Superintendent, where they discussed the life expectancy of county highways and a recent public meeting conducted in Highland Township by the Highway Department to get public input on certain county highways.

Commissioner Heiberger reported on the Improving Criminal Justice Response phone conference where items such as competency evaluations, the community health jail data pilot program, and mental health training for South Dakota attorneys and jail officers were discussed.

Commissioner Heiberger reported on a Cross Systems Partnership Lab program being offered through the National Association of Counties where four U.S. counties will be chosen to participate. Minnehaha County is allowed to submit an application in conjunction with Lincoln County.

#### **OLD BUSINESS**

Commissioner Heiberger stated the 2018 County Board of Equalization will begin on April 10, 2018 at 11:00 a.m.
