Mr. Masur also invited the Commissioners to visit Med-Star Ambulance, as well as the other ambulance services.

Nikki Gronli, 24620 479th Ave, Dell Rapids, spoke on the recent spearfishing scheme that affected the City of Sioux Falls and requested the Commissioners consider annual training for all County employees regarding cyber security.

PRESENTATION

Sheriff Mike Milstead gave a presentation on the Sheriff's Office highlighting the divisions of the office, the contracts for security, the contracts for patrol, Midwest drug trends, overdoses in the area, and the triage center. It was also noted that May 13-19, 2018, is National Police Week. Mike Walsh, Deputy Sheriff Captain, presented on the Patrol Division. Jason Gearman, Deputy Sheriff Captain, presented on the Investigation Division. Jeff Gromer, Jail Warden, presented on the Jail and the 24/7 Sobriety Program.

Sheriff Mike Milstead and Aaron McGowan, State's Attorney, presented on Constitutional Amendment Y, an amendment to the South Dakota Constitution regarding Marsy's Law that will be on the June 5, 2018, Primary Ballot. The amendment's intent is to assist in clarifying parts of the current law that is ambiguous. The original proponents of Marsy's Law was part of the discussions for the amendment and are in support of the amendment.

APPEAL

Kevin Hoekman, Planner, gave a briefing on an appeal filed by Jay Husman on the Planning Commission's decision to approve Conditional Use Permit (CUP) #18-23 to allow a telecommunications tower on the property legally described as Tract 1 Bunde's Addition SE1/4 NE1/4 & E1/2 NE1/4 (Ex Valley View Farm Addn. & Ex Lot H-1) & E40 W1/2 NE1/4, Section 13-T103N-R51W, approximately 1.25 miles west of the Village of Lyons and 1.25 miles east of Tri-Valley High School along County Highway 118. The Planning Commission approved the CUP unanimously at their April 23, 2018, meeting. Curt Walter, representing Verizon Wireless, the petitioner, spoke on their request for the CUP to construct a telecommunications tower and addressed concerns brought forward by the opposition during the Planning Commission meeting. Jay Husman, 46562 252nd Street, Colton, the appellant, raised concerns regarding visibility of the tower from his property, health concerns regarding radiation from the tower, the effect on wildlife flight patterns, increased traffic and traffic safety, noise caused by the construction, the effect on property values, and privacy. Mr. Husman also questioned why the location was chosen for the tower. Kris Christensen, 46568 252nd Street, Colton, spoke in opposition to the CUP citing concerns regarding increased traffic and traffic safety, visibility of the tower from her home, and effects of the tower on her health. Mr. Walter responded to concerns brought forward by the opposition. MOTION by Karsky, seconded by Barth, to approve CUP #18-23 to allow a telecommunications tower on the property legally described as Tract 1 Bunde's Addition SE1/4 NE1/4 & E1/2 NE1/4 (Ex Valley View Farm Addn. & Ex Lot H-1) & E40 W1/2 NE1/4, Section 13-T103N-R51W. 5 ayes.

FUNDS TRANSFER

Jay Soukup, 7304 S Grand Arbor Court, Sioux Falls, Multi-Cultural Center Board Member, thanked the Commission for their support.
