MOTION by Barth, seconded by Karsky, to approve Ordinance MC16-155-18, an ordinance amending the 1990 revised zoning ordinance for Minnehaha County by rezoning certain property from A-1 Agriculture to C Commercial District, Rezoning #18-03. 4 ayes. The entire ordinance is on file and available in the Auditor's Office.

Scott Anderson, Planning Director, was present for the public hearing and gave the second reading of an amendment to Ordinance MC16-90, the 1990 Revised Zoning Ordinance. The amendment is to rezone from an A-1 Agriculture District to C Commercial District for the property legally described as Dawson's Tract 1 in the SE <sup>1</sup>/<sub>4</sub>, S12-T102N-R50W, Minnehaha County, SD. The property is approximately 1.67 acres of land located approximately two and a half (2.5) miles north of Sioux Falls at 25773 472<sup>nd</sup> Ave, Sioux Falls. The petitioner and property owner is Tim Tiahrt. The petitioner has no immediate plans for the property. The Planning Commission voted unanimously to approve the rezoning at their April 23, 2018, meeting. No one spoke in opposition. MOTION by Barth, seconded by Karsky, to approve Ordinance MC16-156-18, an ordinance amending the 1990 revised zoning ordinance for Minnehaha County by rezoning certain property from A-1 Agriculture to C Commercial District, Rezoning #18-04. 4 ayes. The entire ordinance is on file and available in the Auditor's Office.

#### **PRESENTATIONS**

Kori Baade, Sioux Falls Area Humane Society Executive Director, and Andy Oestreich, Senior Humane Officer, presented on the Sioux Falls Area Human Society services and highlighted areas such as daily intakes, medical services, humane officers, partnerships, and funding.

Carol Woltjer, Family Visitation Center Director of Development, and Abraham Knoff, Family Visitation Center, presented on the Family Visitation Center's services highlighting areas such as the weekly average number of families, referrals from Child Protective Services, the number of private pay families, and funding.

## **BID AWARD**

DJ Buthe, Highway Superintendent, reported on the May 9<sup>th</sup>, 2018, bid opening for Bid #18-11, 2018 Two (2) Hydraulic Systems and Dump Bodies. Three bids were received from the following companies: Sanitation Products, Inc., \$144,600; Northern Truck Equipment Corp., \$127,986; and Custom Truck Equipment, \$131,307.06. Staff recommends awarding the bid to the low bidder, Northern Truck Equipment Corp. ### MEMORANDUM OF UNDERSTANDING
