Upon the request of Jeff Gromer, Jail Warden, MOTION by Barth, seconded by Karsky, to authorize the Auditor to publish three Notice to Bidders for the following: the purchase of Jail Kitchen Equipment, the purchase of Inmate Seating and Tables, and the purchase of Inmate Clothing, Bedding, and Mattresses. 3 ayes.

PUBLIC COMMENT

Jeff Gromer, Jail Warden, stated that it is Corrections Officers' Week and would like to recognize the hard work of his staff.

Travis Hatlestad, Henry Carlson Company Project Manager; Scott Mohr, Henry Carlson Company Superintendent; and Keith Halvorsen, JE Dunn Construction Superintendent, spoke on it being the construction industry's National Safety Week. They each serve on the project team for the Jail Expansion Project.

Nick Fosheim, Minnehaha County and Lincoln County Economic Development Associations Executive Director, spoke on the Minnehaha County Area Bus Tour scheduled for May 14, 2019.

Bob Litz, Auditor, spoke on attending the Cyber Security Conference in Denver, CO where his primary focus was to learn about and discuss, with other attendees and present organizations, the role of cyber security in relation to elections.

Commissioner Beninga joined the meeting.

PRESENTATION

Chris Lilla, Director of Equalization, gave a presentation on the Equalization Department highlighting the following areas: maintenance of data, sales review, real estate assessments, development and growth tracking, exemption program administration, and future projects.

AGREEMENT

Margaret Gillespie, Senior Deputy State's Attorney, presented the following agreements resulting from a condemnation case settlement: Agreement for Roadway Acquisition and Temporary Easement, Right Of Way Purchase Agreement, and Temporary Construction Easement. Land is needed for highway and bridge reconstruction on County Highways 122 and 155. One-third of the land is owned by Armen Janjigian, who will be paid \$3,637.34 for his land. Another one-third of the land is owned by the Estate of Gregory Janjigian (the Estate), which will be paid \$3,637.33. Armen Janjigian is the personal representative for the Estate. The remaining one third of the land is owned by two non-settling parties. The land acquisition and easement will allow for additional right-of-way on the property legally described as The Southwest Quarter (SW ¼) of Section Twenty (20), Township One Hundred Three (103) North, Range Fifty-one (51), West of the Fifth P.M., except County Auditor's Lot H-3, Minnehaha County, South Dakota. If approved, a typo in the legal description of the presented documents will be corrected prior to execution by the Chair. MOTION by Barth, seconded by Beninga, to approve the following actions: 1) authorize the Chair to sign the corrected Agreement for Roadway Acquisition and Temporary Easement, authorize the Chair to sign the corrected Right-Of-Way Purchase Agreement, and authorize the Chair to sign the corrected Right-Of-Way Purchase Agreement, Armen

Janjigian, and the Estate of Gregory N. Janjigian, Armen Janjigian, Personal Representative, and 2) based upon the jury's verdict, approve payment in the amount of \$1,277.33, such amount to be divided equally between the two non-settling owners for their one-third interest in the property. By roll call vote: 4 ayes.

Craig Dewey, Assistant Commission Administrative Officer, presented an Agreement of Participation with Avera PACE. Avera PACE is a purchasing group that sells supplies and fixtures for jail medical. Through the agreement, the County would have access to product lists and more competitive pricing for bid exempt supplies that can be purchased directly through the vendors who are part of the Avera PACE network. Participation must be renewed annually. There is no cost to Minnehaha County for participating. MOTION by Barth, seconded by Karsky, to authorize the Chair to sign the Agreement of Participation between Minnehaha County and Avera Health dba Avera PACE becoming effective on June 1, 2019. 3 ayes. Commissioner Beninga abstained.

CHANGE ORDER

Carol Muller, Commission Administrative Officer, requested the approval of Change Order #5 for the Minnehaha County Jail Expansion for the Construction Manager at Risk Agreement Amendment No. 1 with JE Dunn and Henry Carlson. The change order is a total addition of \$284,637.02 for Radio Repeaters at \$153,197.02 and Property Room Revision/Equipment at \$131,440.00. MOTION by Karsky, seconded by Barth, to approve Change Order #5 to the Construction Manager At Risk Agreement Amendment No.1 with JE Dunn Construction Company and Henry Carlson Construction for an addition of \$284,637.02. By roll call vote: 4 ayes.

LIAISON REPORTS

Upon the request of Commissioner Barth, Bill Hoskins, Museum Director, spoke on the Mountain Plains Museum Association Meeting that will take place September 2 through September 5, 2020. Mr. Hoskins has been asked to serve as a Co-Chair for the coordination of the meeting.

Commissioners Barth and Beninga reported on the most recent Metro Communications meeting and announced that Scott McMann was selected as the new director.

Commissioner Barth reported on receiving an invitation from East Dakota Water Development District to attend a regional drainage conference.

Commissioner Bender reported on the timeline of the study of the Homeless Advisory Board and reported on being interviewed by Suzanne Smith, Augustana University, for the study.

NEW BUSINESS

Commissioner Barth proposed a text amendment to Ordinance MC31-5-18, the Ground Ambulance Licensing Ordinance, to be brought forward regarding Article 6: Notice to Licensee of Special Event to change the need to obtain consent of the licensee to only requiring notification of the licensee.

MOTION by Barth, seconded by Beninga, to recess the Minnehaha County Commission Meeting at 10:05 a.m. 4 ayes.

MOTION by Barth, seconded by Beninga, to reconvene the Minnehaha County Commission Meeting at 10:13 a.m. 4 ayes.

MOTION by Karsky, seconded by Beninga, to enter into Executive Session pursuant to SDCL 1-25-2 (1), (3) and (4). 4 ayes.

MOTION by Karsky, seconded by Barth, to adjourn. 4 ayes.
