Michelle Trent, Compass Center Assistant Director and Clinical Director, gave a presentation on potential changes to the Family Violence Project. The Compass Center has initiated conversation with Lutheran Social Services (LSS) about transitioning the project over to LSS. The decision to transition has not been finalized. Michelle Markgraf, Former Compass Center Executive Director, stated that the potential changes being made to the project are good for the community.

Chuck Martinell, 4-H/Youth Development Advisor, gave a presentation on the Minnehaha County 4-H Program highlighting the 2018-2019 program activities, the in-school programing, and the summer/fall programming.

AGREEMENT

Drew DeGroot, Senior Deputy State's Attorney, presented an agreement between Minnehaha County and the State of South Dakota Department of Social Services for funding to reimburse the services of the Qualified Expert Witnesses for abuse and neglect cases. The Indian Child Welfare Act (ICWA) requires the testimony of a Qualified Expert Witness for abuse and neglect court proceedings in court involving Indian children. The agreement shall be effective June 1, 2019, ending May 31, 2020. The State will provide four (4) quarterly payments for a total amount of \$111,524.00 for all cases during the period of the agreement. Mr. DeGroot also presented an agreement between Minnehaha County and Luke Yellow Robe to provide the Qualified Expert Witness service effective June 1, 2019, ending May 31, 2020. Mr. Yellow Robe will be paid the sum of \$111,524.00 for the one-year term, payable in four quarterly installments, with the first payment due upon receipt of funds by the county from the State of South Dakota. MOTION by Beninga, seconded by Heiberger, to authorize the State's Attorney to sign the Cooperative Agreement with the State of South Dakota Department of Social Services Division of Child Protection for funding of the ICWA Qualified Expert Witness. 5 ayes. MOTION by Heiberger, seconded by Beninga, to authorize the State's Attorney to sign the Contract for Professional Services with Luke Yellow Robe for Qualified Expert Witness service. 5 ayes.

LIAISON REPORTS

Commissioner Heiberger reported on attending last week's MacArthur Foundation Safety & Justice Challenge Team Meeting where they discussed a research associate analysis personnel being hired and grant funded positions including a community resource officer, behavioral health case worker, and a peer navigator. Updates on the triage center project were provided, and judges from the Unified Judicial System reported on different ways for court reminders to be implemented and how they are changing their case processes.

NEW BUSINESS

Commissioner Barth encouraged citizens to keep an eye on the County's budget process and to come forward with any questions prior to the budget being finalized.

Carol Muller, Commission Administrative Officer, spoke on the County's budget process and provided the following budget hearing dates: June 4, 2019, at 1:00 p.m., June 6, 2019, at 8:00 a.m., June 19, 2019, at 8:00 a.m., and July 8, 2019, as a hold date if needed. Commissioner Bender encouraged the public to be involved in the budget process.

OLD BUSINESS

Commissioner Heiberger spoke on a presentation given by the Treasurer's Office on May 21, 2019, where they discussed the tax deed process and unpaid taxes owed to the County. Commissioner Heiberger requested more information regarding the notification process of tax payers when they are delinquent. Commissioner Beninga agreed with Commissioner Heiberger and requested more information regarding the overall process and timing.

MOTION by Beninga, seconded by Barth, to recess the Minnehaha County Commission Meeting at 9:42 a.m. 5 ayes.

MOTION by Heiberger, seconded by Barth, to reconvene the Minnehaha County Commission Meeting at 9:55 a.m. 5 ayes.
