MOTION by Barth, seconded by Beninga, to approve the Special Event On-Sale Liquor License for Prairie Pasta Inc. dba Johnny Carino's for the event taking place on September 14, 2019, at the Riviera Event Center. By roll call vote: 3 ayes.

PRESENTATION

Julie Becker, St. Francis House Executive Director, presented an overview of the statistics for restitution and fine payments made to counties in South Dakota by their clients between July 2015 and January 2019 totaling \$659,197.97.

AMENDMENT

Keith Wynia, Air Guard Supervisor, presented Amendment #2 to the Joint Security Protection Agreement between Minnehaha County and the State of South Dakota Department of the Military and Adjutant General. The amendment decreases the FY2019 funding due to the difference between the initial validated amount from the National Guard Bureau to the actual federal funding amount. The decrease is in the amount of \$4,169.01. MOTION by Beninga, seconded by Barth, to authorize the Chair to sign Amendment #2 to the Joint Security Protection Agreement with the State of South Dakota Department of the Military and Adjutant General to decrease the FY2019 funding resulting in a total funding amount of \$916,200.00 effective April 30, 2019. 3 ayes.

Keith Wynia, Air Guard Supervisor, presented Amendment #3 to the Joint Security Protection Agreement between Minnehaha County and the State of South Dakota Department of the Military and Adjutant General. The amendment increases the FY2019 funding by \$109,800.00. MOTION by Barth, seconded by Beninga, to authorize the Chair to sign Amendment #3 to the Joint Security Protection Agreement with the State of South Dakota Department of the Military and Adjutant General to increase the FY2019 funding resulting in a total funding amount of \$1,026,000.00 effective May 16, 2019. 3 ayes.

BID AWARDS

Jeff Gromer, Jail Warden, reported on the May 24, 2019, bid opening for Bid #19-14, Jail Kitchen Equipment for the expansion of the jail. Three bids were received from the following companies: BHS Foodservice Solutions LLC at \$117,029.95; Chef's Depot dba Culinary Depot at \$99,866.35; and Cooks Direct Inc at \$99,371.81. Staff recommended awarding the bid to the low bidder, Cooks Direct Inc. In response to a question from Commissioner Beninga, Warden Gromer spoke on the available funding sources for the kitchen equipment. MOTION by Beninga, seconded by Barth, to award Bid #19-14, Jail Kitchen Equipment to Cooks Direct Inc in the amount of \$99,371.81. By roll call vote: 3 ayes.

Jeff Gromer, Jail Warden, reported on the May 24, 2019, bid opening for Bid #19-13, Jail Inmate Storage, Seating, & Tables for the expansion of the Jail. Two bids were received from the following companies: Pheasantland Industries at \$16,423.57 and Norix Group Inc at \$43,126.85. Due to Pheasantland Industries's bid not conforming to the bid specifications laid out in the bid instructions, staff recommended awarding the bid to Norix Group Inc. MOTION by Barth, seconded by Beninga, to award Bid #19-13, Jail Inmate Storage, Seating, & Tables to Norix Group Inc in the amount of \$43,126.85. By roll call vote: 3 ayes.

SURPLUS & ALLOCATIONS

DJ Buthe Highway Superintendent, presented the following various items for surplus and/or sale proceeds allocations.

A 2013 Track Loader, Asset No. 1063, was damaged in 2018. An insurance payout was received for the damage from Claims Associates in the amount of \$58,500.00. Mr. Buthe requested declaring the loader as surplus to release to Claims Associates and requested direction on where to deposit the insurance claim payout. MOTION by Beninga, seconded by Barth, to declare one 2013 Track Loader, Asset No. 1063, as surplus to release to Claims Associates, and to deposit the insurance claim in the amount of \$58,500.00 into the Highway Fund. By roll call vote: 3 ayes. Commissioner Barth commented on his belief that the General Fund is in greater need than the Highway Fund, but would support the motion made by Commissioner Beninga. Commissioner Beninga commented that, although he agrees the General Fund has a greater need, the funds for the loader came out of the Highway Fund and should be returned to the Highway Fund.

Trimble GPS Survey Equipment, Asset No. 1089, was declared as surplus on February 12, 2019. On March 6, 2019, two bids were received for the purchase of the equipment. 605 Companies Inc., Dirt Works was awarded the bid on March 12, 2019, to purchase the equipment for a total of \$13,500.00. Mr. Buthe requested direction on where to deposit the proceeds of the sale. MOTION by Beninga, seconded by Barth, to deposit proceeds from the

sale of the Trimble GPS Survey Equipment, Asset No. 1089, in the amount of \$13,500.00 into the Highway Fund. By roll call vote: 3 ayes.

On May 14, 2019, two 2012 Street Smart variable message boards, Asset No. 1032 and No. 1033, were declared as surplus to sell to the City of Brandon in the amount of \$10,000.00 each. Mr. Buthe requested direction on where to deposit the proceeds of the sale. MOTION by Barth, seconded by Beninga, to deposit proceeds from the sale of two 2012 Street Smart message boards, Asset No. 1032 and No. 1033, in the amount of \$20,000.00 into the Highway Fund. By roll call vote: 3 ayes.

On October 9, 2018, a Sterling LT9500 Plow Truck, consisting of Asset No. 0459, No. 0761, No. 0465, and No. 0467, was declared as surplus to be sold on Iron Planet. In January 2019, the truck was sold as one whole unit for \$12,270.00. Mr. Buthe requested direction on where to deposit the proceeds of the sale. MOTION by Beninga, seconded by Barth, to deposit proceeds from the sale of a Sterling LT9500 Plow Truck, Asset No. 0459, No. 0761, No. 0465, and No. 0467, in the amount of \$12,270.00 into the Highway Fund. By roll call vote: 3 ayes.

PRESENTATION

James Iosty, Co-Chair of the Minnehaha-Lincoln County Board of Mental Illness, presented the unofficial budget dollar per petition analysis for the years 2007-2018, the unofficial annual statistics by month for 2007-2008, the unofficial Minnehaha County-Lincoln County annual petition totals, the unofficial miscellaneous statistics for 2017, and the unofficial miscellaneous statistics for 2018.

AGREEMENT

Carol Muller, Commission Administrative Officer, reported that negotiations have concluded with the Minnehaha County Deputies Association. The new contract is for a three year period. The association is guaranteed a minimum of a 3% increase in salary for 2020, a 2% salary increase for 2021, and a 1.5% salary increase for 2022. As laid out in Article 15 of the agreement, for years 2021 and 2022, the salary increase will meet the minimums set or will be aligned with the salary increases approved by the County Commission for non-union employees, whichever is greater. Other notable changes to Article 15 are as follows: Section 3, Note 1, reclassify the pay grade for Certified Civil Process Servers from a grade 13 to a grade 14; Section 3, Note 2, reclassify Correctional Systems Operators from a pay grade of 9 to a pay grade of 10; and Section 3, Note 3, eliminate the Correctional Officer in Training classification and convert employees to pay grade 13. Article 23 has been updated to add provisions to give six weeks of ESL following the birth or adoption of a child. Article 28 will sun-set the retiree health benefits for those hired after December 31, 2019. Notable changes made to Article 29 include the following: add a weapon light as basic issue for Deputies and Corporals, add a taser and holster for Deputies, add an option for an externally worn vest carrier for field deputies, add externally worn vests for those hired after December 14, 2019, and update and cap the annual clothing allowance. MOTION by Beninga, seconded by Barth, to authorize the Chair to sign the Deputies Association Contract effective December 14, 2019, through the last payroll period of 2022. 3 ayes.

CONFERENCE SUPPORT

Carol Muller, Commission Administrative Officer, presented a request from the Unified Judicial System (UJS) for support and partnership in their conference taking place on August 13 and 14, 2019. The goal of the conference is to help communities better connect their existing mental health resources with the individuals in the criminal justice system who have mental illnesses. The conference stems from work done with the Helmsley Foundation that resulted in House Bill 1183. The support and partnership UJS is seeking from the County is non-financial. The County would allow the use of logo materials and assist in communicating details of the conference to potential participants. MOTION by Barth, seconded by Beninga, to approve support and partnership with the Unified Judicial System for the August 13 and 14, 2019, conference on improving the criminal justice system for individuals with mental illness. 3 ayes.

LIAISON REPORT

Commissioner Bender reported on attending an initial planning group meeting of the Homeless Advisory Board to listen to the presentation by the Augustana Research Institute showing what comparable cities are doing to address homelessness.

Commissioner Bender commented on information provided by the State's Attorney's Office during the budget process to show the increasing challenges their office is facing, and cited the shooting that took place over the weekend as an example of the type of cases the office is dealing with in the County.

OLD BUSINESS

Jason Gearman, Emergency Management Director, reported that Minnehaha County was selected for individual damage assessment assistance due to the flooding that took place this spring. The State of South Dakota is working to set up places where the public may go to get individual assistance. In the meantime, members of the public may call 1-800-621-3362 or go online to www.disasterassitance.gov.

Commissioner Barth encouraged the public to be involved in the County's budget process noting that the budget hearings are open to the public and are recorded and available on the County website. Commissioner Bender stated that the next Budget Hearing is scheduled for 8:00 a.m. on June 19, 2019.

MOTION by Barth, seconded by Beninga, to recess the Minnehaha County Commission Meeting at 10:10 a.m. 3 ayes.

MOTION by Beninga, seconded by Barth, to reconvene the Minnehaha County Commission Meeting at 10:17 a.m. 3 ayes.

MOTION by Barth, seconded by Beninga, to enter into Executive Session pursuant to SDCL 1-25-2 (1), (3) and (4). 3 ayes.

MOTION by Barth, seconded by Beninga, to adjourn. 3 ayes.
