The Sheriff's Office may participate in a new cooperative initiative project to equip Sheriff's Office vehicles with the next generation of automated external defibrillators (AED). The project is funded by the Helmsley Charitable Trust with the SDDOH providing oversight and distribution. Approximately 25 new AED devices would be supplied to the Sheriff's Office through the project at no cost to the County.
