# **BRIEFING**

Scott Wick, President and CEO of the Sioux Empire Fair Association, presented the 2020 Sioux Empire Fair Report including contributions, special events, COVID-19 changes, community service, fairground changes, the

arts center, and the livestock shows. The total attendance was down by 31% from 2019. A total of \$920,651 in expenses and \$891,659 in revenue resulted in a net loss of \$28,992.

Ms. Gillespie spoke on the definition of open burning according to County ordinance. MOTION by Beninga, seconded by Karsky, to amend the typo in the last sentence of the fourth paragraph of the resolution to read "force until rescinded by the Chair of the Board of County Commissioners in consultation with the Emergency Management Director". By roll call vote: 5 ayes. MOTION by Karsky, seconded by Heiberger, to approve Resolution MC20-65 as amended, Declaring A Fire Emergency In Minnehaha County And Prohibiting Open Burning. By roll call vote: 5 ayes.

# RESOLUTION MC20-65 DECLARING A FIRE EMERGENCY IN MINNEHAHA COUNTY AND PROHIBITING OPEN BURNING

WHEREAS, the Commissioners of Minnehaha County are charged with protecting the health and safety of the citizens of Minnehaha County; and

WHEREAS, conditions of fire danger now exist due to the dry spring conditions, unseasonably warm temperatures, and windy conditions that are currently prevalent in Minnehaha County, South Dakota; and

NOW, THEREFORE BE IT RESOLVED, BY THE MINNEHAHA COUNTY BOARD OF COMMISSIONERS, based on the recommendations of the Minnehaha County Rural Fire Chiefs and the Minnehaha County Emergency Management Director, and under the authority of SDCL 7-8-20 (18), that a Fire Danger Emergency is hereby declared and all open burning as defined in Ordinance MC34-04, is hereby prohibited within the boundaries of Minnehaha County, South Dakota, exclusive of any incorporated municipality within the county; and

**BE IT FURTHER RESOLVED,** that this Resolution is declared to be necessary for the immediate preservation of the public safety in accordance with the provisions of SDCL 7-18A-8 and is effective immediately and shall continue in force until rescinded by the Chair of the Board of County Commissioners in consultation with the Emergency Management Director.
