#### REZONING PUBLIC HEARING

Scott Anderson, Planning Director, was present for the scheduled hearing and gave the second reading of an amendment to Ordinance MC 16-90, the 1990 Revised Zoning Ordinance. The amendment, Rezone #21-03, is to rezone from an A-1 Agricultural District to the I-1 Light Industrial District for the property legally described as Tract 4 (Ex. H-1), SE ¼; Section 22, T102N-R48W Brandon Township, Minnehaha County, located approximately 3/4-mile north of I-90 along SD Highway 11 in Corson. The property is a parcel of land that is approximately 1.66 acres. The petitioner and property owner are Lance Hulzebos. The rezoning request was to allow for future development. The property meets the criterion of the Envision 2035 Minnehaha County Comprehensive Plan by encouraging commercial and industrial development near the intersection of highways, along major corridors and sites able to access rail. The rezone was unanimously recommended for approval by the Planning Commission on October 25th, 2021. No one spoke in favor of or in opposition of the rezoning request.

Kris Graham, Southeastern Behavioral HealthCare CEO; Kim Hansen, Director of Operations Community Support Services Division and Mobile Crisis Team; Debbie Faini, Alternative Sentencing Program; gave a presentation regarding the purpose for calling the mobile crisis team, mobile crisis team 2020 annual statistics, and the public defenders-alternative sentencing program.

### ALCOHOL LICENSE COMPLIANCE

Susan Beaman, Finance and Budget Officer, gave a briefing on recent alcohol compliance check failures. The Minnehaha County Sheriff's Office conducted a compliance check of 63 alcohol beverage licenses in November 2021. Of the 8 failing licensees, two of them, Monarch Steak House Inc. d/b/a The Monarch Lounge and the Safari Bar and Grill d/b/a Safari Bar and Grill are licensed by Minnehaha County. At the time of their next renewal, the failing licensees will be required to have a public hearing. Commissioner Karsky reported on the listening session held at the multi-cultural center for the hiring of a new executive director as the Public Defender's Advisory Board Meeting and the Public Defender's are within budget and are looking at software similar to the State's Attorney Office. Commissioner Karsky asked Tyler Klatt, Assistant Commission Administrative Officer, to report on attending a meeting with Sioux Metro Growth Alliance meeting.
